
FIRST COUNT:

Howard Randolph, also known as "H.B.", within the District of Columbia, in perpetrating and attempting to perpetrate a dangerous misdemeanor offense in a manner that created a reasonably foreseeable risk of appreciable physical injury, that is, assault, as set forth in the second count of this indictment, caused the death of Rayshawn Hailstock, by punching him with his fist on or about June 30, 2013, thereby causing injuries from which Rayshawn Hailstock died on or about June 30, 2013. (Involuntary Manslaughter, in violation of 22 D.C. Code 2105 (2001 ed.))




SECOND COUNT:

On or about June 30, 2013, within the District of Columbia, Howard Randolph, also known as "H.B.", unlawfully assaulted and threatened Rayshawn Hailstock in a menacing manner. (Assault, in violation of 22 D.C. Code, Section 404 (2001 ed.))
