Charles Wennen Young, within the District of Columbia, while armed with a FIREARM, and with the intent to kill another and to inflict serious bodily injury on another and with a conscious disregard of an extreme risk of death or serious bodily injury to another, caused the death of Rokeida Spriggs by SHOOTING her with FIREARM on or about November 22, 2013, thereby causing injuries from which Rokeida Spriggs died on or about November 22, 2013. (Second Degree Murder While Armed, in violation of 22 D.C. Code, Sections 2103, 4502 (2001 ed.))

GIVE BRIEF DESCRIPTION OF WHAT HAPPENED:

On Thursday, November 22, 2013, at 0058 hours units from the Sixth District responded to 4955 G Street, SE, to investigate the report of a shooting victim inside that location. Upon arrival, officers were directed by citizens to apartment C-7, where they discovered a female victim lying on the bathroom floor suffering from an apparent gunshot wound to her upper left chest. DCFD Medic 30 arrived on the scene and transported the victim to Prince George's County Community Hospital, where she succumbed to her injuries and was pronounced dead at 0153 hours by Dr. Cooper. The decedent was identified as being Rokeida Spriggs, and her next of kin was notified on the scene.

During the morning hours of the November 22, 2013, the decedent's remains were transported to the State of MD Medical Examiner's office. Dr. Allan performed an autopsy on the remains of Rokeida Spriggs and determined the cause of death to be a single gunshot wound to the left chest and the manner of death "Homicide."

During the initial canvass a witness was interviewed, hereinafter referred to as W-1. On Thursday, November 22, 2013, W-1 reported to the affiant that IT observed an argument in the hallway at 4955 G Street SE between the decedent and a female that IT knows to live in the building. W-1 reported further, IT heard gunshots and ran into an apartment. At 11:18 am, W-1 contacted the affiant and reported IT observed, "Chili" shooting in the hallway, and IT didn't tell the police this initially because IT was afraid for its safety. W-1 forwarded a photograph to a Detective and stated, "That's, "Chili", the person IT observed shooting in the hallway". The photograph provided by W-1, was that of a black male, short haircut, beard, and tattoos on his neck. The affiant viewed the photo sent by W-1 and determined that it was the same person in the single photograph shown to W-1, to include the distinctive tattoos on his neck. The single photograph shown to W-1 was that of **Charles Wennen Young, PDID# 669829.**

A second witness was interviewed, hereinafter referred to as W-2. W-2 reported to the affiant that IT was in the hallway at 4955 G Street SE, when IT heard gunshots. W-2 stated that shortly after the gunshots IT observed a

subject known to IT as "Chili", approach the entrance door of the apartment building displaying a big black handgun while stating, "You bitches are going to make me kill somebody". W-2 was shown a single confirmation photograph, which the witness positively identified as being a person IT knows as "Chili", the person IT observed with a big black handgun in the hallway at 4955 G Street SE. The photograph shown to the witness is that of, **Charles Wennen Young, PDID# 669829.**

A third witness hereafter referred to as W-3 was located and interviewed and provided three different versions of what happened inside the hallway of 4955 G Street SE. Initially, W-3 reported to the affiant that IT observed an argument inside the hallway of 4955 G Street SE, between the decedent, several females and a male IT knows as "Chili". W-3 reported during this argument IT observed a female spraying mace in the direction of Chili. W-3 then heard the Chili say, "Why the fuck you mace me", and immediately after that statement, the witness reported IT observed Chili reach in his waistband and remove a handgun. W-3 then observed the Chili turn toward the decedent and the other two females, and fire a single gunshot. During the same interview, W-3 changed its account of what occurred and stated that IT did not see Chili shoot the gun, but that IT was inside an apartment at the time of the shooting. W-3 later contacted your affiant and changed its statement again and stated that IT observed an unknown male in the hallway, and that he was the shooter, not Chili. However, W-3 could not provide any identifiable information about the unknown male shooter.

Based on the aforementioned facts and information, the affiant respectfully request a DC Superior Court Arrest Warrant be issued for **Charles Wennen Young, PDID# 669829.**
