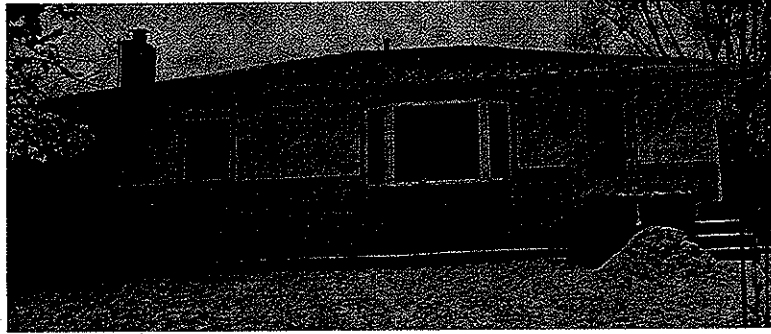



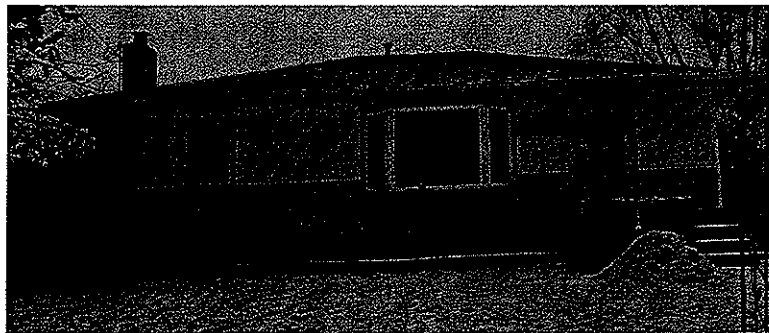

Your affiant conducted an investigation and received the following information:

This affiant has personally conducted various investigations in regard to Homicides, Burglaries, Thefts, Robberies, Fraud/Theft, Narcotics, Sexual Assaults, Child Abuse, Harassments and other criminal violations. I have received training within my employment with the Ankeny Police Department, regarding legal principles and statutes representing criminal violations of the Code of Iowa.

On 12-28-13, [REDACTED] reported to Ankeny PD Officer Matt Mortvedt that his wife's wallet had been stolen from the Ankeny office of the Iowa Clinic during the previous night. His wife, [REDACTED] works at the clinic and had left it on a desk on 12-27-13. Upon returning to work the following day her wallet was missing. After the wallet was stolen, several of [REDACTED]'s credit cards were used at Walmart, Murphy Brothers Gas, Maurice's, and Bass Pro Shops in Altoona, as well as Porter Hardware, McDonald's, Quik Trip, Gordman's, Walgreen's, and Famous Footwear on the east side of Des Moines. There were also multiple online purchases made with [REDACTED]'s credit cards with various merchants.

Officer Mortvedt spoke with [REDACTED], a supervisor for Marsden Cleaning, which was the company that provides janitorial services at the clinic. [REDACTED] told Officer Mortvedt that two people cleaned the clinic that night and he identified them as Randy Williams and [REDACTED]. Officer Mortvedt later spoke with Randy and Randy admitted to taking the wallet. He claimed he thought it belonged to [REDACTED] and she had already left the clinic so he took the wallet with the intention of returning it to her. Randy said he stopped by a Quik Trip gas station on his way home and purchased cigarettes. After leaving Quik Trip he went home and realized he no longer had the wallet and said it must have fallen from his pocket while he was at the Quik Trip store.

On 12-31-13 I was assigned to investigate [REDACTED]'s case. I reviewed surveillance video from Walmart, Murphy Brothers gas, Bass Pro Shops, and Walgreen's. A dark colored Tahoe, believed to be maroon in color, was seen on video at each business dropping off a white female who used the credit cards. The female was wearing red sweatpants with a white stripe in each incident except the Walmart purchase in which she appeared to be wearing jeans. In each incident she wore a dark colored coat with a hood pulled up which partially concealed her face. In the Walmart video, a white male exited the driver's seat of the Tahoe and briefly entered the store's vestibule. He wore tan coveralls, a dark colored, long sleeved, Carhartt shirt with the word "Carhartt" written on the left sleeve, and a tan stocking cap. While he was in the store he was talking on a cell phone. In video from the Quik Trip, a tall thin white male used one of the stolen credit cards to make a purchase of cigarettes. The male had a dark colored coat on with the hood pulled up which partially concealed his face.

One of [REDACTED]'s credit cards was used on 12-28-13 to make an online purchase at Instantcheckmate.com, which is a service that provides background checks on people. A subpoena was sent to the company and the records obtained from them showed the name provided at the time of purchase was [REDACTED] and the email address was [REDACTED]@gmail.com. Officer Mortvedt used pip.com to conduct an online

search of the email address and learned it belonged to Miranda Scigliano. Officer Mortvedt researched the Facebook page of Miranda Scigliano and discovered she was friends with a person named [REDACTED]. I subpoenaed Google and obtained records for the email address [REDACTED]@gmail.com. According to Google's records, the account holder was Miranda Scigliano which matched the earlier information obtained from *instantcheckmate.com*. Google's records showed the email address was active and was being logged into multiple times a day. A secondary email account linked to the Gmail account was [REDACTED]@yahoo.com which, according to Facebook, is another email address used by Miranda Scigliano. With the Google subpoena I also obtained IP addresses used to access the email account of [REDACTED]@gmail.com. On 1-28-14, I obtained information from Mediacom via subpoena that showed an IP address used frequently to access the [REDACTED]@gmail.com email account had a service address of 2113 E 41<sup>st</sup> Street in Des Moines, which corroborated the information provided by Randy Williams.

One of the stolen credit cards was used to make a purchase at Epoch.com. Pote told me that he contacted Epoch.com and learned the suspect provided an email address of [REDACTED]@gmail.com, which was the email account of Miranda Scigliano. The suspect purchased access to an internet porn site which would indicate the suspect was using an electronic device such as a computer, cell phone, or tablet to view and possibly download the porn.

I researched Ankeny PD records and discovered Miranda's boyfriend was Richard Adair. Ankeny PD records indicate Adair was 6'4" and weighed 170 pounds which would make him a likely candidate for a nickname of "Slim".

On 1-17-14 I met with Randy Williams at the Ankeny PD for an interview about this case. Randy told me he was living at 2315 E 41<sup>st</sup> Court in Des Moines which was his grandmother's house. Randy admitted to me that he took the wallet and claimed that he must have lost it at the Quik Trip at 3700 Hubbell Avenue when he stopped to purchase cigarettes. He later admitted that wasn't true and said that after he went home, he then went to a friend's house name Rob Williams who lives at 2101 E 41<sup>st</sup> Street in Des Moines. When he arrived at Rob's house, there were two other people there who Randy identified as "Miranda" and "Richie". Randy confirmed their whole names were Miranda Scigliano and Richard Adair. Randy told me that while he was at Rob's house, Adair took the wallet from him and did not give it back. Randy told me that Adair and Scigliano were both staying at a house two homes north of Rob's house. I reviewed Google maps with Randy and he confirmed the address as 2113 E 41<sup>st</sup> Street in Des Moines. He told me a subject named Justin Ross lived at 2113 E 41<sup>st</sup> Street with his mother and that Scigliano and Adair were staying in the basement. He described Justin as about 27 years old, white male, who drove a red Chevy Malibu. According to Ankeny PD records, the residents of 2113 E 41<sup>st</sup> Street include a 24 year old male named Justin Ross who owns a red Chevy Malibu which matched the information provided by Randy. Randy said that Justin's mother lived upstairs and Justin lived in the basement. Randy told me the house had surveillance cameras with a monitor for the cameras in the basement. He also told me that he had seen Justin with firearms including pistols and that he carries one with him.

FBI criminal history records show that Adair is a convicted felon and prohibited from possessing firearms. Since Justin and Adair both live in the basement, it is possible that Adair could have access to Justin's firearms depending on how they are being stored which would be a violation of law.

The receipts from Walmart showed that the stolen credit card was used to purchase a 46 inch Hisense TV, a Sony blue ray player, a six foot HDMI cable, an 18 volt Hitachi drill, a Samsung Galaxy S3 phone, a ZTE cell phone, and two phone cards. The video from Bass Pro Shops showed the female on her phone while she was in the store. I obtained a copy of the receipts which showed she purchased a pair of

brown/tan Carhartt coveralls, a dark colored hooded shirt with Carhartt written on the sleeve, and light gray women's Under Armour sweatpants. At Walgreen's the suspects rented a copy of "We're The Millers" movie from the Redbox kiosk outside the store. At Murphy's Brother's gas the female suspect purchased a large quantity of cigarettes to include Marlboro brand, as did the male who used the stolen credit cards at Quik Trip. One of the stolen credit cards was used to purchase a pair of gloves, a tape measure, a handle, and a circular saw at Porter Hardware. The stolen credit cards were also used to purchase unknown clothing from Maurice's in Altoona and unknown merchandise from Gordman's on Army Post Road. The female in the video appeared to be Miranda Scigliano however the male did not appear to be Richard Adair. The male who used the credit card at Quik Trip resembled both Richard Adair and Justin Ross but it is unknown the exact identity of the suspect using the card.

I know from training and experience that suspects who purchase items with stolen credit cards will often keep the merchandise for their own use and store the items in their homes or vehicles. It is possible to recover packaging and receipts for the merchandise in the home of the suspects which can provide evidence of the crime.

I am requesting to seize and search cell phones associated with Richard Adair, Miranda Scigliano, Justin Ross, and Randy Williams. Based on training and experience, I know cell phones can contain information vital to an investigation such as call records between defendants and other unknown co-conspirators, location information which can be used to determine if suspects were in an area at the time of a crime, photos which can contain GPS data and other incriminating information. This information can reside on the phone but not necessarily with the cell phone provider. Cell phones can hold a large amount of evidence to include photos, videos, call history, contact information, email, text messages, location history, internet history, emails, maps, digital memos, digital media, and electronic serial numbers. It is necessary to search the phones in order to obtain the data and the Ankeny Police Department has software that can be used to obtain the content from cell phones. In at least two of the incidents in this case, the suspects could be seen using cell phones and evidence linking them to the crimes will likely be on the phones.

FBI wanted person records show that Richard Adair has an outstanding arrest warrant issued by the Des Moines Police Department for Possession with Intent to Deliver Methamphetamine and a Tax Stamp Violation. FBI wanted person records show that Miranda Scigliano has an outstanding arrest warrant for OWI and Possession of a Controlled Substance issued by the Polk County Sheriff's Office.
