149 Household total income - The total income of a household is the sum of the total income from employment, self-employment, investment income, pension and disability income; income from employer and personal pension sources, inheritances, lump sum insurance settlements, capital gains and RRSP withdrawals. Capital consumption are excluded from this total income definition. Household private - Refers to a household where the household members are not temporarily absent on May 10 2011 (e.g. temporarily residing elsewhere) are considered.

150 After-tax income of households - The after-tax income of a household is the sum of the total income of households less provincial and territorial income taxes paid for 2010. Household private - Refers to a household where the household members are not temporarily absent on May 10 2011 (e.g. temporarily residing elsewhere) are considered.

151 Household total income - The total income of a household is the sum of the total income of households - The median income of a specified group of households is that amount calculated from unrounded data by dividing the aggregate income of a specified group of households by the number of households. Household private - Refers to a household where the household members are not temporarily absent on May 10 2011 (e.g. temporarily residing elsewhere) are considered.
