**GIVE BRIEF DESCRIPTION OF WHAT HAPPENED:**

(PAGE 1 OF 6)

On Monday, January 14, 2013, at approximately 10:42 am, members of the Metropolitan Police Department's Sixth District responded to 511 57th Street, Northeast, Washington D.C., for the report of a shooting. Upon arrival on the scene, officers discovered a male victim, the decedent who was later identified as Dominic Davis, suffering from apparent gunshot wounds. There were four expended shell casings, two bullets and multiple bullet fragments located on the scene. DCFD Engine 18 responded to the scene and transported the decedent to Prince George's County Hospital. The decedent was pronounced dead at 11:25 am by Dr. Daee of hospital's staff after all life saving efforts failed.

The Decedent's remains were transported to the Office of the Chief Medical Examiner for the State of Maryland for an autopsy. The autopsy was performed by Dr. King. Dr. King determined the cause of death were multiple gunshot wounds to the body and ruled the death a Homicide.

A witness was interviewed who will be referred to as W-1 for affidavit purposes only. W-1 said IT along with the Decedent were inside a vehicle in the 500 block of 57th Street, NE, Washington, DC, on January 14, 2013 when IT saw two black males wearing ski masks approaching the vehicle. W-1 described the first black male as tall, wearing a black jacket, gray jeans, a black ski mask, and armed with a silver semi-automatic handgun. W-1 described the second suspect as being shorter than the first suspect. The second suspect was wearing a black ski mask, a black jacket and light colored jeans. W-1 said the two suspects ordered W-1 and the decedent from the vehicle and directed them to lie on the ground.

The shorter suspect then "patted down" the Decedent and searched the vehicle in which W-1 was driving. W-1 said IT observed the shorter suspect get the gun from the taller suspect and shoot the Decedent while he was lying on the ground.

W-1 stated that after the shorter suspect shot the Decedent IT got up off the ground and ran and while doing so IT heard additional shots. W-1 looked back and observed the taller of the two suspects enter a four-door black vehicle that was parked in the alley. W-1 said IT looked at the tag; however IT could only remember the last four (4) numbers of the tag number. W-1 said it was a Maryland tag that had a number, two letters and the last four numbers of "4604" or "4804". W-1 said the vehicle then drove off.

The investigation revealed that a cellular telephone, U.S. currency, and a black wallet containing photographs, certification forms, and debit cards were taken during this Homicide/Robbery.

On Monday, January 14, 2013, a witness was interviewed who will be referred to as W-2 for purposes of this affidavit. W-2 said IT was in the area of the 500 block of 57th Street, NE, Washington, DC, on January 14, 2013. While in the area, IT saw a black vehicle drive and circle through the neighborhood at least twice. W-2 then saw the black vehicle drive into the alley of 500 block of 57th Street NE, Washington, DC. Moments later W-2 stated IT heard four gunshots. W-2 then saw two black males wearing black clothing running up the same alley. W-2 said IT heard the tires of a car screeching, and then heard a loud bang as if the vehicle hit something.

A query of the Metropolitan Police Department Tag Reader system was conducted utilizing the partial tag number of "4804" for a Maryland Tag. There were no vehicles found with that partial tag number.

**GIVE BRIEF DESCRIPTION OF WHAT HAPPENED:**

A query of the Metropolitan Police Department Tag Reader system was conducted utilizing the partial tag number of "4604" for a Maryland Tag. A return on the Maryland tag number "[REDACTED]" was obtained. A WALES check revealed the Maryland tag was listed to a black four-door Mazda 6 registered to the Enterprise Rental Company.

Detectives learned that W-3 had rented the vehicle on January 12, 2013. W-3 returned the vehicle on Monday January 14, 2013 at approximately 3:50 pm. The vehicle had minor damage on the right side. The rental contract indicated the vehicle did not have any damage when it was rented on January 12, 2013. Upon returning the black Mazda 6, W-3 requested another vehicle but did not provide a reason for the switch.

During the investigation, W-3 was interviewed. W-3 stated that on January 12, 2013, IT rented the Mazda 6 from Enterprise Rental Company. On the same day, W-3 gave the vehicle to W-7, W-8, and W-9 for their use. W-3 described W-7 as being a black male approximately 5'5 to 5'6 in height slim build with a dreadlock hair style. W-3 believed that W-7's age is approximately 18 to 19 years. W-3 stated W-7 does not have tattoos on his face but W-3 is not sure about his arms. W-3 described W-8 as being a black male, real slim, 16 to 17 years of age approximately, 5'6 or taller in height. W-3 believed W-8 had a star on the side of his face. W-3 described the W-9 as being a black male approximately 5'6 in height, brown skin with real yellow teeth and big eyes, with bumps on his face and his hair was cut. W-3 stated W-8 appeared to be similar in size to W-7.

W-3 stated IT called and spoke with W-8 on Monday, January 14, 2013 at approximately 11:08 am (approximately 60 minutes after the homicide) and stated he needed the vehicle returned to IT. W-3 stated W-8 replied, "OK." W-3 stated that on Monday, January 14, 2013, in the afternoon, W-7 and W-8 returned the vehicle to IT. W-3 identified both W-7 and W-8 to law enforcement. Both W-7 and W-8 were interviewed by law enforcement and denied any involvement in the homicide.

During the course of the investigation, W-3 was re-interviewed. W-3 stated that W-7 and W-8 did not return the rental car to IT on January 14, 2013, following the murder. Rather, RICO returned the car to IT. W-3 stated that IT did not initially tell law enforcement the truth because IT is afraid of RICO. W-3 has known RICO for more than one year.

Your affiant learned that Maudarico Proctor PDID number 608-781 is a relative of W-7 and goes by "RICO." Detectives presented W-3 with a single colored photograph of Maudarico Proctor with PDID# 608-781. W-3 positively identified Maudarico Proctor with PDID# 608-781 as the person IT knows as "RICO", the person who returned the Black Mazda rental car to W-3 on Monday, January 14, 2013, after the homicide of decedent Dominic Davis.

During the course of the investigation, W-4 was interviewed. W-4 stated that on January 14, 2013, IT was in the area of the 300 block of 37<sup>th</sup> Street Southeast, Washington, DC when the black 4-door Mazda 6 rental car was returned to W-3. W-4 observed a person whom "IT" knows as SHITTY aka RICO exit the rental car. Then, W-4 observed SHITTY aka RICO give the keys to W-3 and W-3 entered the car to return it to the rental car company. According to W-4, during the cleaning of the rental car, a black ski mask was found inside the car. The ski mask and trash were discarded. W-4 further stated that IT told W-7 that a black ski mask was found in the vehicle. W-7 asked what happened to the mask. Upon learning that the mask was discarded, W-7 replied, "Thank You! Thank You!"

The investigation revealed that Maudarico Proctor, PDID 608-781 has an aka of "SHITTY". Detectives presented W-4 with a single colored photograph of Maudarico Proctor with PDID# 608-781. W-4 positively identified Maudarico Proctor with PDID# 608-781 as the person IT knows as "SHITTY."

A witness was interviewed who will be referred to as W-5 for purposes of this affidavit. W-5 stated that Rico told IT that he (Rico) and an accomplice caught a guy behind a building or alley. The accomplice smacked the guy with a gun and then he (Rico) shot the decedent. Rico stated, "I went all Wayne Perry on his ass." Rico advised W-5 the only evidence the police has on him is that he gave a black rental car back to the guy who rented the car and that guy may tell the police if he gets caught. W-5 stated that Rico said the shooting was in retaliation for a shooting that happened on 37<sup>th</sup> Street SE when twin got killed. Rico stated that at the time of the shooting he had on a mask and the hood to his coat was on his head. At the time W-5 provided this information to law enforcement, W-5 was incarcerated for an unrelated matter.

Detectives presented W-5, who has known Rico for more than a year, with a single color photograph of Maudarico Proctor, PDID# 608-781. W-5 positively identified Maudarico Proctor with PDID# 608-781 as Rico who told W-5 that he shot and killed the decedent.

Another witness, who will be referred to as W-6 for purposes of this affidavit, was interviewed. W-6 stated that prior to the murder of the decedent, Rico asked if "IT" knew "SET." When W-6 confirmed "IT" did know SET, Rico made a statement to the effect of, I'm going to kill or get him the next time I see him. W-6 advised

the defendant to be careful because the decedent was known to "put in work." W-6 indicated that "put in work" is a street term to describe a person who is believed or known to have killed. W-6 stated the defendant lifted his shirt and displayed a black in color Glock handgun with a 30 round magazine in his waist band. At the time W-6 disclosed this information, W-6 was incarcerated in an unrelated matter.

Detectives presented W-6, who has known Rico for more than a year, with a single color photograph of Maudarico Proctor with PDID# 608-781. W-6 positively identified Maudarico Proctor with PDID# 608-781 as the person who made the statement to the effect of I'm going to kill or get him the next time I see him, and displayed a Glock handgun with a 30 round magazine in his waistband.

An anonymous call was made to the Homicide Branch. The anonymous caller stated that a person named "Donte" ran into the upstairs of a residence. "Donte" was followed by an individual. The individual returned to where the anonymous caller was located and stated "shut the fuck up, "he" just shot "Set", or words to that effect. The individual did not identify who "he" was. Your affiant knows that "Set" is a nickname for the decedent in this case.

On Tuesday, February 5, 2013, a search warrant was executed on the home address of the defendant. During the course of this search warrant, the defendant's cellular phone was seized. A search of his cellular telephone, revealed several photographs depicting the defendant holding what appears to be silver handgun. Based on the photograph properties the photograph was taken on Monday, January 14, 2013 at 7:11 pm. This search also revealed several photographs depicting the defendant holding what appears to be a black in color semi-auto handgun with a large capacity round magazine.

Based on the facts and circumstances, your Affiant respectfully request that a Superior Court of the District of Columbia arrest warrant be issued for Maudarico Proctor PDID 608-781.
