

ATIP Memorandum

Jim,

I've attached scanned letters and email correspondence on five access requests, three requests for previously released documents, plus the OIC request.

As of writing this I am still waiting on the Bank of Canada, which last updated me on March 17 to say they'll need an additional week before they can tell me if my request has turned up documents. There was a delay on this request because the Bank receives the processing payments directly, not the receiver general, so I had to send them a new cheque before it could be processed. I also spoke on the phone with two coordinators to clarify the types of documents I was looking for on March 3rd, at which point we agreed to omit emails and repeat draft versions of documents.

For convenience/brevity, here are my municipal and provincial ATIP request descriptions. The federal requests were repeated verbatim in confirmation letters, which are attached.

No federal level documents were mailed to me outside of correspondence, in one case (Department of Justice) because it was cabinet confidence and the other because the documents didn't exist (Department of Heritage). Both Elliot Lake and the Cabinet Office returned documents; however, neither included the information I was searching for (the latter was mostly partially redacted media monitoring).

Request to City of Elliot Lake:

Any records pertaining to what projects were consider or how project selection was made prior to funding application to the Building Canada fund. Specifically anything drafted between Sept. 2008 and January 2009 that discloses the full range of project considerations before being presented to council.

Ontario Cabinet (Premier's) Office:

Any records, briefing notes, polling data or reports between Nov. 2013 and end of Jan. 2014 related to the Elliot Lake Algo Centre Mall Inquiry. Please exclude documents of Cabinet confidence and consider waiving fees because the request is made in the public interest.




