On Saturday, March 29, 2014, at 0023 hours members of the Seventh District were dispatched to the 1200 block of Eaton Place SE, Washington, DC, to investigate a report of sounds of gunshots. The officers arrived on the scene and found the victim lying on the sidewalk suffering from apparent gunshot wound to the head. DCFD Medic unit #7 arrived on the scene and began emergency lifesaving treatment. The victim was then transported to MEDSTAR Hospital, where he succumbed to his injuries and was pronounced dead at 0115 hours, by Dr. Felder. The decedent was identified as being Derrick Eugene Williams, and his remains were transported to the OCME office pending autopsy.

On Saturday, March 29, 2014, an autopsy was conducted on the remains of Derrick Eugene Williams. Dr. Pierre-Louis of the OCME office concluded that the cause of death was a single gunshot to the head, and the manner of death "Homicide".

During the autopsy, ballistic evidence was recovered from inside the skull of the decedent.

On Saturday, March 29, 2014, a witness was interviewed by Detective's; this witness will hereinafter be referred to as W-1. W-1 reported that IT was in the 1200 block of Eaton Place SE, Washington, DC when IT heard two gunshots coming from outside in the alley across the court yard. W-1 then heard a third gunshot that IT believes was in front of 12 Eaton Place SE.

W-1, seconds later observed two suspects outside standing over a victim lying on the grassy area between 12 and 12 Eaton Place SE. W-1 observed the first suspect pulling the victim's legs, and then the same suspect was observed going in the victim's pockets and taking what appeared to be money and putting it in his pocket. W-1 then observed the same suspect running from the victim, holding his waist band as if he was carrying a weapon.

W-1 described the suspect IT observed going in the victim's pocket and running away holding his waist band as; black male, approximately 24 y.o.a., long dreads, medium to dark complexion., 5'9", some facial hair, looks like he works out, wearing all black. W-1 described the second suspect as; black male, 15 to 17 y.o.a, shorter than 5'9", slim, and wearing a red jacket.

During the conclusion of the interview, W-1 advised the Detectives that IT knows the first suspect as "Face", and has known the suspect for over ten years. Based on the witnesses' knowledge of the first suspect, IT was shown a single "Confirmation" photo. The witness immediately responded to the photo by stating, "Yeah that's him, that's exactly who it is". The witness was asked by the Detectives, "Is the person in the photo, the same person you know as "Face", and the person you observed going through the victims pockets after you heard the gunshots"? The witness replied, "Yeah". The single photograph shown to the witness is a photo of the defendant, Gregory Allen Green (PDID 583286).

W-1 provided text messages that were sent hours prior to talking to Detectives. The messages are consistent with the aforementioned version of events W-1 reported to the Detectives.

A canvass of the area the witness reported IT heard the gunshots coming from, revealed two shell casings, and one cartridge.

Based on the aforementioned facts and information, the affiant believes probable cause exists and respectfully request an arrest warrant be issued for the defendant Gregory Allen Green (PDID 583286).
