GIVE BRIEF DESCRIPTION OF WHAT HAPPENED:									
<p>On Wednesday, July 17, 2013, at approximately 2339 hours, members of the Sixth District were dispatched to the 300 block of Ridge Road, SE, Washington, DC, for the report of shooting. Upon arrival on the scene, officers located Anthony Chase (hereinafter Decedent Chase) lying in front of 155 Ridge Road, SE, and Eric Leeper (hereinafter Decedent Leeper) located across the street, and in front of 3 Ridge Road, SE. Officers also located a third shooting victim, hereinafter, V-1, still on the scene. Decedent Chase was found with multiple gunshot wounds and was determined deceased and remained on the scene. Decedent Leeper, also suffering from multiple gunshot wounds, was transported to Prince Georges County Hospital for medical treatment but succumbed to his injuries. Decedent Leeper was pronounced dead on July 18, 2013 at 0335 hours by Dr. Clark of the hospital staff. The remains of Decedent Chase were transported to the Office of the Chief Medical Examiner for the District of Columbia where he was pronounced dead on July 18, 2013, at 0622 hours by Dr. Michelle Mack.</p>

GIVE BRIEF DESCRIPTION OF WHAT HAPPENED:									
<p>On Thursday, July 18, 2013, Dr. Goslinoski of the Office of the Chief Medical Examiner for the District of Columbia performed an autopsy on the remains of Decedent Chase. Dr. Goslinoski determined that the cause of death was multiple gunshot wounds and the manner of death was ruled a homicide. An autopsy of Decedent Leeper was conducted by Dr. Brassel of the Maryland Office of the Chief Medical Examiner. Dr. Brassel determined that the cause of death was multiple gunshot wounds and the manner of death was ruled a homicide.</p> <p>The investigation recovered ten (10) .40 caliber S&W cartridge casings from the yard area in front of 314 Ridge Road, SE. Seven of those casings were identified as having been fired from the same firearm. The remaining three casings could not be identified or eliminated as having been fired from the same pistol or firearm as the other casings.</p>

GIVE BRIEF DESCRIPTION OF WHAT HAPPENED:									
<p>During the investigation, a witness, hereinafter W-1, was interviewed. W-1, a Metropolitan Police Department officer, reported that it was traveling in an unmarked vehicle in the 300 block of Ridge Road, SE, when it heard the sound of what it believed to be fireworks. W-1 then observed a single person firing a gun in front of 3 Ridge Road, SE, southbound and in the direction of Ridge Road. W-1 reported that it did not see any other person in the block and did not know who the shooter was firing at. W-1 described the shooter as a black male, dark complexion, wearing a black tank-top, and blue jean shorts that came below his knees. W-1 also reported that the shooter covered his head with a black t-shirt, but left his face exposed.</p> <p>Another witness, hereinafter W-2, also a Metropolitan Police Department officer, reported that it, too, was in the 300 block of Ridge Road, SE, when it heard the sound of gunshots. W-2 reported that, as it traveled in the block, it heard gunshots. After the start of the gunshots, W-2 observed a single gunman standing in front of 3 Ridge Road, SE, firing southbound toward Ridge Road.</p>

GIVE BRIEF DESCRIPTION OF WHAT HAPPENED:									
<p>W-2 described the shooter as a dark-complected black male, approximately 5'7" – 5'8" in height, in his 20s, stocky build, and wearing a black t-shirt and blue jean shorts. W-2 could not recall whether or not the shooter's head was covered. W-2 reported that it did not see any other person in the 300 block and did not know who the shooter was firing upon.</p> <p>A third witness, hereinafter W-3, reports that it was in the 3900 block of C Street, SE, which is one block from the scene of the murders. W-3 reported that it heard multiple gunshots coming from the direction of Ridge Road, SE. Approximately one minute after the end of the gunshots, W-3 reports that it saw two black males running away from C Street, SE, in the opposite direction of the gunshots. W-3 described one of the males as approximately 5'7" in height, stocky or heavy build, wearing a dark colored hoodie (with the hood over his head), dark colored jeans, and carrying a handgun. W-3 described the second black male suspect as taller and slimmer than the first suspect.</p>

GIVE BRIEF DESCRIPTION OF WHAT HAPPENED: <p>A fourth witness, hereinafter W-4, was also interviewed in reference to this investigation. W-4 reported that on Wednesday, July 17, 2013, at approximately 2320 hours, it was in the area of Bay Lane, SE, and Ridge Road, SE, when it observed V-1 driving southbound on Ridge Road, SE, in the direction of the residence of Decedents Chase and Leeper in the 300 block of Ridge Road, SE. Shortly thereafter, W-4 observed a gold, two-door vehicle speeding southbound on Ridge Road, SE, and quickly turning left on to Bay Lane, SE. The gold vehicle then drove through a stop sign at the intersection of Bay Lane and turned on Burns Place, SE, and sped away. W-4 approached Burns Place, SE, and observed the gold car park in the 3900 block of C Street, SE, approximately half a block away. W-4 reports that it saw a person that it knows as "Woo" get out of the driver's side of the vehicle. According to W-4, after "Woo" got out of the car, he put on a black shirt and wrapped a white t-shirt over his hair. "Woo" was wearing blue jeans. Another black male, hereinafter S-2, got out of the passenger side of the vehicle and put on a black ski mask, which exposed that suspect's eyes. W-4 observed "Woo" and S-2 run into a grassy area that led to the back of the 300 block of Ridge Road, SE.</p>



GIVE BRIEF DESCRIPTION OF WHAT HAPPENED: Shortly thereafter, W-4 entered the 300 block of Ridge Road, SE, and observed Decedent Chase, Decedent Leeper and V-1 standing in front of 3 Ridge Road, SE. Moments after entering the block, W-4 reports that it heard multiple gunshots and saw the decedents and V-1 begin to run toward Ridge Road. W-4 reports that it saw the person it knew as "Woo" and S-2 emerge from the side of 314 Ridge Road shooting at the decedents and V-1. "Woo" was still wearing the white t-shirt across his head and partially over his chin and S-2 was wearing the same black ski mask that W-4 had just seen both men put on. According to W-4, "Woo" followed Decedent Leeper as he ran, but Decedent Leeper stopped running a short distance from where he originally stood and was again shot by "Woo." S-2 ran after Decedent Chase, who ran across Ridge Road, SE. After Decedent Chase collapsed in front of 155 Ridge Road, SE, W-4 reports that S-2 stood over Chase and shot him again. W-4 reported that it saw V-1 run down Ridge Road after the shooting began. After S-2 shot Decedent Chase, W-4 saw S-2 shoot in the direction of V-1. According to W-4, "Woo" and S-2 fled the scene, but it did not know the direction in which they ran.
