Officers also located a third shooting victim, hereinafter, V-1, still on the scene. Decedent Chase was found with multiple gunshot wounds and was determined deceased and remained on the scene. Decedent Leeper, also suffering from multiple gunshot wounds, was transported to Prince Georges County Hospital for medical treatment but succumbed to his injuries. Decedent Leeper was pronounced dead on July 18, 2013 at 0335 hours by Dr. Clark of the hospital staff. The remains of Decedent Chase were transported to the Office of the Chief Medical Examiner for the District of Columbia where he was pronounced dead on July 18, 2013, at 0622 hours by Dr.

"Woo" was still wearing the white t-shirt across his head and partially over his chin and S-2 was wearing the same black ski mask that W-4 had just seen both men put on. According to W-4, "Woo" followed Decedent Leeper as he ran, but Decedent Leeper stopped running a short distance from where he originally stood and was again shot by "Woo." S-2 ran after Decedent Chase, who ran across Ridge Road, SE. After Decedent Chase collapsed in front of 155 Ridge Road, SE, W-4 reports that S-2 stood over Chase and shot him again. W-4 reported that it saw V-1 run down Ridge Road after the shooting began. After S-2 shot Decedent Chase, W-4 saw S-2 shoot in the direction of V-1. According to W-4, "Woo" and S-2 fled the scene, but it did not know the direction in which they ran.
