On Friday, April 25 2014, an interview was conducted with Witness #4 (W-4), who stated IT had been in a long term relationship with the decedent and the two had a child in common. W-4 stated on Sunday, April 20, 2014, (Easter Sunday) IT had gone to IT's mother's residence to have Easter dinner. W-4 stated the decedent picked IT up from the location later that night. When IT responded outside the decedent was smoking a cigar. W-4 then stated IT observed IT's cousin's boyfriend, who IT knows as

"Yates," parked directly behind the decedent's vehicle.

W-4 stated the decedent and "Yates" got into a verbal altercation. W-4 then observed the decedent pull out a black colored handgun. The decedent pointed the handgun at "Yates" and stated, "I will bust you" or something to that effect. W-4 stated IT separated the decedent and "Yates." W-4 and the decedent then left the area.
