<b>GIVE BRIEF DESCRIPTION OF WHAT HAPPENED:</b>									
<p>On Friday, April 25, 2014, members of the First District responded to the front of [REDACTED] Morris Place, Northeast, Washington, D.C., for a shooting. Upon arriving on the scene, members located a black male lying on the sidewalk, unconscious and unresponsive, suffering from multiple gunshots to the head. The male was later identified as Andre Pierce Joyner. D.C. Fire and EMS responded to the location and transported the victim to Med Star, where he was later pronounced dead by Doctor Street at 1603 hours. Crime Scene Investigation recovered multiple expended F.C. &amp; Win 9mm shell casings from the scene.</p> <p>Subsequently, on Saturday, April 26, 2014, Dr. Nikki Mourtzinos, D.C. Office of the Chief Medical Examiner, performed an autopsy on the decedent and determined that the "cause of death" was a gunshot wound to the head and the "manner of death" was homicide.</p>

**GIVE BRIEF DESCRIPTION OF WHAT HAPPENED:**

On Friday, April 25, 2014, an interview was conducted with Witness #1 (W-1), who stated while in the area of the 600 block of Morris Place, Northeast, IT heard the sound of four gunshots (two shots, followed by two more shots). As IT looked onto the 600 block of Morris Place, Northeast, IT observed a black male standing in front of a residence a short distance away from IT's position. The black male had his hand raised, carrying a black semi-automatic handgun, as he stood between the vehicles. The black male then walked with the gun in his hand, at a fast pace, towards a fairly new BLUE/GRAY, Nissan Altima with chrome trim, bearing a partial D.C. Tag "██████". The vehicle was last seen traveling eastbound on Morris Place, Northeast.

W-1 further describes this individual as a: B/M, mid 20's, med complexion, unknown facial hair, black hair, 5'11" to 6' tall, 220 lbs, wearing a blue "hoodie" with white strings (no writing) and tan pants.

**GIVE BRIEF DESCRIPTION OF WHAT HAPPENED:**

On Friday, April 25, 2014, an MPD officer reported he arrived on the scene and was approached by an unidentified person. This individual, Witness #2 (W-2), stated IT had written down the tag number. W-2 provided the information on a brown paper bag. W-2 stated, "I got the tag number of the vehicle that the guy got into." The tag number was "[REDACTED]"; however, no state was referenced. At this time, the officer voiced the lookout over the 1-D channel. The officer was unable to retrieve W-2's information before IT left the scene of the shooting.

On Friday, April 25, 2014, Witness #3 (W-3) was interviewed and stated while in the area of the 600 block of Morris Place, Northeast, IT was near the decedent when IT observed an unknown black male walking towards the decedent. The two exchanged words, as if they were going to fight. W-3 observed the unknown male holding a gun in his hand. However, W-3 believes the decedent "Dre" did not see the gun.



<p>The unknown black male began to shoot at the decedent, striking him several times as the decedent fell to the ground. At this time, W-3 fled westbound on Morris Place, Northeast, towards 6th Street, Northeast. W-3 further stated, following the shooting, IT responded back to where the decedent was lying and observed an individual standing near the body. This individual stated IT had written down the tag number of the suspect's vehicle. W-3 identified the shooter as a B/M, 26 to 30 years, no facial hair, tall in height, heavy build, bush haircut, wearing a white T-shirt, blue "hoodie" jacket, jeans or sweat pants, armed with a black hand gun.</p> <p>On Friday, April 25, 2014, an interview was conducted with an MPD member. The member stated while on patrol, monitoring the 5-D channel, at around 1538 hours, a lookout was broadcast for a Blue Nissan Altima Bearing D.C. Tag "[REDACTED]". The member ran the tag on the MDT (WALES/NCIC) and revealed the vehicle was registered to [REDACTED] in PSA 507. The member</p>

<p><b>GIVE BRIEF DESCRIPTION OF WHAT HAPPENED:</b></p> <p>advised he responded directly to the location. At 1546 hours, the member arrived at the location and began to secure the area.</p> <p>At approximately 1548 hours, the member observed the BLUE Nissan parked across the street from [REDACTED]. The member approached the vehicle and found it unoccupied. The member touched the hood and found the vehicle to be warm to the touch, as if the vehicle had been recently operated and parked. After Officers on the scene continuously knocked on the front door of the listed location, James Yates finally exited from the residence by coming through the front window wearing a white in color "wife beater" exposing a tattoo with the words "Big Yates." Yates was wearing jeans and had what can be described as a bush haircut. Once outside, James Yates refused to respond to the Homicide Branch to be interviewed. The house was secured in anticipation of obtaining a search warrant (and no individuals were allowed to enter the premises).</p>

W-4 stated IT has known "Yates" for approximately five to six years. On Friday, April 25, 2014, Detectives showed W-4 a single photograph of: James Walter Yates III, DOB: 08/01/1984 and PDID: 569-092. W-4 identified the person in the photograph as "Yates."

On Friday, April 25, 2014, detectives obtained a search warrant was for the residence of [REDACTED] Street, Northeast. At 2058 hours, the warrant was executed – no individuals were found inside the residence. During the search, officers recovered a Glock 19 9mm handgun from a second floor bedroom. The Glock 19 9mm handgun had one round in the chamber with no magazine. The weapon was stored inside of a blue New Balance bag. Further searching this bedroom, officers recovered an extended magazine with a projectile capacity in excess of 17 rounds, at the time of recovery the magazine was loaded with (10) 9mm rounds of F.C. & WIN ammunition. The magazine was recovered from inside of a trap door inside of the same closet where the Glock 19 9mm handgun was recovered.
