Count 4 Poss Firearm During Crime of Violence, 5 year(s) supervised release, \$2,000.00 VVCA

Drug Treatment, and Services. Educational Services. Mental Health Evaluation, and any Services deemed appropriate while incarcerated and while on Supervised Release.
