The victim was transported back to GWUH where he was admitted for his injuries. The victim was listed in grave condition and not expected to survive.  On Friday, May 9, 2014 at 1:53 p.m., the victim (hereinafter referred to as the decedent) was pronounced dead by Dr. Eric Corder from GWUH. The same afternoon, the Metropolitan Police Department (MPDC) released a portion of the 7-Eleven surveillance footage to the media and posted it on "You Tube" seeking the public's assistance to identify the suspects in the assault and robbery.

Upon viewing the footage, the Source said that IT is sure that the individual depicted in the footage wearing a white kufi is Zerrick Brown. The Source has known Zerrick Brown for years and is very familiar with him and people close to him. A confirmatory photo was shown to the Source and the Source confirmed that the photograph shown to IT is the person to which IT was referring. Zerrick Brown is hereafter referred to as Defendant.  MPDC personnel have known the Source in excess of ten years and during that time, the Source has										
	provided information that has helped close other homicides that have occurred in the District of Columbia. The Source has never provided false information.

abov Brow the 7 video was and a basis	On Wednesday, May 13, 2014, an MPD Officer (hereafter "Officer 1") saw, in passing, the above-mentioned confirmatory photo of the defendant and then identified the Defendant as Zerrick Brown. Officer 1 then viewed a portion of the "You Tube" video footage of the suspects captured by the 7-Eleven surveillance cameras to ascertain if he could identify the suspects. Upon viewing the video footage, he identified S-1/Defendant as Zerrick Brown. Officer 1 could not identify S2.
