On Monday April 28, 2014 at approx. 1640 hrs. Ofc. Deleon #1874 and I were on duty as San Francisco Police Officers working in plain clothes, assigned to the Airport Bureau's Ground Transortation Unit. At this time, we were patrolling the upper level domestic roadways, when we saw a gray Ford Escape with Ca plates 5ZXN711 drive past us. We saw that the driver had a lone female passenger in the right rear passenger seat of the vehicle. Believing this to be a vehicle for hire, we followed the vehicle to where it stopped at upper level Terminal 3 at Door 9.

The driver exited the vehicle and unloaded the passenger's bag and then handed it to her. She then entered the terminal. I approached the driver on foot as he was about to enter his vehicle and identified myself as a San Francisco Police Officer using my department issued star. I asked the driver which company he was dropping of for and he stated Uberx. I asked to see his waybill and he seemed reluctant to show me. He told me, "I haven't done anything wrong. I never come here. I only work in Oakland." I told him that Uberx was not allowed to operate at SFO without permits, a waybill and trade dress. He then got into his vehicle to pull out an Uber windshield display (Uber's trade dress). He had placed the Uber display on the front passenger floor. I asked him why he didn't place

At this point, I asked Ofc. Deleon to stay with the driver while I attempted to make contact with the passenger. I saw her entering the Security Checkpoint F2. I made contact with her on the sterile side of security and identified myself as a San Francisco Police Officer using my department issued star. I asked her who the driver was that dropped her off today. She stated that she didn't want to answer my question. I told her that I suspected he was operating an illegal limo or taxi. She asked, "What? Are you trying to stop Uber drivers from working at the airport?" I told her I just needed to know how she made arrangements with the driver to give her a ride today. She wanted to know if she answered my questions, would the driver get in trouble? I stated that based on the information I have he will receive a citation either way. She was still reluctant to cooperate not wanting the driver to get in trouble. She said, "You want me to get the guy who just gave me the best ride ever to be in trouble? He came right away as soon as I called him. Within minutes." I asked her, "So how did you call him?" She did not answer. I told her that I suspected she used the Uber application but that the driver she called was not the driver who showed up. She was suprised. Still having the driver's Uber phone in my hand, I showed her a picture of the driver she requested and told her that that was not the driver outside that dropped her off. She then admitted to using the Uber app on her phone and told me that she was picked up on 24th St. in SF. She even showed me that she paid \$31 for the ride. She then apoligised for being difficult and gave me her information for the report. Her business card identified her as. She then left to catch her

I returned to the location of the stop and Ofc. Deleon told me that he had requested Headquarters to do a registration check on the vehicle and it came back with over 50 unpaid parking violations. Ofc. Deleon informed the driver that he was towing the vehicle per 22651(i) CVC, more than 5 unpaid parking citations. I asked the driver for his insurance and registration card. He gave me his registration for the vehicle registered to him but his insurance was expired.

I issued a written admonishment for SFIA 4.7(A)(2) Operating without an SFO permit and No trade dress. I also cited for CVC 16028(a) No proof of insurance. (citation #94-225927) He signed the citation as a promise to appear, not an admission of guilt and was given his copy. I also gave him a copy the letter sent to all TNC's that require them to have an SFO permit. Ofc. Deleon completed the tow form and San Bruno Auto Center towed the vehicle for storage at Lot D.
