GIVE BRIEF DESCRIPTION OF WHAT HAPPENED:									
<p>On Wednesday, June 04, 2014 at approximately 0242 hours, members of the Metropolitan Police Department, 5th District Patrol Section, received a radio run to assist Fire and EMS in the 1900 block of Fenwick St NE. Officer Castan responded to the scene and was advised by FEMS personnel that Ambulance 13 was flagged down by a citizen who advised that there was a person lying on the sidewalk. Ambulance 13, Engine 10, and EMS 1 responded to the scene where the decedent was located, on the east sidewalk of the 1900 block of Fenwick St NE, where they located the decedent lying face down. The decedent was not conscious, not breathing and showed no signs of life. The decedent remained on the scene. The decedent was pronounced dead at 0450 hours by MLI Leigh Letichevsky. The decedent was transported to the Office of the Chief Medical Examiner and an autopsy was conducted by Dr. Goslinoski. The cause of death was ruled a gunshot wound of the torso and the manner was ruled a homicide. A single bullet was recovered from the torso of the decedent. Furthermore, during the post mortem examination, wounds and contusions consistent with being punched or struck in the face were found on the decedent's mouth. There are also cuts</p>

<p>on the knuckles of the decedent's left hand. The decedent was later identified by fingerprints as Rashard Raigs. Approximately 10 yards south of the decedent there was a green blanket laid out on the ground on the sidewalk and personal belongings laid out on and around the blanket. There was a blue candle in a glass container on the blanket that appeared to have been knocked over, and blue candlewax spilled and dried on numerous items on the blanket and on the sidewalk outside of the blanket. A neoprene laptop case was found just north of the blanket next to a power cord for a laptop computer. The case did not contain a computer, but contained three bottles of nail polish (blue, a blue/green color, and a bright green color). Furthermore, candlewax was spilled on the computer mouse and the decedent's clothing. Bluish nail polish was also found on the decedent. Detectives obtained video that shows the 1900 block of Gallaudet St NE and the intersection of Gallaudet and Fenwick St. NE. Detectives later obtained additional video footage that showed a better view of the offense and the intersection of Gallaudet and Fenwick. In this video, the following is observed: 10:09:58 - A subject wearing a kufi (black male, medium to dark complexion, thin build also dressed in plaid long sleeve shirt, light to medium pants, and white shoes) is seen emerging from Providence to Gallaudet St and walks east on Gallaudet St. This subject is wearing a Kufi identical to that seen being worn by Demetrich Jones on June 5, 2014. Jones's physical build and complexion are also consistent with the subject seen in the video. 10:10:35 - Subject wearing kufi reaches the intersection of Gallaudet and Fenwick St NE, and proceeds to walk north on Fenwick and out of sight of the camera.
