Upon arriving on the scene, the officers were advised by DC Fire & EMS personnel that the driver of the vehicle was found to be suffering from an apparent gunshot wound to the head and was transported to MedStar by ambulance. The decedent succumbed to his injuries and was pronounced dead at 2226 hours by Dr. Staszak. His remains were transported to the Office of the Chief Medical Examiner for the District of Columbia where an autopsy was performed. The decedent has been identified as Kevin Lanar James. On Friday, January 17, 2014, a post-mortem examination was conducted on the decedent's remains by Doctor Goslinoski of the Office of the Chief Medical Examiner for the District of Columbia. At the conclusion of his examination, Doctor Goslinoski determined that the decedent's death was caused by two gunshot wounds to the right side of the head, behind the right ear and ruled the manner of death a Homicide. As a result of this shooting, the MPD's Homicide Branch initiated an investigation. As a result, several witnesses were interviewed. One witness was interviewed and will hereinafter be referred to as W-1. W-1 advised while in the area of the 1500 block of Gallatin Pl., NE, IT heard what sounded like a traffic accident in the block. W-1 observed a BMW that had struck a light pole and a parked vehicle on the street. As W-1 exited IT's location, IT observed the front passenger's door of the BMW open. Upon moving closer to the BMW, IT observed that only the driver occupied the vehicle and the driver's door was closed. W-1 advised that it was apparent that the driver was injured and 911 was contacted.										
Your affiant observed a significant amount of blood inside the vehicle that included the driver's seat along with blood spatter located on the back seat and left rear window of the vehicle. Your affiant also observed that all of the vehicle's windows were closed, except for the driver's window, which was down slightly. It appeared that the decedent sustained a gunshot wound to his head behind his right ear while seated in the driver's seat of the vehicle, suggesting the gunman was also inside the vehicle when the

	The BMW was subsequently towed to the Consolidated Forensic Lab for the District of Columbia where a District of Columbia Superior Court search warrant was executed. Several items of evidence were recovered from within the vehicle, to include a gray T-Mobile cellular phone, which was determined to belong to the decedent. A forensic examination was subsequently conducted on the decedent's cellular phone and revealed that the decedent made several calls to an individual listed as Kev with the number of 202-765-9767 shortly before his demise. The last call to this number was at approximately 07:33 pm which is 6 minutes before the initial 911 call to police. Additionally, a series of text messages were exchanged between the decedent and the individual listed as Kev. The content of the text messages suggests that the decedent was upset that Kev "fucked him over", demanding repayment of monies owed or he would seek payment from Kev's family.
