On 13 October 2014, I, Officer J. Kimbrough #3393, was dispatched to Dillard's, located at 2603 Preston Rd., Frisco, Collin County, TX, in reference to a theft.

Upon arrival, I interviewed Marjorie Lozano (W/F; 02-03-54). Lozano advised me that she was watching a subject, later identified as Joseph Randle (B/M; 12-29-91), on Dillard's closed circuit video surveillance system. Lozano observed Randle purchase an item at the perfume counter then walk to the underwear section. Lozano observed Randle select a package of underwear and conceal the merchandise in his Dillard's bag from his prior purchase. She then watched as Randle walked out of the kitchen section of the store past all points of sale and into the parking lot. Lozano radioed for security to stop Randle. Lozano provided me with a copy of the surveillance video.

I interviewed Raymond Wymer (W/M; 01-03-50) who is a security officer for Securitas and assigned to Dillard's. He advised me that he received word that the subject later identified as Randle had stolen an item and was in the parking lot. Ray entered the parking lot and advised Randle to stop and return to the store. Ray waited with Randle until a Dillard's manager arrived.

I interviewed Jacob Ramsey (W/M; 01-21-85) who is a manager for Dillard's. Ramsey advised me that he escorted the subject later identified as Randle back to the loss prevention office and recovered a 2 pack of black Polo underwear valued at \$39.50 and a "tester" bottle of Gucci Guilty Black cologne valued at \$84.00 from Randle. The total value of the stolen items is \$123.50 prior to tax.

I observed the stolen items. I observed the "tester" bottle of Gucci Guilty Black was almost full as there was little headspace left in the bottle. Ramsey provided me with a photograph of the stolen items and a copy of the receipt detailing the costs of the items.

I viewed the surveillance video of the incident. I observed Randle standing at the perfume/cologne counter. When Randle is handed his Dillard's bag with the item he purchased, he walks by an item on the counter and grabs the item. I then observe him conceal the item in his Dillard's shopping bag. Due to the camera angle, I was unable to see what the item was that Randle concealed. I then observed Randle walk towards the underwear section of the store. I observed him select a package of underwear and place the item in his Dillard's shopping bag. Randle then walks out of the store past all points of sale without attempting to pay for the concealed items and into the parking lot.

Due to the video evidence and the statements by Dillard's staff, I arrested Randle for Theft \$50/\$500. I placed Randle in the rear of my patrol unit #3206 and began transporting him to the Frisco jail to be processed. Before I left the mall parking lot, Randle stated that he should have just kept walking to his car if he knew he would be arrested. He stated that when he saw the "old guy" (Wymer) he thought, "Alright, y'all got me". Randle made these statements without any questioning or other statements from me.

I secured the CD containing the surveillance video in the property room as evidence. The photograph of the stolen items and the copy of the receipt were submitted to records to attach to this report.

On Monday, October 13, 2014, at approximately 8:17 PM, Officer J. Kimbrough and I (Officer R. Chandler #3399) were dispatched to Dillard's, located at 2603 Preston Road, Frisco, Collin County, Texas, in reference to a shoplifter that was detained. Officer Kimbrough and I arrived at the same time and entered the loss prevention office. In an adjacent office I observed the suspect seated. Officer Kimbrough and I entered the room where the suspect was and observed that a Securitas Security Guard, Raymond Wymer, white male, date of birth 01/03/1950 was sitting with him. Officer Kimbrough verbally identified the suspect as Joseph Randle, black male, date of birth 12/29/1991. Officer Kimbrough asked me to stay in the room with Randle while he completed his investigation in the loss prevention office. While standing by with Randle I observed a bag of merchandise on the ground next to his feet that he stated he had paid for. When I asked Randle what he stole, he replied that he took some underwear and a tester bottle of cologne. He stated that he did not pay for the merchandise because he did not want to take the time to do it.

After a short while Officer Kimbrough returned and had Randle sign a criminal trespass warning. Officer Kimbrough then advised Randle he was under arrest for theft and placed him in handcuffs. Officer Kimbrough then transported Randle to the Frisco Jail. Officer Kimbrough had me stand by in the loss prevention office to collect statements from the witnesses and to collect a copy of the in store video.

I received three written statements from Raymond Wymer, Marjorie Lozano, white female, date of birth 02/03/1954, and Jacob Ramsey, white male, date of birth 01/21/1985. I was also provided a copy of the in store video on a disc by Lozano. I later turned all of these items over to Officer Kimbrough. I had no further involvement in this case.
