## Dear Coroner Philpot:

Scripps Howard News Service based in Washington, D.C., is conducting a national reporting project looking into the 185,000 unsolved homicides committed in the United States since 1980. As part of this project, we are investigating whether it's possible to spot victims of serial murder among these unsolved killings using the FBI's Supplementary Homicide Report.

Using multivariate analysis, we've determined that Gary, Indiana, has an elevated number of unsolved murders of women who were strangled in recent years. The data that local police departments reported to the FBI are consistent with the possibility that multiple-victim killers have operated in northwestern Indiana.

Broadly, we see two possible patterns. In recent years, several women have been strangled in their homes. In at least two cases, a fire was set after the women were killed. Also, starting in the 1990 s we've seen several women who were found strangled in or near abandoned buildings.

We doubt these killings are the result of convicted serial killer Eugene V. Britt, who admitted to killing eight people in 1995.

Please note the attached list of homicide victims. We'd be grateful if your investigators would review these cases to determine if any might have a common perpetrator.

Thank you for your time and consideration. Please help us explore whether national crime data can assist local law enforcement.
