On December 10, 2014, the complainant and witness were talking just inside the green doors at City Hall on L1 shortly before 8:00am. Due to the new security measures, the doors were locked and would not be opened until 8:00am. The complainant and the witness stated they observed the suspect, later identified as Councilman Tennell Atkins B/M , wearing a business suit, walking up to the locked doors and begin jerking on them. The complainant stated she asked the suspect if he had his ID card with him. The suspect responded "Open the door!" The complainant stated she stated she wasn't supposed to due to the new security measures and if he didn't have his ID he would need to go to the blue doors and see security. The suspect continued jerking on the doors yelling "open the door!" Both the complainant and the witness then heard the door buzzer and the suspect walked inside. The suspect approached the complainant, grabbed her by the shoulders and yelled in her face "do you know who I am? Why didn't you open the door?" The complainant replied she didn't know who he was and that she was not supposed to open the doors for people due to the security measures. The complainant stated the suspect replied, "I'm Councilman Atkins, it doesn't apply to councilmen!" The complainant stated she told him he needed to take it up with security and he responded he would and stormed off.

The complainant stated she was not injured, but was upset at the way she was treated, embarrassed and offended that the suspect grabbed her in such a manner.

The suspect, Tennell Atkins is being issued an at large citation #C20-292384 for Assault-Offensive Contact 22.01 M/C
