Subpart F – Appeal Procedures

§171.52 Appeal of denial of access to, declassification of, amendment of, accounting of disclosures of, or challenge to classification of records.

- (a) Right of administrative appeal. Except for records that have been reviewed and withheld within the past two years or are the subject of litigation, any requester whose request for access to records, declassification of records, amendment of records, accounting of disclosure of records, or any authorized holder of classified information whose classification challenge has been denied, has a right to appeal the denial to the Department's Appeals Review Panel. This appeal right includes the right to appeal the determination by the Department that no records responsive to an access request exist in Department files. Privacy Act appeals may be made only by the individual to whom the records pertain.
- (b) Form of appeal. There is no required form for an appeal. However, it is essential that the appeal contain a clear statement of the decision or determination by the Department being appealed. When possible, the appeal should include argumentation and documentation to support the appeal and to contest the bases for denial cited by the Department. The appeal should be sent to: Chairman, Appeals Review Panel, c/o Appeals Officer, A/GIS/IPS/PP/LC, U.S. Department of State, SA-2, Room 8100, Washington, DC 20522-8100.
- (c) *Time Limits*. The appeal should be received within 60 days of the date of receipt by the requester of the Department's denial. The time limit for response to an appeal begins to run on the day the appeal is received. The time limit (excluding Saturdays, Sundays, and legal public holidays) for agency decision on an administrative appeal is 20 days under the FOIA (which may be extended for up to an additional 10 days in unusual circumstances) and 30 days under the Privacy Act (which the Panel may extend an additional 30 days for good cause shown). The Panel shall decide mandatory declassification review appeals as promptly as possible.
- (d) Notification to appellant. The Chairman of the Appeals Review Panel shall notify the appellant in writing of the Panel's decision on the appeal. When the decision is to uphold the denial, the Chairman shall include in his notification the reasons therefor. The appellant shall be advised that the decision of the Panel represents the final decision of the Department and of the right to seek judicial review of the Panel's decision, when applicable. In mandatory declassification review appeals, the Panel shall advise the requester of the right to appeal the decision to the Interagency Security Classification Appeals Panel under §3.5(d) of E.O. 12958.

NONETHELESS, LIBYANS FROM THE UK -- POSSIBLY EVEN SOME WITH LONDON PEOPLE'S BUREAU LINKS -- COULD WELL HAVE TRAVELLED TO IRELAND RECENTLY UNBEKNOWNST TO IRISH AUTHORITIES (DFA OFFICIALS DON'T THINK SO BUT COULD NOT RULE OUT THE POSSIBILITY). 1. (C) SUMMARY:

ACCORDING TO ITALIAN MFA MIDDLE EAST AND NORTH AFRICA CHIEF LIOTTA, BRITISH/LIBYAN TALKS IN ROME MARCH 5 WERE UNPRODUCTIVE. LIOTTA SAID QADHAFI'S RECENT THREATS TO SUPPORT TERRORISTS IN ITALY, GERMANY AND IRELAND WERE NOTHING NEW AND BEST IGNORED; BUT HE ADDED THAT ITALY DOES POINT OUT TO QADHAFI THE NEGATIVE EFFECTS OF SUCH STATEMENTS. END SUMMARY.

2. (C) BRITISH/LIBYAN TALKS:

LIOTTA SAID THAT BOTH LIBYA AND THE UK HAD WANTED BI-LATERAL TALKS, AND HAD IDENTIFIED ROME AS THE DESIRED LOCATION. HE ALSO SAID, HOWEVER, THAT ITALY HAD WORKED CONFIDENTIAL

TO BRING THE TWO SIDES TOGETHER. THE MARCH 5 TALKS IN-VOLVED BOTH "LIGHT AND SHADOW," SAID LIOTTA, AS WAS TO BE EXPECTED. THE DISTANCE BETWEEN THE TWO REMAINS GREAT, HE CONCLUDED.

3. (U) QADHAFI THREATENS TO SUPPORT TERRORISM:

THE ITALIAN PRESS MARCH 4 REPORTED REMARKS BY LIBYAN LEADER QADHAFI TO THE EFFECT THAT IF ITALY, GREAT BRITAIN,

AND WEST GERMANY TREAT THE "TERRORIST MOVEMENTS" HOSTILE TO LIBYA AS DEMOCRATIC OPPOSITION, THEN LIBYA WILL CONSIDER THE IRA, THE RED BRIGADES AND THE BAADER-MEINHOF GANG AS "REVOLUTIONARY OPPOSITION."

- 4. (U) THE FOLLOWING DAYS' PRESS WAS RICH IN INDIGNANT STATEMENTS BY A WIDE RANGE OF ITALIAN POLITICAL FIGURES, WITH A CHRISTIAN DEMOCRATIC LEADER DECLARING, "ONE CANNOT CONTINUE TO PRETEND THAT NOTHING HAS HAPPENED, THE RISK IS REAL..." A SOCIALIST PARLIAMENTARIAN WONDERED WHETHER THIS WAS THE ONLY RESULT OF ITALY'S POLICY OF "EQUIDISTANCE" IN THE MIDDLE EAST/MEDITERRANEAN, WHILE A MEMBER OF THE LIBERAL PARTY SCORED EFFORTS TOWARD BETTER TIES WITH LIBYA AS "A FAILURE." ON THE EXTREMES, THE NEOFASCIST MSI CALLED FOR A BREAK IN RELATIONS WITH TRIPOLI, AND THE OFFICIAL COMMUNIST PAPER CALLED QADHAFI'S STATEMENT "AN INADMISSIBLE ATTACK ON OUR COUNTRY."
- 5. (U) SUBSEQUENTLY, LIBYA'S AMBASSADOR IN ROME ATTEMPTED TO CLARIFY WHAT QADHAFI HAD MEANT, TELLING LEFTIST "LA REPUBBLICA" THAT "IF THEY (OTHER COUNTRIES) SUPPORT THE TERRORIST ORGANIZATIONS WHICH OPERATE AGAINST US, WE WILL CONFIDENTIAL

- 6. (C) IN CONVERSATION WITH EMBOFF MARCH 7, LIOTTA SAID THAT WHILE IT WAS STILL NOT ENTIRELY CLEAR JUST WHAT QADHAFI HAD SAID, IT DID SEEM THAT HE HAD ONCE AGAIN NOT ONLY CALLED FOR REPARATIONS FROM ITALY FOR COLONIAL AND WAR-TIME ACTIVITIES, BUT ALSO ASSERTED THAT IF WESTERN COUNTRIES, INCLUDING ITALY, HELP ANTI-LIBYAN TERRORISTS, LIBYA WOULD, OF COURSE, "CONSIDER HELPING OTHER TERRORISTS."
- 7. (C) LIOTTA STATED (AS HE HAS BEFORE) THAT IT IS ALWAYS A MISTAKE TO PAY TOO MUCH ATTENTION TO WHAT QADHAFI SAYS. WHAT HE DOES IS BAD ENOUGH, SAID LIOTTA, AND CAUSES ENOUGH PROBLEMS. WE SHOULD TRY TO CONTAIN HIS BEHAVIOUR, AND NOT WORRY EXCESSIVELY ABOUT HIS "ORAL INCONTINENCE."
- 8. (C) IT IS NOT THE FIRST TIME QADHAFI HAS MADE SUCH REMARKS, LIOTTA WENT ON. HE IS JUST TRYING TO PROVOKE INTERNATIONAL REACTION AS A MEANS OF MAKING HIMSELF SEEM MORE IMPORTANT. THE LESS ATTENTION WE PAY, THE LESS WE SEEM TO TAKE HIM SERIOUSLY, LIOTTA ASSERTED, THE LESS HE GAINS.
- 9. (C) EVEN SO, LIOTTA CONCLUDED, ITALY DOES POINT OUT AND EVEN STRESSES TO QADHAFI THAT SUCH REMARKS HARM BILATERAL RELATIONS, STIRRING UP PUBLIC AND PARLIAMENTARY

THAT IRELAND HAS WORKED SO HARD TO CULTIVATE THE LIBYAN EXPORT MARKET (WITH VISITS BY VARIOUS GOVERNMENT MINISTERS AND THE PRESENT OPPOSITION LEADER OVER THE YEARS), DESPITE QADHAFI'S VERBAL AND POSSIBLY MATERIAL SUPPORT FOR THE IRA, CAN ONLY BE EXPLAINED BY THE DESPERATE NEED FOR EXPORTS AND JOBS.

SUMMARY: GOF TERRORISM JUDGE JEAN-LOUIS BRUGUIERE IS MAKING PROGRESS INTO THE INVESTIGATION OF THE ESKUND, THE SHIP STOCKED WITH LIBYAN-SUPPLIED ARMS DESTINED FOR THE IRA THAT WAS SEIZED BY FRANCE LAST YEAR. HE THINKS HE WILL SOON ISSUE AN INTERNATIONAL ARREST WARRANT AGAINST A COLONEL IN THE LIBYAN INTELLIGENCE SERVICE IN CONNECTION WITH THE CASE. HE IS ALSO INVESTIGATING THE ARC--THE NOW APPARENTLY DEFUNCT GUADELOUPE-BASED CARIBBEAN TERRORIST

GROUP--AND ITS POSSIBLE CUBAN CONNECTIONS. BRUGUIERE REQUESTED USG INFORMATION ON BOTH OF THESE CASES. END SUMMARY.

- 4. POLOFF RECENTLY SPOKEN WITH FRENCH JUGE D'INSTRUCTION FOR TERRORIST CASES JEAN-LOUIS BRUGUIERE (PROTECT). BRUGUIERE HAD JUST RETURNED FROM A TRIP TO ATHENS WITH GOF COUNTER-TERRORISM PROSECUTOR ALAIN MARSAUD TO INVESTIGATE THE JULY ATTACK BY THE ABU NIDAL GROUP ON THE "CITY OF POROS." HE PREFERRED TO DEFER DETAILED DISCUSSION OF THE CITY OF POROS INVESTIGATION UNTIL HE HAD ORDERED HIS NOTES, BUT WAS EAGER TO TALK ABOUT TWO OTHER ONGOING INVESTIGATIONS: THE EKSUND AFFAIR AND THE PROSECUTION OF FRENCH CARIBBEAN TERRORISTS.

LIBYAN-SUPPLIED ARMS, MUNITIONS, AND SUPPLIES DESTINED FOR THE IRA--THAT FRENCH AUTHORITIES SIEZED LAST NOVEMBER. BRUGUIERE EXPLAINED THAT HE HAD DEVOTED MOST OF HIS EFFORTS TO ESTABLISHING EXACTLY WHO IN THE LIBYAN GOVERNMENT WAS BEHIND THE SHIPMENT. HE HAS IDENTIFIED A CERTAIN NASIR MEHDI ASHUR (ALIAS NASER) AS THE CHIEF CULPRIT. BRUGUIERE CLAIMED THAT HE HAS "INCONTROVERTIBLE" PROOF THAT ASHUR WAS "INTIMATELY INVOLVED" IN THE OPERATION, TO THE POINT OF DIRECTING THE LOADING OF THE ARMS ONTO THE EKSUND. ACCORDING TO BRUGUIERE, ASHUR WAS ONE OF THE STAFFERS OF THE LIBYAN PEOPLE'S BUREAU IN LONDON WHO WERE EXPELLED AFTER THE SHOOT-OUT IN THE EARLY 1980S. HE IS SUPPOSEDLY A MEMBER OF THE LIBYAN INTELLIGENCE SERVICE WITH THE RANK OF COLONEL. BRUGUIERE BELIEVES HE IS CURRENTLY IN TRIPOLI. THE JUDGE REMARKED THAT CURRENTLY HE COULD NOT TRACE THE RESPONSIBILITY FOR THE SHIPMENT BEYOND ASHUR, BUT HE DID NOT EXCLUDE GOING EVEN HIGHER INTO THE LIBYAN HIERARCHY AT A LATER DATE.

6. BRUGUIERE SAID HE PLANS TO ISSUE AN INTERNATIONAL ARREST WARRANT FOR ASHUR BEFORE THE END OF THE YEAR. HE ADDED THAT IN THE PRE-TRIAL STAGE THE JUGE D'INSTRUCTION HAS BASICALLY A FREE HAND TO ISSUE SUCH WARRANTS, PROVIDED HE CAN CONVINCE THE STATE PROSECUTOR (IN THIS CASE MARSAUD'S OFFICE) THAT HE HAS SUFFICIENT LEGAL GROUNDS. BRUGUIERE ASSURRED POLOFF

THAT THE WARRANT WOULD BE TRANSMITTED TO INTERPOL. HE THOUGHT THAT THE ACTUAL TRIAL OF THE IRA PRISONERS IN FRENCH JAILS WOULD BEGIN AT THE VERY EARLIEST IN THE LATE SPRING OF NEXT YEAR.

WE SUSPECT THAT MOST OF THE DEADLINES HE MENTIONED WILL SLIP, AND THAT HE WILL PROBABLY NOT ISSUE THE INTERNATIONAL ARREST WARRANT FOR ASHUR THIS YEAR. NEVERTHELESS, BRUGUIERE IS A TENACIOUS INVESTIGATOR WITH NEARLY A DECADE OF EXPERIENCE ON TERRORIST CASES WHO IS DETERMINED TO TRACK DOWN EVERY LEAD AND PROSECUTE WHENEVER POSSIBLE.
- 9. ACTION REQUESTED: BRUGUIERE ASKED POLOFF WHETHER WE COULD PROVIDE ANY BIOGRAPHICAL BACKGROUND ON ASHUR AND ANY INSIGHTS INTO HIS ROLE WITHIN THE LIBYAN SERVICES/GOVERNMENT. HE ALSO ASKED IF WE HAD ANY INFORMATION REGARDING CUBAN SUPPORT FOR CARIBBEAN RADICAL GROUPS, ESPECIALLY THE ARC. 

KING WENT ON TO DESCRIBE THE SEIZURE IN JANUARY 1986 OF "THE LARGEST ARMS FIND EVER IN IRELAND INCLUDED NEARLY 100 LIBYAN TYPE KALASHNIKOV RIFLES AND TENS OF THOUSANDS OF ROUNDS OF AMMUNITION IN BOXES MARKED "LIBYAN ARMED FORCES".
- 2. THE SUNDAY TIMES ALABORATED ON THE KING STATEMENT. IN A HEADLINED ARTICLE, CORRESPONDENT CHRIS RYDER CLAIMED THE IRA HAD BEEN GIVEN "AT LEAST 2 MILLION POUNDS STERLING IN CASH AND BULLION BY LIBYAN AGENTS IN EUROPE." HE CLAIMED "SECURITY FORCES THROUGHOUT EUROPE ARE LOOKING FOR A 35 YEAR OLD BELFAST MAN WHO IS THE CENTRAL CONTACT BETWEEN THE IRA AND THE LIBYANS" UNCLASSIFIED

AND ONE OF THE ORGANIZATION'S "MOST PERSISTENT AND PROFESSIONAL PROCURERS OF MONEY, ARMS AND EXPLOSIVES" WHO "LIAISES DIRECTLY WITH THE IRA'S SO-CALLED DIRECTOR OF FINANCE, AN ELDERLY BELFAST MAN NOW RESIDENT IN DUBLIN WHO IS KNOWN TO HAVE VISITED LIBYA HIMSELF."

3. RYDER STATED "SMALL NUMBERS OF IRA TERRORISTS ARE BELIEVED TO HAVE BEEN TRAINED IN LIBYA" PARTICULARLY IN "HOW TO MAKE REMOTE-CONTROLLED AND RADIO CONTROLLED DEVICES USING MICRO-ELECTRONICS TO CAUSE EXPLOSIONS" AND MORTARING, ESPECIALLY

LONG RANGE MORTARING. HE ALSO CHARGED LIBYAN MONEY HAD BEEN USED BY SINN FEIN TO FIGHT ELECTIONS IN 1982 FOR THE NORTHERN IRELAND ASSEMBLY, IN 1983 TO FINANCE THE SUCCESSFUL CAMPAIGN OF SINN FEIN LEADER GERRY ADAMS FOR A WESTMINSTER SEAT, AND TO OPERATE 30 SINN FEIN ADVICE CENTERS ACROSS THE PROVINCE.

4. RYDER DID NOT GIVE THE NAME OF THE WANTED PIRA MAN BUT DESCRIBED HIM AS HAVING JOINED PIRA IN 1970 BEEN INTERNED IN 1972, JAILED IN 1973 FOR NINE YEARS ON AN EXPLOSIVES CHARGE, ESCAPED BRIEFLY FROM THE MAZE, AND EVENTUALLY RELEASED IN 1978. SINCE THAT TIME, ACCORDING TO RYDER, HE HAS BEEN PICKED UP BY THE FRENCH GOVERNMENT SUSPICIOUS OF HIS ARAB CONNECTIONS AND INTERCEPTED AT THE CANADIAN BORDER IN 1982 WHILE TRYING TO ENTER THE U.S. ILLEGALLY "CARRYING 30,000 POUNDS STERLING AND DOCUMENTS RELATED TO THE SUPPLY OF REMOTE CONTROLLED MODEL AIRCRAFT WHICH COULD CARRY A PAYLOAD UP TO 25 LBS."

THE EXPLOSIVES HAVE PLAYED A CENTRAL PART IN THE CURRENT UPSURGE OF IRA VIOLENCE. THEY WERE USED IN THE ASSASSINATION OF A NORTHERN IRELAND JUDGE, SIR MAURICE GIBSON, IN LAST MONTH'S LETTER BOMB OFFENSIVE IN BRITAIN AND IN RECENT MORTAR ATTACKS.

REPUBLICAN SOURCES IN NORTHERN IRELAND SAID THAT THE IRA HAD RECEIVED THE EXPLOSIVES, MONEY AND OTHER MATERIAL FROM COL. GADDAFI. SECURITY SOURCES SAID THAT THEY HAD BELIEVED FOR SOME TIME THAT LIBYA WAS THE SOURCE.

EARLIER THIS YEAR THE LIBYAN LEADER ANNOUNCED THAT HE HAD INCREASED SUPPLIES TO THE IRA IN RETALIATION FOR BRITISH INVOLVEMENT IN AMERICAN BOMBING RAIDS ON LIBYA LAST YEAR.

THE EXPLOSIVES ARE MADE IN EASTERN EUROPE AND REACHED THE IRA THROUGH AN INDIRECT EUROPEAN ROUTE. THE ORGANISATION NOW HAS MORE OF THE MATERIAL, CALLED "SEMTEX", THAN IT HAS HAD BEFORE. EXPLOSIVES EXPERTS ESTIMATE THAT IT IS UP TO 10 TIMES AS EFFICIENT AS THE IRA'S HOME-MADE EXPLOSIVES.

THE SECURITY FORCES ALSO BELIEVE THAT LIBYA HAS SUPPLIED THE IRA WITH SUBSTANTIAL SUMS OF MONEY, AS WELL AS WEAPONS AND TRAINING. THE RE-ESTABLISHMENT OF THE LIBYAN CONNECTION, WHICH WAS DORMANT FOR 11 YEARS, IS A MAJOR BOOST FOR THE TERRORIST ORGANISATION, AND A SOURCE OF SERIOUS CONCERN FOR THE SECURITY FORCES.

LAST MONTH TWO SENIOR SINN FEIN OFFICIALS VISITED LIBYA FOR A CEREMONY TO MARK THE RAID'S ANNIVERSARY. ON THAT OCCASION COLONEL GADDAFI'S TEENAGE SON, SAID, SAID LIBYA WOULD OPEN CENTRES FOR THE IRA AND THE PLO. IN THE EARLY 1970'S THE IRA RECEIVED SUBSTANTIAL AID OF ABOUT 2,000,000 POUNDS STERLING AND ARMS INCLUDING ROCKET-LAUNCHERS, FROM COL GADDAFI. IN 1973 A SHIP, THE

CLAUDIA, WAS INTERCEPTED ON ITS WAY TO IRELAND AND FOUND TO CONTAIN FIVE TONS OF WEAPONS.

IT IS LIGHT AND PARTICULARLY DIFFICULT TO DETECT. SECURITY SYSTEMS AT MANY AIRPORTS ARE NOT GEARED TO ITS DISCOVERY. IT LASTS MUCH LONGER THAN EXPLOSIVES SUCH AS GELIGNITE, AND DOES NOT BECOME UNSTABLE. END TEXT.

IN SEPARATE DISCUSSIONS WITH POLOFF ON NOVEMBER 5, THE CHIEF FRENCH TERRORISM PROSECUTOR AND THE DEPUTY GOF COUNTERTERRORISM COORDINATOR (PROTECT) ELABORATED ON THE FRENCH SEIZURE LAST WEEKEND OF A LIBYAN ARMS SHIPMENT DESTINED FOR THE IRISH REPUBLICAN ARMY. THE FRENCH OFFICIALS CONFIRMED MUCH OF WHAT HAS ALREADY BEEN REPORTED IN THE PRESS AND SUPPLIED ADDITIONAL DETAILS ON THE ARMS AND EXPLOSIVES SEIZED AND ON THE FIVE IRA MEMBERS ARRESTED ON THE SHIP. BASED ON THE

INTERROGATION OF THE TWO CREW MEMBERS WILLING TO TALK, THERE IS NO DOUBT THAT THE LIBYAN GOVERNMENT SUPPLIED THE ENTIRE ARSENAL AND THAT LIBYAN SOLDIERS LOADED THE SHIP IN A MILITARY PORT IN TRIPOLI. (END SUMMARY)

FRENCH CUSTOMS VICTORY

- 3. A FRENCH CUSTOMS PLANE SPOTTED THE "EKSUND" IN FRENCH TERRITORIAL WATERS OFF THE COAST OF ROSKOFF ON OCTOBER 30 AT AROUND 2100. THE SHIP, REGISTERED TO "PANAMA CORAL SPRING NAVIGATION, S.A.", WAS FLYING A PANAMANIAN FLAG. CREW MEMBERS BECAME AWARE OF THE FRENCH SURVEILLANCE AND WERE PREPARING TO LEAVE THE SHIP WHEN THE FRENCH DECIDED TO BOARD.
- 4. THE SHIP'S CARGO WAS APPROXIMATELY 150 TONS OF WEAPONS, INCLUDING SAM-7 MISSILES, MORTARS, ROCKET-PROPELLED GRENADES, AK-47 ASSAULT RIFLES, HEAVY MACHINE GUNS, AND LARGE QUANTITIES OF EXPLOSIVES AND AMMUNITION. THE INVENTORY WILL BE COMPLETED WHEN ALL 2000 CONTAINERS ABOARD THE SHIP HAVE BEEN EMPTIED. (A PARTIAL INVENTORY IS LISTED IN PARAGRAPH 15.)

THEY WERE SUBSEQUENTLY TRANSPORTED TO PARIS ON NOVEMBER 4 AND PUT UNDER THE CONTROL OF THE COUNTERTERRORISM SECTION OF THE STATE PROSECUTOR'S OFFICE, WHICH IS NOW PURSUING THE INTERROGATION.

9. HOPKINS AND CAIRNS SEPARATELY PROVIDED SLIGHTLY DIFFERENT VERSIONS OF EVENTS FROM WHICH THE FOLLOWING FACTS CAN BE GLEANED. (COMMENT: IN ORDER TO DEMONSTRATE THE AUTHENTICITY OF THE INFORMATION, THE PROSECUTOR ALLOWED POLOFF TO READ THE TRANSCRIPTS OF THE INTERROGATIONS.)

10. PRIOR TO THIS INCIDENT, BOTH HOPKINS AND CAIRNS HAD PARTICIPATED IN HANDLING FOUR PREVIOUS LIBYAN ARMS SHIPMENTS TO EUROPE (PRESUMABLY TO THE IRA) SINCE SUMMER 1985, TOTALLING 100-130 TONS OF WAR MATERIEL. HOPKINS CLAIMS THAT HE WAS CONTACTED AGAIN IN FEBRUARY 1987 BY CAIRNS, WHO ASKED HIM TO PURCHASE A SMALL CARGO SHIP TO CONDUCT SOME BUSINESS WITH NIGER. (COMMENT: THE FRENCH ARE SKEPTICAL OF HOPKINS' CONTENTION THAT HE WAS DUPED INTO PARTICIPATING.) HOPKINS BOUGHT THE "EKSUND" IN SWEDEN FOR THE SUM OF 120,000 POUNDS. AFTER A SERIES OF MODIFICATIONS AND REPARATIONS IN FALMOUTH, ENGLAND, THE SHIP WAS TAKEN TO MALTA BY A MARITIME COMPANY. DURING THE MONTH OF AUGUST IN MALTA, HOPKINS CONCLUDED THE FORMALITIES OF PANAMANIAN REGISTRATION.

11. AFTER A SHORT STAY IN IRELAND, HOPKINS RETURNED TO MALTA IN EARLY OCTOBER WHERE HE JOINED UP WITH SECRET

CAIRNS AND THE OTHER THREE CREW MEMBERS. BOTH HOPKINS AND CAIRNS STATED THAT THE THREE OTHERS WERE PROFESSIONAL MEMBERS OF THE PROVISIONAL IRA. THEY ASKED HOPKINS TO REPLACE THE CAPTAIN ORIGINALLY HIRED TO PILOT THE VESSEL AS FAR AS GIBRALTAR, AND HE AGREED TO PILOT THE SHIP HIMSELF. HOPKINS CLAIMS THAT SHORTLY AFTER THEIR DEPARTURE FROM MALTA ON OCTOBER 12, BOYLE DECLARED THAT HE AND THE OTHERS WERE PROVISIONAL IRA MEMBERS WHOSE MISSION WAS TO TAKE DELIVERY OF A STOCK OF ARMS IN TRIPOLI, LIBYA, THAT WAS DESTINED FOR IRELAND. (COMMENT: THE FRENCH FIND IT HARD TO BELIEVE THAT HOPKINS WAS NOT ALREADY AWARE OF THIS.)

12. THE "EKSUND" ARRIVED OFF THE COAST OF TRIPOLI ON OCTOBER 13, WHERE IT WAS MET AT 1900 BY A "ZODIAC" RUBBER DINGHY IN WHICH WERE TWO LIBYAN SOLDIERS AND ONE LIBYAN CIVILIAN OFFICIAL. THESE LIBYANS CAME ABOARD THE "EKSUND", AND THEN ONE OF THEM PILOTED THE SHIP TOWARD THE MILITARY PORT OF TRIPOLI. A LIBYAN TUGBOAT GUIDED THE SHIP INTO THE MILITARY PORT. THE

"EKSUND" PASSED BY NUMEROUS MILITARY SHIPS, INCLUDING SUBMARINES AND A CRUISER, BEFORE COMING TO ANCHOR AT THE DOCK.

13. DURING TWO SUCCESSIVE NIGHTS, THE SHIPMENT OF OVER 2000 CRATES OF WEAPONS AND EXPLOSIVES WAS TRANSFERRED FROM THE DOCK TO THE SHIP BY SOME 40-50 LIBYAN SOLDIERS. THE TRANSFER TOOK LONGER THAN EXPECTED BECAUSE A HYDRAULIC CRANE THAT WAS TO HAVE BEEN USED TO LOAD THE SHIP QUICKLY BROKE DOWN, AND THE LIBYANS WERE FORCED TO USED WOODEN PLANKS TO SLIDE THE CRATES INTO THE SHIP'S HOLD. HOPKINS AND CAIRNS CLAIMED THAT THE LIBYANS OFFERED TO PROVIDE AIR PROTECTION FOR THE SHIP IN THE MEDITERRANEAN. THEY ALSO STATED THAT THE SENIOR LIBYAN OFFICIALS SEEMED TO SECRET

HAS BEEN SEVERELY CURTAILED SINCE WPC YVONNE FLETCHER WAS SHOT DURING THE SEIGE AT THE LIBYAN PEOPLE'S BUREAU IN LONDON IN 1984. IT WAS FOLLOWED BY THE EXPULSION OF THE LIBYAN DIPLOMATS AND THE INTRODUCTION OF STRICT VISA REQUIREMENTS AND SECURITY CHECKS FOR LIBYANS.

THE MEETINGS BETWEEN THE IRA AND THE LIBYANS WERE DETECTED AND MONITORED BY THE SECURITY AUTHORITIES IN FRANCE AND THE NETHERLANDS. THEY HACE STEPPED UP THEIR SURVEILLANCE OF LIBYAN AND IRISH NATIONALS AS PART OF THE DRIVE AGAINST INTERNATIONAL TERRORISM.

THE CONTACTS WERE REPORTED UNDER ARRANGEMENTS FOR INTELLIGENCE SWAPPING AND INVESTIGATED FORTHER BY SECURITY FORCES IN BRITAIN AND IRELAND. THE JOINT INTELLIGENCE COMMITTEE AT THE CABINET OFFICE REPORTED THE INFORMATION TO SCOTLAND YARD, THE PRISON AUTHORITIES AND THE HOME OFFICE, WHERE PRECAUTIONS WERE TAKEN AT EACH OF THE SECURITY PRISONS.



NEVERTHELESS, HE SPECULATED THAT WHILE QADAHFI BEGAN THE ARMS SHIPMENTS TO THE IRA IN 1985, HE SPEEDED THEM UP AND INCREASED THE AMOUNTS DURING 1986 PRIMARILY TO STRIKE BACK AT THE U.K. FOR ITS ROLE IN THE U.S. RAID ON TRIPOLI. 


