This is in response to your request of October 22, 2014, requesting the Flavor and Extract Manufacturers Association (FEMA), GRAS determinations 1960 to present. Your request was forwarded to the Office of Food Additive Safety in the Center for Food Safety and Applied Nutrition.

X ____We have searched our files and find no responsive information. From the 1960s through the late 1980s, under a contract with FDA, FEMA prepared Scientific Literature Reviews (SLRs). The official repository for the SLRs is the National Technical Information Service (NTIS, http://www.ntis.gov, use the search terms "Flavor and Extract," "food," "FDA," GRAS," to yield a reasonable number of search results. You will need to create a log-in in order to view these documents. In the mid 1990s, FEMA provided safety and technical information to the Joint FAO/WHO Expert Committee on Food Additives (JECFA) for their evaluation. FDA scientists participate in the JECFA evaluations. The safety and technical information are publically available on the WHO website (http://apps.who.int/food-additives-contaminants-jecfa-database/search.aspx#, select the appropriate functional class, such as flavouring agent, etc. to bring up lists of substances, each with a hyperlink to the supporting data).

If you do request further consideration and if the agency then formally denies your request, you will have the right to appeal that decision. Any letter of denial will explain how to make this appeal.
