BEFORE ME, the undersigned authority, on this day personally appeared the undersigned affiant who, after being duly sworn by me, on oath stated: My name is Michael Yeric #7178

and I am a peace officer of the City of Dallas, Dallas County, Texas. I, the affiant, have good reason and do believe that on or about the 19th day of August, 20 15, one (name of suspect) Juan Miguel Andrade

did then and there in the City of Dallas, Dallas County, Texas commit the offense of Murder

a violation of Section 19.02 of the Texas Penal Code

a Felony of the 1st Degree

Affiant's belief is based upon the following facts and information which Affiant received from:

Affiant's personal investigation of this alleged offense.

_____, a fellow peace officer of the City of Dallas, Dallas County, Texas, who personally participated in the investigation of this alleged offense, providing this information to Affiant, and whose information Affiant believes to be credible.

On August 19, 2015, at approximately 2:10 AM Dallas Police responded to a call of shots fired with a man down at 1625 Regal Row, which is a Motel 6. Upon their arrival, officers observed a man, later tentitively identified as Jose Rubiel Aguilar-Hernandez, shot to death on the second story landing of the motel. Witnesses observed a latin male wearing a white polo style shirt and blue jeans walking away from the area of gunfire carrying a gun. From that description the hotel manager believed the suspect to be a customer that he had spoken with immediately prior to the offense. The hotel manager identified the man as Juan Miguel Andrade who had checked in a few days prior using his Texas ID. A family member notified police that Suspect Andrade had checked into another hotel. Dallas Police responded to this location and took Andrade into custody for an outstanding warrant out of Dallas County. Andrade was transported to the CAPERS office where he was interviewed. Suspect Andrade was read his Miranda Warning and agreed to speak with detectives. Andrade stated that he shot and killed Complainant Aguilar-Hernandez with a .45 caliber handgun. .45 caliber cartridges were found at the crime scene.

Suspect Andrade then directed detectives to the location where he discarded the gun. A .45 caliber handgun was recovered at that location.
