
YOU ARE HEREBY COMMANDED, that you take the body of:

## PROBABLE CAUSE AFFIDAVIT

In the Name and by the authority of the State of Texas: **BEFORE ME**, the undersigned authority on this day personally appeared the undersigned affiant, who after being by me duly sworn on oath, deposes and says that he or she has good reason to believe and does believe, that heretofore, to wit: on or about **December 05, 2015**, and anterior to making and filing this complaint, in the County of Collin and state of Texas **Darrell Glenn Whitten, white male, date of birth 01-25-1965, 5'7" tall, 165 pounds, brown hair and brown eyes, Texas driver license number 10238040** did then and there commit **IMPROPER RELATIONSHIP BETWEEN EDUCATOR / STUDENT PC 21.12 / F2, CFS 15085790**, a criminal offense against the laws of the State of Texas.

Affiant **Danny Stasik**, is employed by the Collin County Sheriff's Office, Collin County Texas, assigned as a **Investigator**. Affiant's belief is based on the following facts:

On August 18, 2015, ISD Police Chief, Kelly Davison received a complaint on Melissa ISD School Teacher, Darrell Whitten (DOB 01/25/1965/50 years old). The involved child / student was identified as [REDACTED]

On August 19, 2015, Lisa Martinez did a Forensic Interview at the Children's Advocacy Center in Plano. During the Forensic Interview, [REDACTED] made an outcry towards Darrell "Glenn" Whitten stating that he kissed her on the side of the neck.

On August 20, 2015 Investigator Stasik and Investigator Fontana conducted a follow up interview with the victim. [REDACTED] said Darrell kissed her for the first time on December 5, 2014. The [REDACTED] said she made out with Darrell. [REDACTED] told Darrell she liked to be kissed on the neck. [REDACTED] said Darrell asked [REDACTED] if he could kiss her on the neck and she said yes. [REDACTED] said Darrell kissed her on the neck on two occasions and each kiss lasted approximately 5 minutes. The second incident occurred a few months afterwards during a [REDACTED] competition at the Melissa School. During this incident the [REDACTED] stated Darrell Whitten was sitting on a desk and she was standing in front of him. [REDACTED] said Darrell Whitten was "cradling" her with one hand underneath her leg and the other hand on her back.

[REDACTED] said during one of the incidents Darrell had an "ERECT PENIS" and he rubbed his "ERECT PENIS" on her right leg. [REDACTED] said Darrell's "ERECT PENIS" felt uncomfortable. [REDACTED] also said during the interview Darrell asked [REDACTED] to kiss her on the lips and she told Darrell no.

[REDACTED] also told Darrell Whitten about another teacher's inappropriate behavior towards her and stated to him if she were to ever come up missing to call the police and to talk to her friend [REDACTED]. [REDACTED] also told Darrell that she was feeling suicidal and depressed she told him in person and via text message. Darrell Whitten did not report the other teacher's inappropriate actions or [REDACTED] suicidal thoughts to administration, Child Protective Services, or Law Enforcement.

Based on the aforementioned information Investigator Stasik does have probable cause to believe that Darrell Glenn Whitten commit the offense o IMPROPER RELATIONSHIP BETWEEN EDUCATOR PC 21.12 / F2 THEN AND THERE INTENTIONALLY OR KNOWINGLY ENGAGE IN SEXUAL CONTACT WITH [REDACTED] A PERSON ENROLLED IN A PUBLIC/PRIVATE PRIMARY/SECONDARY SCHOOL IN WHICH DEFENDANT WAS AN EMPLOYEE, and THEN AND THERE INTENTIONALLY, WITH THE INTENT TO AROUSE OR GRATIFY THE SEXUAL DESIRE OF SAID DEFENDANT, ENGAGE IN SEXUAL CONTACT BY TOUCHING [REDACTED] WHEN SHE WAS CRADLED IN-BETWEEN HIS LEGS WHILE BEING KISSED AND HIS ERECT PENIS WAS RUBBING HER RIGHT LEG, A CHILD YOUNGER THAN 17 YEARS,
