SUBJECT: After Action Report – S. University Drive Investigation

In October 2011 we received complaints of drug activity at an apartment building near the TCU campus. Officers Cespedes and Williams investigated the complaint and identified numerous individuals who were involved in the sales of marijuana, prescription drugs, and narcotics on and near the campus.

Over the following 4 months Cespedes and Williams met with and made undercover purchases from current and former students, and others who were simply supplying students with illegal substances. 93 arrest warrants were issued for 31 individuals.

On February 15^{th} a round-up was conducted for wanted individuals. Below is a list of individuals arrested and property seized as of this date.

Arrest warrants for 10 additional/unnamed individuals will be processed in the near future.
