The Grand Jury charges:

FIRST COUNT:

Ricardo L. Mitchell, within the District of Columbia, while armed with a firearm, purposely and with deliberate and premeditated malice, killed Wyatt Robinson by shooting him with a firearm on or about August 21, 2011, thereby causing injuries from which Wyatt Robinson died on or about August 21, 2011. (First Degree Murder While Armed (Premeditated), in violation of 22 D.C. Code, Sections 2101, 4502 (2001 ed.))

The Grand Jury Further Charges that at the time such murder was committed, the following aggravating circumstance existed: the murder was especially heinous, atrocious, or cruel, in violation of 22 D.C. Code, Section 2104.01(b)(4), and 24 D.C. Code, Section 403.01(b-2)(2)(D) (2001 ed.))

SECOND COUNT:

On or about August 21, 2011, within the District of Columbia, Ricardo L. Mitchell did possess a firearm while committing the crime of murder as set forth in the first count of this indictment. (Possession Of a Firearm During Crime Of Violence Or Dangerous Offense, in violation of 22 D.C. Code, Section 4504(b) (2001 ed.))

THIRD COUNT:

On or about August 21, 2011, within the District of Columbia, Ricardo L. Mitchell, previously having been convicted in any court of a crime punishable by imprisonment for a term exceeding one year, owned, kept, and had within his possession and control, a firearm. (Unlawful Possession of a Firearm, in violation of 22 D.C. Code Section 4503 (a)(1) (2001 ed.)) FOURTH COUNT:

On or about August 21, 2011, within the District of Columbia, Ricardo L. Mitchell, did carry, openly and concealed on or about his person, in a place other than his dwelling place, place of business or on other land possessed by him, a pistol, without a license issued pursuant to law. (Carrying a Pistol Without a License (Outside Home or Place of Business), in violation of 22 D.C. Code, Section 4504(a) (2001 ed.))
