On Sunday, June 3, 2012, at approximately 0104 hours, uniformed officers working in the Seventh District were approached by a citizen who stated that a man was lying on the sidewalk. The officers were directed to the 1100 block of Chicago Street, S.E., Washington, D.C. Once on the scene, the officers located the decedent, who was later identified as Henry Miller, lying on the sidewalk suffering from gunshot wounds to the body. Henry Miller was transported via ambulance to Med Star where all life- saving efforts failed and he was pronounced dead by Doctor Skolnick at 0219 hours.

Uniformed officers were in the 1100 block of W Street, S.E., approximately 1/10 of a mile from the 1100 block of Chicago St. S.E., when they observed a white pickup truck drive past them. The officers drove to the 1100 block of Chicago Street, S.E., and interviewed a witness who provided a lookout for a white pickup truck with a driver wearing a red hat and a red shirt.

Officers monitoring the Seventh District radio transmissions heard the lookout for the white pickup truck. Uniformed officers observed a white pickup truck in the 1200 block of Good Hope Road, S.E., about 2/10 of a mile from the 1100 block of W Street, S.E. The officers activated their lights and sirens and attempted to conduct a traffic stop on the white pickup truck. The white pickup truck initially stopped, but then fled from the officers. A vehicular pursuit was initiated with uniformed officers chasing behind the white pickup truck. The pursuit, which lasted for several miles, ended in the 1400 block of Brentwood Parkway, N.E., Washington, D.C., where the driver was apprehended. The uniformed officers observed a revolver handgun lying in plain view on the driver's side floor board. The driver was identified as David Shepherd, hereafter referred to as D-1. He was wearing a red shirt. Also located in the vehicle was a red hat.

Members of the Metropolitan Police Department's Homicide Branch initiated an investigation into the shooting of Henry Miller. During the course of the investigation, law enforcement interviewed witnesses.

The events described above occurred in the District of Columbia.

As the investigation progressed, members of MPD's Homicide Branch conducted a formal interview of W-1. During the interview, W-1 stated that IT was located in the 100 block of Chicago St., S.E. when IT observed a verbal argument between a subject known to IT as "Shep" and the eventual decedent, during which IT heard "Shep" tell the decedent, "I'll bust your head." After "Shep" and the decedent had been separated, W-1 observed "Shep" starting to walk back towards the decedent. W-1 said that IT heard D-1 say, "I'll bust your motherfucking head." W-1 said that IT then observed "Shep" pull an object from his waistband and point the object at the decedent. W-1 heard a gunshot and saw sparks coming from the object. W-1 said that the decedent fell to the ground and IT observed blood flowing from the face of the decedent. W-1 said that IT observed "Shep" walk to his white-colored work truck and speed away from the scene. W-1 said that when "Shep" drove away, he was wearing a red shirt, though IT believed the hat he was wearing was tan-colored.

W-1 was shown a single confirmation photo and positively identified D-1, William Shepherd, as the person that IT knows as "Shep" and that IT saw shoot the decedent.

D-1 was placed under arrest and transported to the Homicide Branch for processing.

The events described above occurred in the District of Columbia.
