C stated that he utilizes a software program named the "TOR NETWORK" in order to browse the internet anonymously. C stated that the Tor Network works differently from internet web browsers; users are also able to view websites only available on the Tor Network. When browsing the Tor Network on 6/07/2011, C clicked on a link titled TSCHAN. Upon viewing the link, C stated that it was a child pornography website. C gave the URL for the website as: [redacted]

C stated that the website was not viewable through normal web browsers (such as Safari, IE, or firefox) and that the site and it's contents could only be viewed on the Tor Network.

Assessment Findings:

Writer and TFC [redacted] interviewed complainant on 7/15/11. Complainant explained that he was using the TOR network to look for a deep web location called the "silk road." He visited the TOR directory at the following site: [redacted] At this site, he noticed a link to "adult" websites and clicked on it. He noticed a link on the next page for "TSCHAN" which he recognized to be a hacking affiliated group. When he clicked on this link, he saw pictures he described as child pornography. He said it looked like child pornography because he could tell the subjects were very young with some in diapers. All were still images, no videos, and he said most showed the children posing for the pictures.

Complainant brought in the computer he had used to access the site, but had "wiped" the hard drive after visiting that site.

Complainant had no other information about who the subjects of the pictures were or who would have posted the pictures. Also, because everyone (all internet traffic) connected to the TOR network is anonymous, there is not currently a way to trace the origin of the website. As such no other investigative leads exist.
