Dear Mr Foxe,

I refer to your request under the Freedom of Information Acts 1997 and 2003 which was received in this office on 15th May 2012 and to your request for access to the following records:

- A list of all payments made by way of pensions to TDs/Senators for the calendar years 2011 & 2012: to include the amount paid and name of the recipient in each year.
- Details of all lump sum payments made to TDs/Senators in 2011 & 2012: to include the amount and the name of the recipient.
- Details of all termination payments made to TDs/Senators in 2011 & 2012: to include the amount and the name of the recipient.
- Details of all step-down payments made to TDs/Senators in 2011 & 2012: to include the amount and the name of the recipient.

In accordance with the provisions of the Acts I have decided to release the records. Please note that step-down payments are not made to former Members and as such these records do not exist.

Accordingly, a copy of the records is now attached as per the Schedule of Records below. You have sought access to the records by email and I consider this an appropriate form of access in this case. Accordingly, a copy of the records is now attached in this email.

Please note that -

- the figures included in this record are **gross** figures and do not include any deductions for tax, PRSI etc. Net payments may be significantly lower.
- pension is payable only after termination payments are completed or ceased and are not payable simultaneously.

Appendix A - Fees for internal review

Under the Freedom of Information (Fees) Regulations 2003, a standard fee of €75 must accompany an application for internal review under section 14. A reduced fee of €25 applies if you are covered by a medical card, in which case you should supply details of the medical card registration number and issuing health board together with your consent to the verification of these details with the relevant health board. The fee can be paid by cheque, bank draft or order payable to the Office of the Houses of the Oireachtas. The following internal review applications are exempt from fees:

- (a) an application in relation to a decision concerning records containing only personal information related to the applicant.
- (b) an application in relation a decision under section 17 (right of amendment of records relating to personal information).
- (c) an application in relation to a decision under section 18 (right of person to information regarding acts of public bodies affecting the person).
- (d) an application in relation to a decision to charge a fee or deposit, or a fee or deposit of a particular amount.
