FIRST COUNT:

DCTN: U12018906

On or about February 15, 2012, Reynaud Cook, also known as Reynard Cook, also known as "Rizzy," within the District of Columbia, while armed with a firearm, purposely and with deliberate and premeditated malice, killed Yolanda Stone by shooting her with a firearm, thereby causing injuries from which Yolanda Stone died on or about May 20, 2012. (First Degree Murder While Armed (Premeditated), in violation of 22 D.C. Code, Sections 2101, 4502 (2001 ed.))

SECOND COUNT:

On or about February 15, 2012, within the District of Columbia, Reynaud Cook, also known as Reynard Cook, also known as "Rizzy," did possess a firearm while committing the crime of murder as set forth in count one of this indictment. (Possession of a Firearm During a Crime of Violence Or Dangerous Offense, in violation of 22 D.C. Code, Section 4504 (b) (2001 ed.))

THIRD COUNT:

On or about February 15, 2012, within the District of Columbia, Reynaud Cook, also known as Reynard Cook, also known as "Rizzy," was ordered by D.C. Superior Court Judge Brian Holeman in *D.C. Superior Court Case Number 2011 CPO 2396*, to stay away from and to not assault, threaten, harass or stalk Yolanda Stone or her children. On or about February 15, 2012, within the District of Columbia, Reynaud Cook, also known as Reynard Cook, also known as "Rizzy," knowingly, willfully, and intentionally violated that order by assaulting Yolanda Stone. (Contempt, in violation of 11 D.C. Code, Section 944(a) (2001 ed.))

(First Degree Cruelty To Children, in violation of 22 D.C. Code, Section 1101(a) and 22-3611 (2001. ed.))

FIFTH COUNT:

On or about February 15, 2012, within the District of Columbia, Reynaud Cook, also known as Reynard Cook, also known as "Rizzy," did intentionally, knowingly or recklessly expose a child, R.S., a child under the age of eighteen years, that is about four years of age, in a highway or street, with intent to abandon the child. (First Degree Cruelty To Children, in violation of 22 D.C. Code, Section 1101(a) and 22-3611 (2001. ed.))

NINTH COUNT:

On or about February 15, 2012, within the District of Columbia, Reynaud Cook, also known as Reynard Cook, also known as "Rizzy," did intentionally, knowingly or recklessly expose a child, T.D., a child under the age of eighteen years, that is about one years of age, in a highway or street, with intent to abandon the child. (Second Degree Cruelty To Children, in violation of 22 D.C. Code, Section 1101(b) (2001 ed.))

TENTH COUNT:

On or about February 15, 2012, Reynaud Cook, also known as Reynard Cook, also

known as "Rizzy," within the District of Columbia, previously having been convicted of a

felony or a violation of this section, did carry, openly and concealed on or about his person, in a

place other than his dwelling place, place of business or on other land possessed by him, a pistol,

without a license issued pursuant to law. (Carrying a Pistol Without a License (Outside Home or

Place of Business), in violation of 22 D.C. Code, Section 4504(a)(1)(2) (2001 ed.))
