On Monday, June 25th, 2012, at approximately 2047 hrs., members of the Metropolitan Police Department's 6th District were dispatched to the alley rear of 1522 Kenilworth Avenue NE, Washington, DC for the report of the aggravated assault. Units arrived on the scene and discovered a black male later identified as James Eric Cain, 53 years old, who from here on will be referred to as the decedent, unconscious and unresponsive. DCFD Medic Unit #8 responded to the scene and transported the decedent to Prince George's County Hospital Center, where life saving efforts failed to revive him. He was subsequently pronounced deceased at 2131 hrs. by Dr. Bahmanyar of hospital staff.

On Tuesday, June 26th, 2012, Dr. Patrice Eronica-Pollak of the Maryland State Medical Examiner's Office in Baltimore, MD conducted an autopsy of the decedent, and ruled that the cause of death was multiple sharp force injuries, and the manner of death was ruled homicide.

On June 28th, 2012, a witness was located and interviewed in reference to this investigation. The witness, hereafter referred to as Witness 1, or W-1, stated that IT observed the defendant who IT knew as Six or Ramadhan along with the defendant's wife, and another individual come to the area of 1522 Kenilworth Avenue, NE in a silver Ford Taurus that had the letter "U" in the license tag. According to W-1, the decedent greeted the defendant who was seated in the rear passenger area of the silver Ford Taurus. The defendant and the decedent began to argue about who was a

real Muslim and who was a fake Muslim. The defendant exited the car and confronted the decedent. The defendant and decedent became engaged in a physical altercation, pushing and shoving each other. W-1 observed the defendant produce a knife. Prior to that time, W-1 did not observe the decedent with any weapon. The decedent then went to a wooded area and retrieved a long metal object. The decedent and the defendant once again confronted one another and continued exchanging words. The decedent with the metal object lunged towards the defendant, but not striking the defendant. According to W-1, the defendant's wife began striking the metal object that the decedent was holding with a cane. W-1 told both the decedent and the defendant to stop and told the defendant to get back in the car. The defendant did not return to the car. The decedent moved W-1 and the defendant's wife aside. The defendant was then observed by W-1 with his right hand stabbing the decedent with a knife to the body and neck area. According to W-1, IT did not observe the decedent lunge or swing at the defendant just before he was repeatedly stabbed by the defendant. The defendant then entered the silver Ford Taurus along with others and fled the area. W-1 stated that IT does not have vision in one of IT's eyes.

On June 28, 2012, W-1 was shown a photo array which consisted of nine color PDID photos with the defendant Antoine Little, DOB: 5/26/1976, PDID: 456-668 depicted in position 4. The photo array was shown to W-1. W-1 looked at the array and immediately pointed to picture 4 identifying the defendant Antoine Little, DOB: 5/26/1976, PDID: 456-668. Moreover, W-1 stated, That's him, Ramadhan, Six or Mr. Little. He stabbed Black. Black is a nickname for the decedent.

On June 29th, 2012, W-1 was re-interviewed. W-1 stated that on June 28th, 2012, the defendant's wife contacted IT and asked IT to testify on the defendant's behalf. In the re-interview, W-1 stated that IT did not see the defendant produce the knife prior to the decedent walking to the wooded area and retrieving the metal object because the defendant's back was to W-1. However, W-1 stated that by the time the decedent returned to the defendant, the defendant already had the knife in his hand. Moreover, W-1 stated that after both IT and the defendant's wife were moved aside, both the defendant and the decedent began to square off, making lunging and stabbing gestures at one another. During the square off is when IT observed the defendant stab the decedent repeatedly.

On June 28th, 2012, W-2 was interviewed in reference to this investigation. W-2 is a close family member of the defendant. W-2 stated that IT traveled with the defendant and another to the area of 1522 Kenilworth Avenue, NE, Washington. DC to meet the decedent. W-2 stated that at some point an argument ensued between the defendant who was seated in a car and the decedent. During the argument, W-2 heard the defendant say words to the effect, you are not going to keep talking to me any type of way. Then, the defendant exited the car. W-2 observed the decedent backing up at which time the defendant asked, where are you going? The decedent was observed going a short distance to a fence area then returned to where the defendant was located. The decedent swung his fist at the defendant. The defendant then swung a fist at the decedent who ducked and went towards the fence again. The decedent grabbed a metal spear like object which W-2 tried to knock out of the decedent's hands with a cane. W-2 stated that the defendant grabbed the object that the decedent was holding. The decedent pulled the metal object that the defendant was still holding causing the two to come into closer contact with one another at which time the defendant began stabbing the decedent. W-2 stated that IT did not see the defendant with the knife until the defendant had begun stabbing the decedent.

During a canvass of the area the night of the murder and a re-canvass days later, members of MPD never located a metal object as described by W-1 and W-2.

Based on the aforementioned facts and circumstances your affiant submits that there is probable cause to believe the defendant Antoine Little, DOB: 5/26/1976, PDID: 456-668 committed the offense of Second Degree Murder while Armed.
