All warrant personnel were dressed in tactical gear and uniforms marked "POLICE."

On the 15th day of February, 2012, I, Officer AD Taylor #3604, along with members of the FWPD Narcotics unit and Zero Tolerance unit, executed an arrest warrant at 4053 Winfield Ave. for Tanner, Brock Wilson (ARR). I had 3 felony arrest process for Tanner, each for Delivery of Marijuana >1/4 oz <=5 lbs. I observed Tanner's black dodge truck ((Control -(SZD)) parked in the driveway of the target location.

Officer J. Hill #3420, Officer J. Parsons #3409 and Sgt R. Johnson #2478 knocked on the front door of the target residence. Officers observed somebody looking out a window from inside the residence. A white male, later identified as Pachall, Casey (WIT1), opened the front door of the target residence. When Casey opened the door, Officers could smell an odor of unburned marijuana coming from inside the residence. Officers heard noise coming from the inside of the residence. Officers entered the residence believing that Tanner was inside the house due to the fact that his truck was parked in the driveway and the fact that officers heard noise coming from inside the residence. Casey was detained in the living room of the target location by Officer Sandoval. Officer Hill and Parsons located Tanner in the back bathroom along with Harris, Devon (WIT2). Both Tanner and Devon were detained. Sgt Johnson and I detained Michaelson-Bartlett, Kira (WIT3) in Pachall's bedroom. During a protective sweep of the target residence, Sgt Johnson observed a digital scale, plastic bags consistent with narcotics distribution and a glass pipe, which is believed to be used to smoke marijuana, on top of Tanner's dresser. Based on the fact Officers smelled an odor of marijuana coming from inside the target residence and the fact that officers observed the digital scale, plastic bags and glass pipe, Officer Sandoval drafted a search warrant for 4053 Winfield Ave.

### Narrative

The search warrant was signed by Judge Gonzalez and the Fort Worth City jail at 0646 hrs on the 15th day of February,2012. Officers conducted a search of the target residence. I located a plastic container underneath Tanner's bed in the bedroom. Tanner's bedroom is located on the southeast corner of the target residence. The container contained a green leafy substance, which based on my training and experience as a police officer, I believe to be marijuana (ITEM #1). The marijuana(ITEM#1) had an approximate field weight of 0.49 oz. I located a sprint Sanyo cell phone(ITEM #2) on the nightstand to the left side of Tanner's bed. I located a black digital scale(ITEM #3) on top of Tanner's dresser. I located 2 glass smoking pipes(ITEM #4 &5) on top of Tanner's dresser. the brown smoking pipe was sitting in plain view on top of the dresser. The blue glass smoking pipe(ITEM #6) inside one of Tanner's dresser drawers. I located a black and silver Hookah (ITEM #7) sitting in plain view on a table next to the dresser in Tanner's room. I located Tanner's drivers license inside a wallet in a pair of pants on the floor next to Tanner's bed. I photographed all of the evidence that I located in Tanner's room.

Officer Sandoval searched Tanner's truck and located a multi-colored wooden smoking pipe (ITEM #8) inside the glove box of Tanner's truck. Officer Sandoval photographed ITEM #8 and collected it, then released it to my custody once inside the target residence.

Sgt Johnson photographed 2 utility bills that were hanging on the wall in the dinning room. One bill was addressed to Casey and one was addressed to Tanner.

Officer Sandoval interviewed Casey at the target location.

I left a copy of the search warrant and the search warrant property inventory on the dinning room table at the target location.

Tanner was transported to 3128 W. Bolt St. and was interviewed by Officer J. White and myself.

Tanner was arrested for his 3 warrants for Del Marijuana >1/4 oz <=5 lbs and also charged with possession of marijuana <2oz.

Tanner was transported to the city jail by Officer J. Hill and released to MLEC personnel in good health.

All the pictures and the digital interviews were stored on the server under the street address.

#### Narrative

I Officer Sandoval am supplementing the to the original narrative with the details of the oral interview with one of the roomates of ARR-Brock, Tanner Wilson, WIT- Pachall, Casey.

I Officer J Sandoval 3625 conducted an interview of Pachall, Casey while inside the residence due to the fact that he is a roommate of ARR-Brock, Tanner Wilson.

I read Casey his Miranda Warnings prior to this interview. After I concluded reading Casey his Miranda warnings he replied that he understood them. I then began speaking with Casey about the current narcotics investigation that lead Officers to the residence at 4053 Winfield Ave.

I asked Casey how long he and Brock had been living at their current residence. Casey stated that they moved in last year. Casey stated that he has been roommates the entire time. I asked Casey if during the past 7 months that he has been living at the residence if he has observed any narcotics inside the residence. Casey replied "yes". During parties at the residence he has observed outside people bring in narcotics and use them while inside the residence. I then asked Casey if he had observed any of the actual residents of the house have any narcotics or use any narcotics and Casey replied "no". I then asked Casey if he has ever used narcotics?.

Casey replied that he has used narcotics in the past. Casey stated that he has smoke Marijuana in the past. Casey replied that the he smoked as recent as a week to two weeks prior to this date (2-15-12.) Casey stated that he has smoked marijuana with Tanner at least once in the past.

Due to Casey being a student athlete at TCU I asked if they receive any drug test. Casey replied they do and that he failed their most recent one which was right after he had smoked Marijuana last. Casey stated that he smoked Marijuana maybe a day or two prior to the test.

Sgt. Johnson who was also in the room as I was interviewing Casey asked Casey if he has ever used any other narcotics other than Marijuana. Casey stated that he has used Cocaine and Ectasy in the past. Casey stated that he used cocaine possible a year from this date and ectasy about seven months prior to this date. Both were just a one time thing and hasn't done either since.

Casey was then released. Officers collected all evidence from scene and Brock was transported by Officer Hill in marked Police vehicle.

#### Narrative

On February 15, 2012, I, Officer J.A. White #3207, assigned to Fort Worth Police Department Tactical Narcotics Team 2, conducted a post-arrest interview with Tanner Brock. The interview was conducted at the Fort Worth Police Department South Division Criminal Investigations Unit located at 3128 West Bolt Street. Officer A.D. Taylor #3604, assigned to the Fort Worth Police Department Narcotics Unit, was present for the interview with Brock. Brock was not restrained in handcuffs and made no request prior to the interview.

At approximately 9:00 a.m. I read Brock his Miranda Warning. Brock waived his rights and agreed to speak with me without a lawyer present. I stated to Brock that during the investigation he was identified as a person selling marijuana. Brock replied yes sir. Brock stated to me that he was in a "fucked" situation and that's "real money." In response to a question about selling marijuana, Brock said he can assure me it was not for popularity or money.

Brock stated he got involved in the sale of marijuana because he is a smoker. A smoker is a common used street term for a person who smokes marijuana. Brock stated that he did not know if he even had enough marijuana for personal use at the time of his arrest.

Brock stated that he got involved in the sale of marijuana beginning in January. Brock stated he typically buys marijuana in quarter ounce to half ounce quantities. Brock stated that he pays \$240 per half ounce. According to Brock, it takes him approximately one week to one and half weeks to smoke a half ounce of marijuana. Brock stated he does not have regular customers who buy marijuana from him and that he does not sell marijuana to random people. Brock informed me that he sells marijuana to friends or a friend of a friend. Brock described his marijuana transactions as casual in that his customers come to his house. In some cases the people Brock sells marijuana to sit down and smoke with him while they watch the television show Tosh.O.

Brock again stated that he buys a half ounces approximately once per week. In that time frame Brock stated the approximately one or two people hit him up during the week. The phrase "hit him up" is a common phrase used by drug dealers to describe customers calling them inquiring about the purchase of drugs. Brock stated the people that usually contact him are friends and that it is small stuff he has bought for himself. Brock stated he was not trying to self-incriminate himself in regards to identifying the people he sells marijuana to.

Brock agreed to the statement that he had purchased approximately three (3) ounces in six (6) weeks. He stated that between his girlfriend and him, they had smoked more than half of the three (3) ounces. I told Brock that if he sold 1 ½ ounces in six (6) weeks for twenty dollars per gram that is a little over \$600 or \$700. I asked Brock if that was accurate. Brock replied yea, but he stated he has never had \$600 or \$700.

In conclusion, Brock stated that it was a "big TCU thing." Brock informed me that a few weeks ago his coach said there was something big happening at TCU, he did not know what it was, but they were getting serious about it, so it is not a surprise. As we walked out of the interview room Brock stated to me "talking about 700 bucks this is about 100 million right here." This comment was made as Brock held up his expulsion letter from TCU.
