## **Equal Opportunity Policy**

## From the Chief of Police

This report contains important information about safety and security on the Texas Christian University campus. In addition to describing the University's crime prevention and security programs, the report provides statistics about crime on the University campus. The statistics demonstrate that the University is an extremely safe campus, and we believe it is based in part on the combined efforts of many University departments and members of the University community. Safety is a shared responsibility, and we rely on each member of our community to contribute to security on our campus by reporting suspicious activities and using common sense when carrying out their daily activities.

The Texas Christian University Police Department is responsible for developing services, programs, and strategies for maintaining a safe campus. The department focuses primarily on four functions:

1. A strong partnership with the community. We support the idea that all relationships require constant nurturing. We are committed to the philosophy of community-oriented policing and problem solving.
2. The emergency management functions. We embrace a comprehensive approach to preventing, preparing for, responding to, and recovery from emergency situations.
3. Leveraging security technology. We have invested in several different systems to enhance on-campus safety through technology. These systems include automated card access to many facilities on campus, security cameras in select areas, license plate recognition cameras at entrance to some of the remote parking lots, and multiple areas that could serve as an emergency operations center here on campus to deal with any emergency that may arise.
4. Enforcement of University regulations and federal, state and local laws. We strive to maintain a safe environment that supports our educational mission by ensuring that community members comply with local, state and federal laws. # The Campus Security Act

(also known as the Clery Act)

The Campus Security Act requires colleges and universities to:

- Publish an annual report every year by October 1 that contains three years of campus crime statistics and certain campus security policy statements.
- Publish crime statistics for the campus, public areas immediately adjacent to or running through the campus, and certain non-campus facilities and remote classrooms. (The statistics must be gathered from campus police or security, local law enforcement, and other University officials who have “significant responsibility for student and campus activities.”)
- Publish “timely warning” notices where a crime has occurred on or near campus that, in the judgment of the TCUPD, constitutes an ongoing or continuing threat to members of the University community.
- Make available for public inspection a daily public crime log of “any crime that occurred on campus or within the patrol jurisdiction of the campus police and is reported to the campus police.”

## Who is responsible for the Annual Security Report?

The TCUPD is responsible for preparing and distributing the Annual Security and Fire Safety report. The TCUPD works with other administrative departments and law enforcement agencies—such as the office of the Dean of Campus Life and the Fort Worth Police Department—to compile the information incorporated into the report.

## The TCU Police Department

Who we are

Located at 3025 Lubbock Ave., the TCUPD provides professional police patrol and security functions 24 hours a day, 365 days a year. All TCU commissioned officers are licensed and certified by the Texas Commission on Law



Enforcement as meeting the minimum training requirements of the State of Texas for peace officers. TCU Police Officers have the same authority as a municipal officer. To remain certified, TCU Police Officers must complete 40 hours of in-service training bi-annually to comply with state mandated training and attend additional training in various areas to help maintain a professional police department. Currently, TCU Police have 28 sworn officers that work to make TCU a safer community.



In addition, the department utilizes 15 security and administrative personnel and a minimum of 25 student workers. Officers patrol the campus on foot, by bicycle, by T-3 scooters, and in vehicles. Several officers and a supervisor are on duty 24 hours a day. The Communications Center is staffed with trained and certified dispatchers who answer calls for service, dispatch officers and other emergency services to incidents, and monitor intrusion detection and fire alarms. The department also employs students who carry out a variety of roles, including operating the Froggie Five-O escort program. TCU has an emergency reporting telephone system that allows anyone to make immediate contact with TCUPD by simply pressing the button at one of the emergency phones indicated by a blue light and strategically placed through-out the campus. TCUPD can also be reached by dialing 7777 from any campus phone extension or 817-257-7777 from an outside line. TCUPD additionally monitors all emergency 911 calls from campus phone lines that are automatically directed to concurrent jurisdiction emergency services agencies.

Electronic locks, silent alarms, audible alarms, and standard locking and access procedures help control building security. Other crime prevention methods include programs such as Rape Aggression Defense System (RAD), Assault Prevention Theatre (APT), Froggie Five-0 Student Escort Service, and safety meetings conducted throughout the year.



Parking regulations are enforced by all patrol and security officers in a diligent manner to help ensure parking and traffic flow at TCU is as safe and efficient as possible. The agency has a Coordinator of Parking and Transportation Services and an Administrative Assistant for data entry and to assist those who wish to appeal a parking citation. The appeal board is comprised of TCU faculty, staff and students who report back to the agency violator's questions and concerns about the enforcement process.

**Accountability** We value the opportunity to serve the community and will ensure that our conduct always merits trust and support. We will accept full responsibility for our actions and will take appropriate actions to meet community and professional expectations.

**Service** We are committed to enhancing public safety and increasing the community's sense of security. We will work in partnership with the community to identify and solve problems that affect the quality of life on campus. We demonstrate our commitment to serve by placing the needs of others ahead of our own.

**Mentoring** We recognize that individual and team contributions are essential to a high-performing department. By sharing insight and guidance, and creating leaning opportunities, we acknowledge that each member of our department makes a valuable contribution to our purpose and wisdom.

## Our Police Authority and Jurisdiction

### **Law enforcement authority and interagency cooperation**

The TCUPD's sworn officers derive their law enforcement authority from the Texas Education Code, Sec. 51.212 and the Code of Criminal Procedure, Title 1, Chapter 2, Art. 2.12.

### **Interagency Cooperation**

The TCUPD has a close working relationship with the Texas Alcohol Beverage Commission, Department of Public Safety, Federal Bureau of Investigations, Alcohol Tobacco and Firearms, Drug Enforcement Administration, Department of Defense, Immigration and Customs Enforcement and other Federal agencies.

TCUPD has a very close working relationship with the Fort Worth Police Department. By agreement between TCUPD and the Fort Worth Police Department, the TCUPD will be the primary agency in dealing with law enforcement response and investigative needs related to all calls and offenses occurring on the TCU campus. TCUPD may call upon the Fort Worth Police Department for additional patrol or investigative assistance on any calls for service or criminal offenses occurring on campus. In the event that TCUPD, or a victim, requests that the Fort Worth Police Department become involved in an investigation of an offense on campus, the investigation will be conducted as a joint investigation by both agencies.

The Fort Worth Police Department is the lead agency in investigations of homicide, suicide, or sexual assault and may take the lead on other major felony crimes. TCUPD and the Fort Worth Police Department work closely together to solve crimes in and near the campus. There is no written MOU (memorandum of understanding); however, we have been working under this understanding for the last 17 years. TCUPD operates on the same radio communications system with the Fort Worth Police Department.

When students are handled by TCUPD officers on matters that constitute violations of local, state, or federal laws, the students are subject to arrest or citation as allowed by law. Additionally, in criminal cases involving students, the case will also be referred through the Office of Campus Life for possible University sanctions and/or discipline.



We encourage all to immediately report all crimes to the TCUPD by calling 817-257-7777 while on campus or, if off campus, to dial 911.

## Crime reporting procedures

All students, employees, and visitors of the University should promptly report criminal incidents, accidents, and other emergencies to the TCUPD by dialing 817-257-7777. Individuals may also report incidents in person at the TCUPD located at 3025 Lubbock, Fort Worth, Texas 76109.



Victims of off-campus crimes or incidents may report the offense to TCUPD which will help the person notify the appropriate agency.

The University has installed over one hundred emergency two-way call boxes, (blue light phones) throughout the campus. By pressing the red button on the stations, users can communicate directly with the TCUPD Communications center. The location of each station is displayed to the communications officer.

## Voluntary Confidential Reporting

Texas Christian University has several methods for individuals to report crimes and other serious incidents, including the ability to report on a confidential basis. With your permission, the TCUPD can file a report on the details of the incident without revealing your identity. The purpose of filing confidential reports in some cases is to comply with your wish to remain anonymous, while also taking steps to ensure the safety of yourself and others. By being informed about the incident, the TCUPD can keep an accurate count as to the numbers of incidents affecting the campus community and determine if a pattern of crime exists regarding a particular offense, area of campus, suspect or method of operation and alert the campus community to any such information. Reports filed confidentially are included in the annual crime statistics for the University.

- Confidential E-mail. Individuals can send an email to [police@tcu.edu](mailto:police@tcu.edu).
- Anonymous Report of Sexual Assault. If you have been or know of someone who has been a victim of sexual assault, the TCUPD's online form can be submitted confidentially by visiting <http://www.police.tcu.edu/annontips.htm>. This form allows victims or witnesses to anonymously report an incident of sexual assault and assists the University in evaluating whether a Campus Crime Alert should be issued and in collecting valuable information about sexual assaults. It is a valuable tool available to any member of the community.

Note: We do not have policies or procedures that encourage pastoral, professional counselors, and other confidential counselors to report crimes to the TCUPD.

## Monitoring and recording criminal activity at Off-campus organizations

We rely on our very close working relationships with local law enforcement agencies to receive information about incidents involving University students on and off campus.

In coordination with local law enforcement agencies, the TCUPD will actively investigate certain crimes off-campus.

The Fort Worth Police Department often provides information about students who are involved in criminal activity off-campus. This information will be forwarded to the Office of Campus Life for possible University follow-up pursuant to University code of conduct violations.

If the department is notified of a situation in which a campus community member is the victim of a crime, depending on the circumstances the department may issue a Campus Crime Alert, detailing the incident and providing tips so that other community members may protect themselves.





# Security of and access to campus facilities

## Academic and Administrative

Access to campus buildings and grounds is a privilege extended to students, faculty, staff, and authorized guests. The University encourages an open environment with limited constraints to ensure the reasonable protection of all



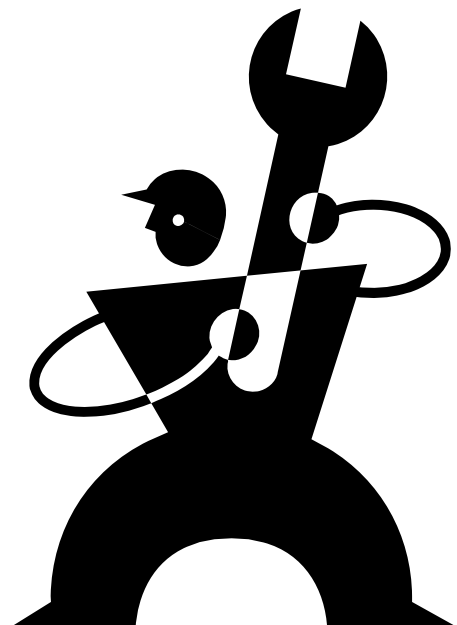
members of the community. Most campus facilities are open during weekday business hours. Individuals who wish to access campus facilities during non-business hours or for special events should contact the appropriate department administrator, Conference Services or the TCUPD.

An automated card access control system is also installed in many

academic and administrative buildings. University members with questions about the system should contact the TCUPD.

The TCUPD and representatives from the Physical Plant's access shop work together to identify inoperative locking mechanisms. We encourage community members to promptly report any locking mechanism deficiency to the Physical Plant's work order desk at 817-257-7956 or the TCUPD at 817-257-7777.

Maintenance staff is available to respond to calls for service regarding unsafe facility conditions, or for personal safety and property protection. These conditions may also include unsafe steps or handrails, unsafe roadways on campus, and unsecured equipment.



## Residence Halls

Texas Christian University offers traditional residence halls that provide campus housing for approximately 3,900 students. The safety and security of these residents, their property and the facility is important to TCU. The Office of Housing and Residential Life manages all TCU residence hall facilities. Every TCU residence hall is staffed by a professional, live-in residence hall director. A variety of live-in residence assistants (RA's) and other student staff also work in each campus residence hall facility. All staff members working in the Office of Housing and Residential Life undergo comprehensive training each year regarding community living environments and how safety and security are a vital part of that environment. All members of the office of Housing and Residential Life actively partner with the TCUPD to help keep the residence halls as safe as possible.

Each hall is locked 24 hours a day, 7 days a week with access being restricted to residents with valid electronic card reader access cards. Access is allowed at main entrances only. Access to residence hall facilities is restricted to residents, escorted guests and university staff. TCUPD can assist individuals with access needs after hours if the Housing and Residential Life staff are unavailable.

Safety and security related presentations are made each fall semester to all campus residence halls to alert residents to the fact that they are partners in preventing campus crime. Residents are encouraged to always lock their room doors and to alert Housing and Residence Life staff and the TCUPD if they see or hear anything unusual in or around the residence hall facilities.

## Landscape and Lighting



Texas Christian University is committed to campus safety and security. Exterior lighting, sidewalks, steps, and landscape control are critical parts of that commitment.

Various departments take part in security surveys that help ensure a safe campus. Routine checks of lighting

and safety issues are conducted as part of our patrol duties. If lights are not working, officers will initiate an immediate work order, which is acted upon by a representative of the appropriate maintenance office, usually by the next business day. We encourage community members to report any instances of inadequate lighting to the Physical Plant work order desk at 817-257-7956. Any community member who has a concern about physical security, including landscaping, should contact the TCUPD at 817-257-7777.

The TCU Physical Plant and grounds crews work hard to maintain an attractive landscaped campus. Any concerns about plants/shrubs or landscaping that may pose a safety or security risk should be reported to the TCUPD.

## Timely Warning Notices, Campus Crime Alerts

Every effort is made to keep the University apprised, on a timely basis, of crime problems confronting the campus community. When, in the judgment of the Chief



of Police, or his designee, a situation arises which constitutes an ongoing or continuing threat, a timely warning will be issued through the college email system to students, faculty, and staff, the campus student newspaper, The Daily Skiff, and the University's cable television information outlet, the TCU Bulletin Board, Cable Channel 21.

If community members report crimes or serious incidents to other University administrators, those administrators should notify the TCUPD. The department will collaborate with these administrators to issue a crime alert, if warranted.



## Distribution of Campus Crime Alerts

The TCUPD distributes campus crime alerts in various ways. Once the University determines that an alert will be issued, the department e-mails the announcement and posts it on its website <http://www.police.tcu.edu>.

The department may also post alerts on bulletin boards and/or residential housing doors throughout campus.



## Clery Required Daily Crime Log

Consistent with the Clery Act requirements, the TCUPD maintains a Daily Crime Log and Fire Report that records, listed by the date the incident was reported, all crimes and other serious incidents that occur:

- On campus
- In a non-campus building or property owned or operated by the University or its students in a reasonably contiguous geographic area
- On public property within, adjacent to, or immediately accessible from the campus
- Or within the department's patrol jurisdiction.

The Daily Crime Log is available for public inspection at the department's location, 3025 Lubbock Ave., or at <http://www.police.tcu.edu/Criminal%20investigations.htm>. The Daily Crime Log includes the nature, date, time, and general location of each crime reported to the department, as well as its disposition (if this information is known at the time.)

The department posts incidents in the Daily Crime Log within two business days of receiving a report of an incident and, in accordance with the Clery Act requirements, may exclude incidents from the log in certain circumstances, particularly those in which inclusion may compromise the investigation.

## TCUPD Responses to calls for services

The TCUPD will immediately dispatch an officer to investigate suspected criminal activity. Responses include, but are not limited to:

- Dispatch of one or more uniformed police officers
- Investigation of all reports
- Arrest and filing of charges, depending upon the circumstances of the offense
- Victim referral to assistance agencies, both on and off campus
- Referring alleged offenders to appropriate campus agencies, such as Campus Life and/or Alcohol and Drug Education



## Emergency Preparedness

Texas Christian University recognizes the need to be prepared for critical incidents. Under the guidance of the Emergency Operations Group, several departments work together to prepare for, prevent, respond to, and recover from emergency situations.

In conjunction with local government first responders, such as the Fort Worth Police Department, Fort Worth Fire Department and/or MedStar, the University is well prepared to respond to a full range of critical incidents.

The University's Health Center and Police Department work together to ensure our emergency protocols and plans are updated as needed.



## Notification to the community about an immediate threat.....

The TCUPD and the Office of Communications receive information from various offices/departments on campus. If the department confirms there is an emergency or dangerous situation that poses an immediate threat to the health or safety of some or all members of the University community, the Police Department and the Office of Communications will determine the content of the message and will use some or all of the systems described below to communicate the threat to the campus community, or to the appropriate segment of the community if the threat is limited to a particular building or segment of the population.

The Police Department will without delay and taking into account the safety of the community, determine the content of the notification and initiate the TCU Alert System that allows authorized TCU officials to send news and instructions through the use of e-mails and text messages within moments of a critical incident. An alert will be issued unless issuing a notification will, in the judgment of the first responders, including but not limited to the TCUPD, the Fort Worth Police Department, the Fort Worth Fire Department and or any Federal agencies, compromise the efforts to assist a victim or to contain, respond to, or otherwise mitigate the emergency.



In the event of a serious incident that poses an immediate threat to members of the TCU community, the University has various systems in place for communicating information quickly (such notification may be related to the aforementioned warning notice). Some or all of these methods may be activated in the event of an immediate threat to the TCU campus community. The University will also post updates on the TCU web page, [www.tcu.edu](http://www.tcu.edu).



TCU community members are encouraged to notify the TCUPD of any situation or incident on campus that involves a significant emergency or dangerous situation that may involve an immediate or ongoing threat to the health and safety of students and/or employees on campus. The TCUPD has the responsibility of responding to, and summoning the necessary resources, to mitigate, investigate, and document any situation that may cause a significant emergency or dangerous situation. In addition, the TCUPD has a responsibility to respond to such incidents to determine if the situation does, in fact, pose a threat to the community. If so, federal law requires that the institution notify the campus community or the appropriate segments of the community that may be affected by the situation.

## ACTIVE SHOOTER

The TCUPD has trained with the Fort Worth Police Department in responding to calls of an active shooter. If you see or hear of an active shooter on campus, immediately contact the TCUPD by dialing 817-257-7777 or 911. Do not approach the person with the weapon. Remain calm and if it is safe to do so, immediately leave the area and advise others to do the same. If possible, enter a building and go to a classroom or safe zone and secure the door, close the windows, turn off the lights, and stay low to the floor, away from the door. If the door will not lock, use barricades to help stop it from opening. Do not leave the area until you are instructed to do so by the TCUPD and/or other authorized personnel. Follow all instructions given to you by the TCUPD and/or other authorized personnel.

## SEXUAL ASSAULT

The University educates the student community about sexual assaults and date rape through mandatory freshman orientations each fall. The Police Department offers sexual assault education and information programs to University students and employees upon request. Literature on date rape education, risk reduction, and University response is also available through the TCUPD web site at <http://www.police.tcu.edu/crime%20prevention.htm>.

If you are a victim of a sexual assault at this institution, your first priority should be to get to a place of safety. You should then obtain necessary medical treatment. The TCUPD strongly advocates that a victim of sexual assault report the incident in a timely manner. Time is a critical factor for evidence collection and preservation. An assault should be reported directly to a University officer and/or to a Housing and Residential Life representative. Filing a police report with a University officer will

not obligate the victim to prosecute, nor will it subject the victim to scrutiny or judgmental opinions from officers. Filing a police report will:

- › ensure that a victim of sexual assault receives the necessary medical treatment and tests, at no expense to the victim;
- › provide the opportunity for collection of evidence helpful in prosecution, which cannot be obtained later (ideally a victim of sexual assault should not wash, douche, use the toilet, or change clothing prior to a medical/legal exam);
- › assure the victim has access to free confidential counseling from counselors specifically trained in the area of sexual assault crisis intervention.

When a sexual assault victim contacts the TCUPD, the Fort Worth Police Sex Crimes Unit will be notified as well. A representative from the Office of Campus Life will also be notified. The victim of a sexual assault may choose for the investigation to be pursued through the criminal justice system and the University Conduct Council, or only the latter. A University representative from the Police Department or the Campus Life office will guide the victim through the available options and support the victim in his or her decision. Various counseling options are available from the University through the Student Health Center, the Women's Center, University Ministries, Employee Assistance, and the Psychological and Counseling Center. Counseling and support services outside the University system can be obtained through the Office of Campus Life, TCUPD or the Fort Worth Police Sex Crimes Unit.

University disciplinary proceedings, as well as special guidelines for cases involving sexual misconduct, are detailed in the *Student Handbook*. The *Handbook* provides, in part, that the accused and the victim will each be allowed to choose one person who has had no formal legal training to accompany them throughout the hearing. Both the victim and accused will be informed of the outcome of the hearing. A student found guilty of violating the University sexual misconduct policy could be criminally prosecuted in the state courts and may be suspended or expelled from the University for the first offense. Student victims have the option to change their academic and/or on-campus living situations after an alleged sexual assault, if such changes are reasonably available.

## **Sex Offender Registry and Access to Related Information**

The Federal Campus Sex Crimes Prevention Act, enacted on October 28, 2000, went into effect October 28, 2002. The law requires institutions of higher education to issue a statement advising the campus community where law enforcement agency information provided by a State may be obtained concerning registered sex offenders. It also requires sex offenders already required to register

in a State to provide notice, as required under State law, of each institution of higher education in that State at which the person is employed, carries on a vocation, or is a student. This act amends the Family Educational Rights and Privacy Act of 1974 to clarify that nothing in that Act may be construed to prohibit an educational institution from disclosing information provided to the institution concerning registered sex offenders and requires the Secretary of Education to take appropriate steps to notify educational institutions that disclosure of this information is permitted. State law requires persons convicted of or placed on deferred community supervision for certain offenses to register as sex offenders. Offenders who committed "sexually violent" offenses (most contact offenses) must register for the remainder of their life, even after completing probation or parole. Others (some noncontact offenses) may quit registering ten years after completing their term of supervision. Law enforcement authorities are required to inform the University when registered sex offenders indicate they are living, working, or volunteering services on campus.

## BOMB THREAT

A bomb threat is usually made by phone and the recipient should attempt to have the person relaying the threat answer the questions below and then immediately notify TCUPD.

Ask the caller:

- When is the bomb going to explode?
- Where is the bomb located?
- What kind of bomb is it?
- What does it look like?
- Why did you place the bomb?

Keep talking to the caller as long as possible and record the following:

- Time of call
- Age and sex of caller
- Speech pattern, accent, or possible nationality
- Emotional state of the caller
- Background noise



In the event of a suspicious device or bomb threat, immediately call TCUPD, quickly and quietly clear the area, and do not open drawers, cabinets, or turn

lights on or off.

TCUPD officers will respond to the scene and implement procedures to mitigate the situation. If occupants are directed to evacuate the facility/area, they will move a minimum of 300 feet from the suspected bomb or suspicious device.

## Disruptive Individual

A disruptive individual is someone who:

- Makes threats of physical harm to others or themselves
- Behaves in a bizarre manner or is out of touch with reality
- Appears to be intoxicated or under the influence of drugs

### **Steps to take when dealing with a disruptive individual:**

- Contact TCUPD and give your name, location, and a brief description of the incident
- If possible provide a name and/or description of the individual
- Maintain a safe distance and do not confront or attempt to restrain the person
- Try to keep the person calm and within sight until assistance arrives

## EMERGENCY EVACUATION PROCEDURES

An evacuation drill is coordinated by the Office of Housing and Residential Life and a team of University employees each semester for all residential facilities.



Thus, the emergency response and evacuation procedures are tested at least twice each year. Students learn the locations of the emergency exits in the buildings and receive guidance about where they should assemble. The TCUPD does not tell residents in advance about the designated locations for evacuations because those decisions are affected by time of day, location of the building being evacuated, the availability of various designated emergency gathering locations on campus, and other factors such as the location and nature of the threat. In all cases, staff from the TCUPD and the Office of Housing and Residential Life on the scene will communicate information to students regarding the developing situation or any evacuation status changes. The purpose of these evacuation drills is to prepare building occupants



for an organized evacuation in case of a fire or other emergency. At TCU, evacuation drills are used as a way to educate and train occupants on fire-safety issues specific to their building. During the drill, occupants “practice” drill procedures and familiarize themselves with the location of exits and the sound of the fire alarm. The process also provides the University an opportunity to test the operation of fire alarm system components. Evacuation drills are monitored by the TCUPD and the Office of Housing and Residential Life staff to evaluate egress and behavioral patterns. Reports are prepared by participating departments that identify deficient equipment so that repairs can be made immediately. Recommendations for improvements also are submitted to the appropriate departments/offices for consideration of its emergency response and evacuation procedures.



## EXPLOSION

If there is an explosion, take immediate cover under tables, desks or other objects that will give you protection from falling glass and debris. Do your best to remain calm and once it is safe to do so, evacuate the building and respond to your assigned meeting place so that an accurate account of the building’s occupants can be made. If others around you need assistance and you can safely do so, assist them in exiting the building. Use caution when opening doors or exiting the windows of the building. As soon as possible, contact the TCUPD by dialing 817-257-7777 or 911 and tell them as much information as possible including the location of the explosion, other locations in the building where injured people may be and any injuries you have observed. Follow all instructions given to you by the TCUPD and/or other authorized personnel.



## FIRE

If the fire alarm sounds, remain calm and immediately evacuate the building by the nearest exit. If you observe smoke or a fire and the alarm is not sounding, leave the building immediately and while doing so attempt to find the nearest pull station and activate the fire alarm if it is safe to do so. Close doors behind you if possible and safe to do so. Shut down any hazardous operations quickly if it is safe to do so. If it is not safe to use the nearest exit, go to the next nearest available exit. Do not use elevators! Contact the TCUPD by dialing 817-257-7777 or 911 as soon as possible.



Remain calm, do not run! Go to your building's assigned meeting area so that an accurate account of building occupants can be made. If you can do so safely, assist any person(s) with disabilities with their evacuation. If you know of anyone who may possibly be trapped inside, notify the TCUPD and provide the trapped person(s) last known location.

## HAZMAT SPILL



In the event there is a hazardous material spill, immediately leave the area if it is safe to do so and go to a safe area. Remain calm. If you or another person needs medical assistance or to use the decontamination facilities in another building and it will not affect your safety, please do this first. Avoid contact with others during this process. As soon as you or another person are able, contact the TCUPD or dial 911. Provide as much information as possible

including identity of hazardous material involved, the location and how many people are affected. Follow all the instructions that are given to you by the TCUPD and/or other authorized personnel.



## HOSTAGE SITUATION

If you see or hear of a possible hostage situation, immediately remove yourself from any danger. Remain calm and contact the TCUPD as soon as you can do so safely. Be prepared to give as much information as possible to the TCUPD including your name and phone number, the location, number of possible hostages, number of possible hostage takers, physical descriptions of the hostage takers, any possible injuries, and the type of weapon being used.

If you are taken hostage, remain calm and cooperate with your captors. Do not attempt to escape unless there is no danger in doing so. If possible, call the TCUPD and leave the line open. Do not draw attention to yourself. Do what you are told to do. Do not speak unless spoken to and do not try to intimidate the captors. Stay low below windows and behind cover if possible.

## INTRUDER ON CAMPUS

If you come across or learn of an intruder or someone who is threatening the safety of individuals on campus, immediately contact the TCUPD as soon as you can do so safely. In addition, remove yourself from danger, if safe to do so get to a safe zone. Do not approach the person. Be prepared to give a full description of the individual, as well as his or her location.



## LOCKDOWN

In the event that an emergency situation arises, the TCUPD and/or other personnel will lockdown some or all buildings on campus. You will be notified of a lockdown by the TCU Alert System, which includes a variety of methods to provide swift and accurate information to the community.

In the event of a lockdown, remain calm, lock your doors, close and lock your windows, and shut blinds. If you can do so safely, inform others in your area of the lockdown. If someone needs assistance and you can do so safely, help get them to the lockdown area. If you are in an area that does not lock, use all available items including desks, dressers, tables, chairs, etc. to barricade doors. Stay low on the floor away from windows and doors and under desks if possible. Do not leave the area until you are told to do so by the TCUPD and/or other authorized personnel.

## MEDIA POLICY

If members of the media are on campus covering an emergency of any kind, the Office of Communications will answer all questions from the media. Please direct all questions from the media to the Office of Communications.

## MEDICAL EMERGENCY

Remain calm and contact the TCUPD. Do not move the injured/ill person. If it is safe to do so, comfort them and reassure them that help is on the way. Do not touch the person if you are not certified in first aid and/or do not have personal protection gear if there is danger of coming into contact with bodily fluids. If you are certified in first aid and it is safe to do so, provide care to the person to the extent you are capable. Follow all directions given to you by the TCU Police and/or authorized personnel.



## SUICIDE ATTEMPT

If there is a possible suicide attempt or in the event a person expresses suicidal thoughts, do not leave the person alone if you can remain with them safely. Contact the TCUPD and remain calm. If weapons are present, leave the area immediately. Do not touch any weapons or other items that the person may consider using, or has used, to ensure your personal safety. Advise the TCU Police Department of all possible weapons or other items if you can do so safely. Show support to the person without being judgmental. Follow all directions given to you by the TCUPD and/or other authorized personnel.

If there is a possible suicide, do not touch anything in the area. Immediately contact the TCUPD and report the situation. Remain calm and be prepared to give all information possible to the TCUPD including your name, phone number, location, name of victim if known, and any other pertinent information.

## STALKING/INTIMATE PARTNER VIOLENCE

If a student/staff member reports to you that he/she believes that he/she is in an abusive relationship or is being stalked, he/she may be in either imminent danger or immediately at risk. Stalking and intimate partner violence is a serious crime and is so often minimized. College campuses are closed environments and for that reason pose a great risk to victims of intimate partner violence/stalking.

If the victim believes he/she is in imminent danger, locate a safe place; police station, residence unknown to assailant, domestic violence shelter, church or public place. Call the TCUPD if on campus or if off-campus dial 911.

If the victim believes he/she is not immediately at risk, offer options to call the TCUPD, victim services/counseling on-campus, and off-campus victim service agencies. These entities will explain protection/restraining orders, stalking laws, documentation of events, contingency/escape planning.

If a student/staff believes that he/she is being stalked, explain to him/her to maintain a log recording all stalking-related behaviors including, but not limited to, electronic mail, phone calls, text messaging, and in-person contact. Regardless of whether or not he/she chooses to report the events, they will have documentation.

## SUSPICIOUS PACKAGE

If you discover a suspicious package or substance, do not touch the item. Remain calm and immediately leave the area, and warn others of the possible danger. If physical contact is made with the package or substance, wash all affected areas of the body as soon as possible.

Do not use a cell phone near the area. Once you can safely do so, contact the TCUPD and advise them of the situation. Be sure and provide any information you can recall regarding the location of the item, size, description, etc. Follow all instructions given to you by TCUPD and/or other authorized personnel.

## THEFT / ROBBERY

In the event of a burglary or robbery in a classroom, residence hall, office, or other campus property, contact the TCUPD immediately so that members of the campus community can be warned. A robbery is the attempt to take something by using force. If this occurs, report items missing along with a description of the perpetrator. If a student reports a mugging or robbery to you, contact the TCUPD immediately. On college campuses, most perpetrators of robberies are serial and will continue to prey on the community.

A burglary occurs when no one is present or no force is used while belongings are taken from a dormitory, office, classroom, or other campus property. Report items missing and suspicious persons to the TCUPD.

## WEAPON ON CAMPUS

If you observe a weapon on campus, you should remain calm and immediately contact the TCUPD. Do not touch the weapon. If the situation warrants, remove yourself from the area in which the weapon is located. Advise the TCUPD of your exact location and a description of the weapon. Follow all instructions given to you by the TCUPD and/or authorized personnel.

If you observe a person(s) with the weapon, remain calm and contact the TCUPD as soon as it is safe to do so. Provide all available information to the TCUPD including your name, phone number, and a description of yourself, a description of the person with the weapon, the types of weapon (if you know) and the number of weapons you have observed as well as any other information that could be pertinent. Follow all instructions given to you by the TCUPD and/or other authorized personnel.

## WEATHER EVENT

In the event of severe weather, the National Weather Service will issue a warning or advisory. Weather alerts can include, but are not limited to, ice storms, snow storms, thunderstorms, or tornado watches and warnings. If possible, stay inside your building, away from windows and other areas with glass. Do not use your cell phone or any type



of portable phone during a thunderstorm. If you are outside, immediately go into a building to avoid possible falling tree limbs and other debris.



## Shelter-in-place procedures:



If an incident occurs and the buildings or areas around you become unstable, or if the air outdoors becomes dangerous due to toxic or irritating substances, it is usually safer to stay indoors, because leaving the area may expose you to that danger. Thus, to “shelter in place” means to make a shelter of the building that you are in. In a longer-term emergency, this location can be made even safer and more comfortable with a few adjustments until it is safe to go outside.

If an incident occurs and the building you are in is not damaged, stay in an interior room until you are told it is safe to exit. If your building is damaged, take your personal belongings (purse, wallet, ID card, etc.) and follow the evacuation procedures for your building (close your door, proceed to the nearest exit, and use the stairs instead of the elevators). After you have evacuated, quickly seek shelter at the nearest University building. If police or fire department personnel are on the scene, follow their directions.

## How will you know to “shelter in place?”

A shelter-in-place notification may come from several sources, including the TCUPD, Office of Housing and Residential Life, and other University employees utilizing the University’s emergency communication tools.

Always be aware of your surroundings, be prepared for the unexpected, and stay informed of what is transpiring with an emergency incident.



## How to “shelter in place”

No matter where you are, the basic steps of “shelter in place” will generally remain the same. Should the need ever arise, follow these steps, unless instructed otherwise by local emergency personnel:

- If you are inside, stay where you are. Collect any emergency shelter-in-place supplies and a telephone to be used in case of emergency. If you are outdoors, quickly proceed into the closest building or follow instructions from emergency personnel on the scene.
- Locate a room to shelter inside. It should be:
  - a. an interior room;
  - b. above ground level; and
  - c. without windows or with the least number of windows. If there is a large group of people inside a particular building, several rooms may be necessary.
- Close and lock all windows and close exterior doors.
- Turn off air conditioners, heaters, and fans.
- Close vents to ventilation systems as you are able (University staff will turn off the ventilation as quickly as possible).
- Make a list of the people with you and ask someone (another faculty or staff member) to call and provide the list to the TCUPD so officers know where you are sheltering. If only students are present, one of the students should call and provide the list.
- Turn on a computer, radio, or TV and listen for further instructions.

## Contacting the TCU Police Department

Any member of the University community who wishes to file a complaint should contact the TCUPD at 817-257-7777.

The officer's primary concern will be the safety of the victim. Reporting the incident to the police department does not mean that a victim must file criminal charges. He or she maintains the ultimate decision to file charges.

## Notification of missing students

If a member of the University community has reason to believe that a student who resides in on-campus housing is missing, he or she should immediately notify the police department at 817-257-7777. TCUPD will generate a missing person report and initiate an investigation. After investigating the missing person report, should the department determine that the student is missing and has been missing for more than 24 hours, TCUPD will notify the Fort Worth Police Department and also the student's emergency contact no later than 24 hours after the student is determined to be missing. If the missing student is under the age of 18 and is not an emancipated individual, the University will notify the student's parent(s) or legal guardian(s) immediately after the TCUPD has determined that



the student has been missing for more than 24 hours. In addition to registering an emergency contact, students residing in on-campus housing have the option to identify, confidentially, an individual to be contacted by the University in the event the student is determined to be missing for more than 24 hours. If a student has identified such an individual, the University will notify that individual no later than 24 hours after the student is determined to be missing. A student's confidential contact information will be accessible only by authorized campus officials and law enforcement as appropriate.

## Education regarding fire/security measures

Campus security and fire safety procedures are discussed during “Frogs First” TCU’s new student orientation week. The TCUPD and the Office of Campus Life, in addition to staff in the housing department, participate in forums and programs in residence halls to address students and to explain University security, public safety, and fire safety measures and procedures at Texas Christian University. Members of the TCUPD conduct crime prevention and general security and safety awareness presentations when requested by



various community groups, including students and employees of the University. During these presentations, the following information is typically provided: crime prevention tips; statistics on crime at TCU; fire safety information; and information regarding campus security procedures and practices, including encouraging participants to be responsible for their own security/safety and for the security/safety of others on campus. In addition, the TCUPD organizes and sets up crime prevention and education display tables, which are staffed by an officer(s) at various locations throughout the year. This activity provides an opportunity for the TCUPD staff to hand out safety-related information, as well as to answer individual questions.

## Crime prevention education and awareness; Preventing crime through collaboration and cooperation



Crime prevention is a top priority of the TCUPD. Together with other campus offices, at the beginning of each school year, the department meets with each residence hall to provide programs to enhance personal safety and teach proactive crime-reduction strategies. The campus's crime-prevention strategy involves a proactive area patrol of the campus, crime prevention education, and training to members of the University community, with information gathered from building and area security surveys. This approach relies on the dual concepts

of eliminating or minimizing criminal opportunities and encouraging community members to take responsibility for their own and each other's safety. Members of the department are available to assist any individual or group in planning, presenting, and coordinating programs of interest or concern. Listed below are some of the programs and services offered by the department.

### **Rape Aggression Defense (RAD)**



The RAD program has been on campus since September, 1996 and has been well received by the campus community. RAD stands for Rape Aggression Defense system and it teaches women defensive concepts and techniques against various types of assault by utilizing easy, effective, and proven self-defense/martial arts tactics. RAD provides effective options by teaching women to take an active role in their own self-defense and psychological well-being. The RAD program



was developed for and is offered to females only. E-mail notices will be sent out throughout the year for registration in one of the classes here on the TCU campus.

## **Froggie Five-0**

Students who use the Escort Service (Froggie Five-0) have responded positively



to the program. TCU Police Officer escorts are offered 24 hours a day, 7 days a week. Student escorts however, operate between the hours of 8:00 p.m. to 1:00 a.m., fall and spring semesters. If you need someone to walk with you from the parking lots to your dorm or provide transportation (when available), call Froggie Five-0. Use the emergency

phones at various locations near parking lots and around campus or dial 7777 at any time to request the service. If you have a cellular phone in your car, you may phone TCUPD at 257-7777, request an escort, and, in many cases, have the service waiting on you when you arrive. The TCUPD and Froggie Five-0 are here to assist you.

## **Assault Prevention Theater**

A visual presentation of the issues surrounding sexual assault makes a more



dramatic impact on audiences than mere "speaking" presentations. The TCU Theatre Department joined with the TCUPD in forming a "troupe" of student theatre-majors who provide the programs for APT performances. The presentations are followed by a group discussion with players remaining "in character" while audience members ask questions or offer comments concerning the events they have witnessed.



## EMERGENCY BLUE LIGHT PHONES

The emergency, “blue light” (on top of phone box for identification), phones are located in parking lots, on jogging paths, and near many buildings on campus. Should an emergency or any situations requiring police service arise: go to the emergency phone, pick up the receiver, then press the button and, when the dispatcher answers, relate the necessary information to get assistance to you. The location of the phone from which you are calling automatically registers in the dispatch office. The dispatcher will send officers to your location; try to remain near the phone from which you call, if in so doing, you do not further jeopardize your safety.

### Campus Crime Watch

Program emphasis is of a "neighborhood watch" nature with the TCU campus being our neighborhood. Meetings for the program are open to all students, faculty, staff, and friends. TCUPD's Crime Prevention Specialist hosts the meetings and provides speakers on subjects of interest to campus community members.

### Lost and Found

The TCUPD is the official lost and found office. Articles lost or found should be reported as soon as possible to help the office in returning property to the rightful owner.

All found property turned into the TCUPD will be stored for at least 180 days in an effort to return property to the rightful owner.



## WHAT TO DO IF YOU ARE A VICTIM OF ANY CRIME

The TCUPD encourages anyone who is the victim or witness to any crime to promptly report the incident to the police. Because police reports are public records under state law, the TCUPD cannot hold reports of crime in confidence. Confidential reports for purposes of inclusion in the annual disclosure of crime statistics can generally be made to other TCU campus security authorities\* as herein identified.

\* Campus security authorities are identified as any member of the TCU Police Department, its officers and staff; and any University official who has significant responsibility for student and campus activities, including, but not limited to, the Offices of Campus Life, its Deans, and Directors; Housing and Residence Life staff, Hall Directors, and Residential Advisors; the Department of Athletics (coaches); the Chancellor, Vice-Chancellors, and their respective offices; and any other University official who has the authority and the duty to take action or respond to particular issues on behalf of the University.

### If on campus...

Contact TCUPD at 817-257-7777 as soon as possible. Inform the dispatcher of the nature of the crime committed and the description and direction of travel taken by the criminal, if available.

Remember all you can about the criminal and give the description to the police dispatcher. Information to relate includes: race/sex of suspect, clothing description, height/weight, eye/hair color, any unusual features, jewelry, and a description of the suspect vehicle.

Stay on the telephone with the police dispatcher until he or she understands your information, if in so doing, you do not jeopardize your safety.



### If off campus...

Dial 9-1-1 for emergencies, 817-335-4222 for non-emergency calls to Fort Worth Police.



## Alcohol and Substance Abuse

All students, employees, and visitors are subject to state and local laws regarding the possession, consumption, and sale of alcoholic beverages on campus. Legal drinking age in Texas is 21 years of age. Students 21 years of age or older may consume alcoholic beverages in their dorm rooms only. No underage drinking is permitted on campus and doing so is a violation of the Code of Student Conduct. Illicit drug usage is prohibited by TCU policy. Prescription drugs must be used as prescribed by a licensed physician and must conform to State law. Information on education programs can be found in the Student Handbook. The TCUPD enforces state and federal laws for the possession, use, and sale of illegal drugs. For additional information, including penalties see the police department website at <http://www.police.tcu.edu/alcoholdrug.htm>.

## Pastoral Care/Counselor Reporting Procedures

TCU community members are strongly encouraged to immediately report criminal activity and suspicious person(s) to the TCUPD. Incidents that may or may not be crimes may also be reported to "campus security authorities". Licensed counselors (including certified Sexual Assault Victim Counselors) and campus clergy (pastoral counselors) are exempt from reporting requirements. TCU encourages counselors and clergy; if and when they deem it appropriate, to inform those who they counsel of procedures for reporting crimes on a voluntary, confidential basis for inclusion in the Campus Security Report.

## IDENTITY THEFT

The most common way thieves go about getting your personal information is by stealing your wallet. However, other ways include looking over your shoulder at ATMs and phone booths to capture your PIN number; stealing mail from your mailbox; digging through your discarded trash; and fraudulently ordering a copy of your credit record.

To prevent this from happening to you:

- Do not give out your social security number. If a stranger telephones you asking for bank account or social security information, get a business number and call back.

- Tear into small pieces all credit card offers, ATM receipts, bank statements, credit card statements, and other printed materials that have your account numbers on them. Use a paper shredder if possible.
- Do not send personal information over the Internet, through email, or over cellular phones.
- Do not use passwords that are obvious - names (yours or those of your friends, relatives, or pets), birth dates, even street addresses. The best passwords mix numbers with upper and lowercase letters. A password that is not found in the dictionary is even better because there are programs that will try every word in the dictionary in an effort to crack your code.
- Avoid break-ins by changing your password regularly and memorizing it. If you have several, set up a system for remembering them. Do not write your password on your notebook or stick it on a Post-it note in your wallet or purse.

## Protect Your Credit Cards

- Only give your credit card account number to make a purchase or reservation you have initiated. And never give this information over a cellular phone.
- Never give your credit card to someone else to use on your behalf.
- Watch your credit card after giving it to store clerks to protect against extra imprints being made.
- Destroy any carbons. Do not discard into the trash can at the purchase counter.
- Keep charge slips in a safe place.
- Protect your purse or wallet, especially when traveling or in crowded situations.
- Never leave your purse, wallet, or backpack unattended or in an unlocked area.
- Keep a master list in a secure place at home with all account numbers and phone numbers for reporting lost or stolen cards.
- Cancel all credit cards that you have not used in the last six months. Open credit is a prime target.
- Order your credit report at least twice a year. Reports should be obtained from all three major sources: Equifax (800.685.1111); Experian (888.397.3742); and TransUnion (800.680.7293).

## Workplace violence

To ensure the safety and security of the workplace, the University has implemented a policy for addressing threats and/or threatening behavior, or acts of violence by University employees against staff members, faculty, students, visitors, or other individuals on University property, or by University employees while in the conduct of University business off campus. A member of the University community who exhibits inappropriate or disruptive behavior deemed to be threatening or potentially threatening may be subject to disciplinary action. The employee may be required to attend an employee-assistance program for assessment and counseling as a condition of continued employment.

All staff members should report threatening or violent behavior, whether that behavior is exhibited by a member of the TCU community or a visitor to the campus. A report can be made to TCUPD, the Office of Campus Life, or the Office of Human Resources.

## Shuttle Service

TCU provides a shuttle service from lots 3 and 4 (north of the stadium) to the main campus and east campus, and from lot 12 (on Sandage Avenue) to the east campus. These shuttles run during the Fall and Spring semesters and a limited route during the summer. Also, the T (Fort Worth Transportation Authority) operates a route from Worth Hills to the main campus and east campus during the Fall and Spring semesters. The shuttles are available from 6:30 a.m. to 4:00 a.m., depending on the route. ## Bicycle Registration

The primary function of TCUPD's bicycle registration program is to provide identification for bicycles stored on campus. While bicycle registration with the TCUPD is not mandatory, we strongly encourage you to consider registering your bike with us. # CRIME STATISTICS

The TCUPD maintains a very close relationship with the Fort Worth Police Department to ensure that crimes reported directly to the Fort Worth Police Department involving University community members are brought to the attention of the TCUPD.

## Definitions of reportable crimes in the Campus Security Act (FBI's Uniform Crime Reporting Program)

### **Criminal homicide**

- Murder and non-negligent manslaughter. The willful (non-negligent) killing of one human being by another.
- Negligent manslaughter. The killing of another person through gross negligence.

### **Forcible sex offenses**

- Forcible rape. The carnal knowledge of a person, forcibly and/or against that person's will; or not forcibly or against the person's will, where the victim is incapable of giving consent because of his or her youth or because of temporary or permanent mental or physical incapacity.
- Forcible sodomy. Oral or anal sexual intercourse with another person, forcibly and/or against that person's will; or not forcibly against the person's will, where the victim is incapable of giving consent because of his or her youth or because of his or her temporary or permanent mental or physical incapacity.
- Sexual assault with an object. The use of an object or instrument to unlawfully penetrate, however slightly, the genital or anal opening of the body of another person, forcibly and/or against that person's will; or not forcibly or against the person's will, where the victim is incapable of giving consent because of his or her youth or because of his or her temporary or permanent mental or physical incapacity.
- Forcible fondling. The touching of the private body parts of another person for the purpose of sexual gratification, forcibly and/or against that person's will; or, not forcibly or against the person's will, where the victim is incapable of giving consent because of his or her youth or because of his or her temporary or permanent mental or physical incapacity.

### **Non-forcible sex offenses**

- Incest. Non-forcible sexual intercourse between persons who are related to each other within the degrees wherein marriage is prohibited by law.
- Statutory rape. Non-forcible sexual intercourse with a person who is under the statutory age of consent.

### **Robbery**

- The taking or attempting to take anything of value from the care, custody, or control of a person or persons by force or threat of force or violence, and/or by putting the victim in fear.

### **Aggravated assault**

- An unlawful attack by one person upon another for the purpose of inflicting severe or aggravated bodily injury. This type of assault usually is accompanied by the use of a weapon or by a means likely to produce death or great bodily harm. (It is not necessary that injury result from an aggravated assault when a gun, knife, or other weapon is used that could and probably would result in serious personal injury if the crime were successfully completed.)



### **Burglary**

- The unlawful entry of a structure to commit a felony or a theft. For reporting purposes, this definition includes: unlawful entry with intent to commit a felony; breaking and entering with intent to commit a larceny; housebreaking and safecracking; and all attempts to commit any of the aforementioned acts.

### **Motor vehicle theft**

- The theft or attempted theft of a motor vehicle. Motor vehicle theft is classified as any case where an automobile is taken by a person not having lawful access, even if the vehicle is later abandoned, including joy riding.



## Arson

- Any willful or malicious burning or attempt to burn, with or without intent to defraud, a dwelling house, public building, motor vehicle or aircraft, personal property of another, etc.

## Other offenses

- **Liquor law violations.** The violation of laws or ordinances prohibiting: the manufacture, sale, transporting, furnishing, or possession of intoxicating liquor; maintaining unlawful drinking places; furnishing liquor to a minor or intemperate person; using a vehicle for illegal transportation of liquor; drinking on a train or public conveyance; and all attempts to commit any of the aforementioned activities. (Drunkenness and driving under the influence are not included in this definition.)
- **Drug abuse violations.** Violations of state and local laws relating to the unlawful possession, sale, use, growing, manufacturing, and making of narcotic drugs. The relevant substances include: opium or cocaine and their derivatives (morphine, heroin, codeine); marijuana; synthetic narcotics (Demerol, methadone); and dangerous non-narcotic drugs (barbiturates, Benzedrine).
- **Weapon laws violation.** The violation of laws or ordinances dealing with weapon offenses, regulatory in nature, such as: the manufacture, sale, or possession of deadly weapons; the carrying of deadly weapons, concealed or openly; the furnishing of deadly weapons to minors; aliens possessing deadly weapons; and all attempts to commit any of the aforementioned acts.

## How do we compile these statistics?

The TCUPD collects the crime statistics disclosed in this report through a number of methods.

Police officers enter all reports of crime incidents made directly to the department through ARMS, automated report management system. After an officer enters the report into ARMS, a department administrator reviews the report to ensure it is appropriately classified in the correct crime category. The department periodically examines the data to ensure that all reported crimes are recorded in accordance with the crime definitions outlined in the FBI Uniform Crime Reporting Handbook.

## Offense definitions relating to hate/bias-related crime

Statistics as per the UCR Hate Crime Reporting Guidelines

Hate crimes include those based on race, gender, religion, sexual orientation, ethnicity, and disability, such as:

- **Simple assault.** An unlawful physical attack by one person upon another where neither the offender displays a weapon, nor the victim suffers obvious, severe, or aggravated bodily injury involving apparent broken bones, loss of teeth, possible internal injury, severe laceration, or loss of consciousness.
- **Intimidation.** To unlawfully place another person in reasonable fear of bodily harm through the use of threatening words and/or other conduct, but without displaying a weapon or subjecting the victim to actual physical attack.
- **Theft.** To unlawfully appropriate property with the intent to deprive the owner of said property.
- **Vandalism.** To willfully or maliciously destroy, damage, deface, or otherwise injure real or personal property without the consent of the owner or the person having custody or control of it.

## ANNUAL FIRE SAFETY REPORT

Texas Christian University, pursuant to the Institutional fire safety policies and fire statistics, since July 01, 2010 have been compiling data for the Annual Fire and Safety Report. An institution must report statistics for each on-campus student housing facility, for the three most recent calendar years for which data are available. Texas Christian University maintains a fire log. The Fire Log table below is designed to contain a compilation of actual fire statistics for each calendar year (should any exist) for Texas Christian University on-campus student housing. The Fire Log table is designed to include statistics outlining the number of actual fires and the cause of each actual fire, the number of injuries and deaths related to actual fires and the value of property damage related to actual fires for Texas Christian University on-campus student housing (should any exist).

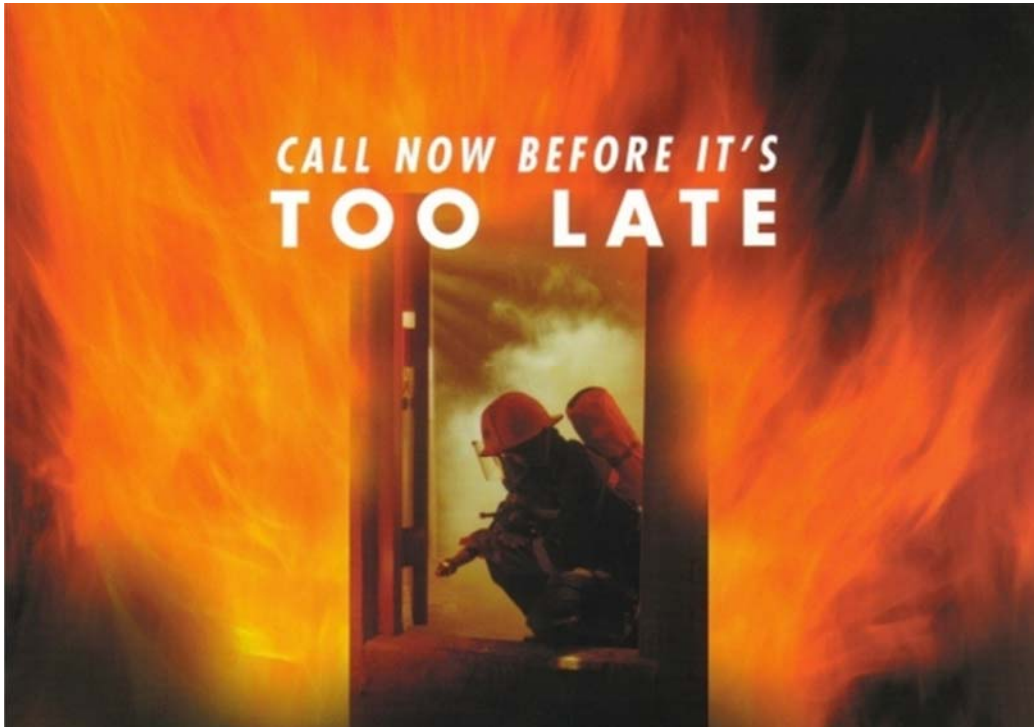
For a fire to be reportable, for Higher Education Opportunity Act / Clery Act, it must be an actual fire, and it must meet the federal definition of a fire. The Higher Education Opportunity Act (HEOA) regulations define fire as “[a]ny instance of open flame or other burning in a place not intended to contain the burning or in an uncontrolled manner.

### On-Campus student housing and life safety systems

Texas Christian University has a total of 39 on-campus student housing facilities. Each facility is equipped with fire detection systems, which consist of smoke and or heat detectors, and or pull box stations. All fire life safety systems report directly to the TCUPD, and the Texas Christian University Physical Plant.

### Mandatory supervised fire drills

Texas Christian University conducts two mandatory fire evacuation drills per calendar year, one in the fall and one in the spring. The fire evacuation drills are supervised by the housing inspection manager and a team of University employees. The fire evacuation drills are conducted by activating each individual fire alarm system in each on-campus student housing facility.

### Fire Safety Policies

Texas Christian University considers fire safety extremely important and students have an obligation to adhere to University regulations as well as city and state statutes. The following are TCU policies and procedures for matters involving fire safety.

#### 3.2.5 Tampering with Safety Equipment and Arson

Use of equipment designed for safety or security in a manner inconsistent with the intended use of the equipment or intentional or unintentional use of flame or

heat in a dangerous manner. Violators of this policy may also face criminal charges. This includes but is not limited to:

- a. the activation of a smoke detector in a non-emergency situation whether done intentionally or by failure to exercise reasonable care;
- b. discharging a fire extinguisher in a non-emergency situation;
- c. tampering with or activating a building alarm in a non-emergency setting;
- d. setting fires inside a building and on campus;
- e. non-emergency or prank use of emergency telephones.

### **Setting a Fire (Arson)**

Any individual who sets a fire (commits arson) in or near a University building is subject to immediate suspension from the University, will be charged a fine of \$400, and may be charged for the repairing of any damage caused by the fire and subject to criminal charges.

### **False Fire Alarm Sanctions**

Every effort will be made to identify the individual(s) who causes a false alarm. When such person(s) are identified they will be referred to the Campus Life Office for disciplinary action, which may include suspension from the University, even for a first offense and be subject to criminal charges. In addition to appropriate disciplinary action, an assessment of \$400 for the false fire alarm will be charged to the individual involved. In the event that an individual or individuals cannot be identified within 10 class days, the false alarm assessment will be charged to all individuals in the residence hall or living unit with a \$5 minimum charge for each resident.

### **Procedures for Student Housing Evacuations**

Know these procedures in the case of an evacuation:

1. Leave the building immediately upon hearing the fire alarm sound. Under normal conditions, all students are expected to evacuate from the residence halls in less than 3 minutes. All occupants must leave the building and may not return unless told to do so by TCUPD Police officers or fire officials.
2. Learn the locations of all exits nearest to your room. Do not assume your regular exit is closest or safest.
3. If possible, wear shoes and dress appropriately for the weather conditions.
4. When you leave your room, close the door.

5. If smoke is present, crawl low to the floor or stay in your room (see #9 below).
6. Only use stairways; never use an elevator.
7. Warn fellow neighbors by knocking on doors as you quickly make your way to the nearest exit. Once outside, go to the building collection area at least 150 feet away from the building.
8. If you cannot leave your room for any reason:
  - a. block all openings with wet towels;
  - b. call TCUPD (x7777) or 911 and advise the dispatcher of your location;
  - c. stay close to the window holding a wet towel to your face;
  - d. do not open the windows except to alert rescue personnel by hanging a white sheet or cloth out the window.
9. Any individual who fails to evacuate a building after a fire alarm has sounded will be subject to appropriate disciplinary action and may be charged a fine of at least \$100, unless forced to do so due to circumstances of an emergency.

### **Misuse of Fire Safety Equipment(Other than Fire Alarms)**

Any individual who misuses or tampers with any fire safety equipment (other than fire alarms) will be subject to appropriate disciplinary action and will be charged a fine of \$100 (minimum) plus the cost of repair or replacement of misused or damaged equipment, cleaning of the facility, and damage to other property. In addition to being subject to University penalties, any student who starts a fire, damages or tampers with the evacuation alarm or misuses fire safety equipment will be subject to criminal charges.

- Tampering with a fire extinguisher
- Tampering or damaging control valves
- Smoking in any residence hall
- Breaking a sprinkler head (s)
- Removing smoke detectors or covers
- Disabling fire suppression system
- Blocking exits with furniture or other items
- Tampering or damaging fire exit lights, lights, pull stations, notification devices, or obstructing locking exit doors.

### **Prohibited Items and Actions**

- The following items are prohibited in the Residence Halls:
  - Candles/ Incense/ Plug-ins



- Halogen Lamps (floor or desk lamps)
- Broilers/Skillets/Woks
- Toaster Ovens/Toasters, Hot-plates
- Attaching anything near or by sprinkler heads or water pipes
- Fireworks/Explosives
- Coffee pots, microwaves, refrigerators, heaters
- All flammable or combustible products
- Things to Know:
  - Any furniture item brought by a resident must be certified by the manufacturer as flame-retardant; otherwise, the item is prohibited.
  - Unannounced Health and Safety inspections will be done on a monthly basis and/or at holiday breaks
- The following actions are prohibited because they can activate the fire systems:
  - Physical activities such as hockey and basketball in lounges and hallways.
  - Throwing water or other liquids in lounges or hallways.
  - Spraying paint or water in lounges or hallways.

## Training

Texas Christian University conducts training for resident assistants and hall directors. Every residence hall occupant will be instructed about fire safety procedures during mandatory meetings at the beginning of each academic school year.

Resident assistant and hall director training covers:

- Evacuation and emergency preparedness
- Causes and types of fires
- Fire safety and prevention
