Upon arriving on the scene, Officer Salazar located the decedent, later identified as Bidley Warren (DOB 5/6/90), lying on the south side of the sidewalk with a gunshot wound to his head. The decedent was unconscious and unresponsive. The decedent was from the 1200 block of Brentwood Road, NE, which is considered part of the "Saratoga" neighborhood. He was transported to Med Star where he was pronounced dead at 2241 hours. On Friday, August 24, 2012, an autopsy was performed. The cause of death was determined to be a gunshot wound to the head and the manner of death was ruled a homicide.  Your Affiant and Detective Corbett interviewed a wimess ("WI"), who stated that IT was walking on Rhode Island Avenue, NE, with the decedent. When they reached the intersection of 10 <sup>th</sup> and Rhode Island Avenue, IT saw a group of guys standing on a porch on 10 <sup>th</sup> St, NE. WI thought it was the third or fourth house on the right side of the street, walking from Rhode Island Ave towards the dead end on 10 <sup>th</sup> Street. WI said one of the guys walked off the porch, pull out a gun and began shooting at them. W1 and the decedent began running. WI stated that IT felt rounds passing by IT's head. WI stated that the decedent tripped and fell to the ground. WI attempted to help the decedent to his feet but saw the shooter pointing the gun at him. WI ran and did not see the decedent alive again. WI stated that while running, IT heard two more gunshots coming from the location where IT last saw the decedent alive. WI described the shooter as a black in color, but was unsure what type it was. This is a supplemental statement to the Affidavit in Support of an Arrest Warrant for the above-captioned defendant for the homicide that occurred on August 23, 2012 in the 1000 block of Rhode Island Avenue, NE at approximately 10:15 p.m.

The undersigned interviewed W-2 again who provided additional information about the night of the shooting. Immediately prior to the shooting, W-2 saw Sean Carter emerge from his house on the 2400 block of 10th Street, NE. He was angry and in a hurry. When witnesses inquired of him as to why he was so angry, he brushed past them without a word and hurried down the street. Shortly thereafter, W-2 heard the gun shots and saw Sean Carter, with his arm extended in front of him, chasing the two guys in the 1000 block of Rhode Island Avenue, NE. In W-2's previous interview, W-2 denied seeing Sean Carter that night before IT saw him chasing the two guys up Rhode Island Avenue.

On or about October 1, 2012, Sean Carter was apprehended by the U.S. Marshals in Fulton County (Atlanta), Georgia. On October 3, 2012, the undersigned and Det. Darin March interviewed Sean Carter in Georgia. Sean Carter waived his Miranda rights and stated the following: On the night of the shooting, Sean Carter saw the decedent, who he knows as "Bills" and a "kid" with him emerge from the P6 bus on Rhode Island Avenue. Sean Carter recognized both of them as individuals who had jumped him on previous occasions. Sean Carter and two other individuals with him walked past Bills and the kid. Bills and the kld then followed behind Sean Carter and taunted him.
