GIVE BRIEF DESCRIPTION OF WHAT HAPPENED:											
<p>On Thursday, August 23, 2012, at approximately 2215 hours, Officer Max Salazar responded to a call for "Shots Fired and a Man Down" in the 1000 block of Rhode Island Avenue, NE. Upon arriving on the scene, Officer Salazar located the decedent, later identified as Bidley Warren (DOB 5/6/90), lying on the south side of the sidewalk with a gunshot wound to his head. The decedent was unconscious and unresponsive. The decedent was from the 1200 block of Brentwood Road, NE, which is considered part of the "Saratoga" neighborhood. He was transported to Med Star where he was pronounced dead at 2241 hours. On Friday, August 24, 2012, an autopsy was performed. The cause of death was determined to be a gunshot wound to the head and the manner of death was ruled a homicide.</p> <p>Your Affiant and Detective Corbett interviewed a witness ("W1"), who stated that IT was walking on Rhode Island Avenue, NE, with the decedent. When they reached the intersection of 10th and Rhode Island Avenue, IT saw a group of guys standing on a porch on 10th St, NE. W1 thought it was the third or fourth house on the right side of the street, walking from Rhode Island Ave towards the dead end on 10th Street. W1 said one of the guys walked off the porch, pull out a gun and began shooting at them. W1 and the decedent began running. W1 stated that IT felt rounds passing by IT's head. W1 stated that the decedent tripped and fell to the ground. W1 attempted to help the decedent to his feet but saw the shooter pointing the gun at him. W1 ran and did not see the decedent alive again. W1 stated that while running, IT heard two more gunshots coming from the location where IT last saw the decedent alive. W1 described the shooter as a black male, unknown complexion, slim to medium build, short bush hair style, approximately 5'10" to 6'0". W1 further stated that the shooter was wearing a black t-shirt and blue jeans. W1 stated that the shooter appeared to be about the same age as the decedent (22 year old). W1 described the gun used as black in color, but was unsure what type it was. W1 said that IT did not see the shooter's face.</p>

GIVE BRIEF DESCRIPTION OF WHAT HAPPENED: Another witness ("W2") was interviewed and stated that IT was on a porch in the 2400 block of 10 th St, NE, when IT heard what IT believed to be a gunshot. W2 stated that IT looked in the direction of the sound and saw two guys running up Rhode Island Ave, NE, from 10 th Street in direction of 12 th Street. W2 stated that IT saw a person IT recognized to be "Sean Carter" chasing behind the two guys with one arm raised and extended in front of him as he chased them. IT could not see a gun in his hand. W2 stated that IT saw one of the two guys being chased fall to the ground. W2 stated that IT began to run inside the house when it heard two more gunshots. W2 stated that IT did not look back to see what happened. W2 described the person IT knew as Sean Carter chasing the two guys as wearing a black shirt and further stated that IT last saw Mr. Carter running on the sidewalk, behind the two guys, in the 1000 block of Rhode Island Ave, NE. W2 indicated that IT has known Sean Carter for more than a year. W2 was shown a confirmation photo of Sean Carter, PDID #586-661. W2 identified the person in the photo as "Sean Carter" and as the person IT saw chasing the two guys in the 1000 block of Rhode Island Ave, NE, after hearing a gunshot. On August 30, 2012, another witness ("W3") was interviewed and stated that IT learned of the shooting right after it occurred. W3 stated that IT later spoke with Sean Carter. W3 indicated that IT has known Sean Carter for more than a year. W3 stated that Mr. Carter told IT that he shot a guy from the Saratoga neighborhood. W3 further stated that Mr. Carter explained that he was walking and the decedent and another guy were walking behind him. The two guys were harassing him verbally. Mr. Carter then identified one of the guys as a person whom he believed participated in "jumping" him earlier this year. Mr. Carter told W3 that he chased the guys and shot one of them. W3 was shown a confirmation photo of Sean Carter, PDID #586-661. W3 identified the person in the photo as "Sean" and as the person who told IT that he shot one of the guys that he was chasing on Rhode Island Avenue on August 23, 2012.



This is a supplemental statement to the Affidavit in Support of an Arrest Warrant for the above-captioned defendant for the homicide that occurred on August 23, 2012 in the 1000 block of Rhode Island Avenue, NE at approximately 10:15 p.m.

The undersigned interviewed W-2 again who provided additional information about the night of the shooting. Immediately prior to the shooting, W-2 saw Sean Carter emerge from his house on the 2400 block of 10th Street, NE. He was angry and in a hurry. When witnesses inquired of him as to why he was so angry, he brushed past them without a word and hurried down the street. Shortly thereafter, W-2 heard the gun shots and saw Sean Carter, with his arm extended in front of him, chasing the two guys in the 1000 block of Rhode Island Avenue, NE. In W-2's previous interview, W-2 denied seeing Sean Carter that night before IT saw him chasing the two guys up Rhode Island Avenue.

On or about October 1, 2012, Sean Carter was apprehended by the U.S. Marshals in Fulton County (Atlanta), Georgia. On October 3, 2012, the undersigned and Det. Darin March interviewed Sean Carter in Georgia. Sean Carter waived his Miranda rights and stated the following: On the night of the shooting, Sean Carter saw the decedent, who he knows as "Bills" and a "kid" with him emerge from the P6 bus on Rhode Island Avenue. Sean Carter recognized both of them as individuals who had jumped him on previous occasions. Sean Carter and two other individuals with him walked past Bills and the kid. Bills and the kid then followed behind Sean Carter and taunted him.


The events and acts described above occurred primarily in the District of Columbia and were committed as described by defendant(s) listed in the case caption.



Sean Carter then claims to have heard Bills call someone on his cell phone and say, words to the effect of, "That bitch-ass nigger is right here. Come down to the Avenue and handle this." Sean Carter then went to his house and retrieved his .9 Barretta gun from underneath his mattress. He then returned to Rhode Island Avenue and shot at Bills and the kid. Sean Carter's gun jammed. He cleared it while he chased Bills and the kid up the street. When Bills fell down, he then shot Bills. Sean Carter claimed that he did not intend to kill Bills and the kid. He just wanted to scare them.


