b) Sheltered Housing --- Cork, Limerick and Waterford

The Good Shepherd Congregation was an approved body in terms of the Housing Act 1988 – the provision by non-profit and voluntary organisations of housing accommodation for disadvantaged persons.

Disadvantaged persons under the Act were defined in a broad way -- elderly persons eligible for housing or institutional care at public expense, homeless people, handicapped people, persons who are victims of family violence and desertion, single parents etc.

Under the Housing Act 1992, mortgages were granted by the Local Authorities to enable housing units to be built on land owned - in the case of Good Shepherd - in Cork, Limerick and Waterford.

Certain conditions --Construction specification, use, percentage used by eligible categories of persons, maintenance and management were specified. The capital and interest payments were waived provided all the conditions set out were met.

The Good Shepherd congregation has fully met all the conditions in respect of the mortgages. Due to the age profile of the Sisters, progressively, more and more external professional help has had to be employed in the care of the people in the sheltered housing units.

The mortgage arrangements conclude in 2014. In anticipation of this and to ensure that the original objectives of the sheltered units is continued into the future, discussions with collaborative organisations have and continue to take place.

The age profile of our Sisters, the increasing needs of many of the people in our care, some now very elderly, make such linkages essential. Of more concern is the continuance of the provision of housing and other support services now being provided. The need which existed 20 years ago in respect of housing and other services for disadvantaged people which resulted in the provision of sheltered housing as was developed by our congregation and the Local Authorities has not diminished.

PROPERTY

a) We have stated in our submission that the property valuations we have used are our best assessment of the value of properties at this time.

It is clear that property values are impossible to assess with any degree of confidence in the present climate. This is evident from commentaries and opinions in the context of political, business, development, banking and court determinations at this time.

We have not carried out a "professional" valuation on our properties, as we believe such an exercise would not give any more realistic or reliable assessment of the value of our properties than our own estimation. This is particularly true in the rather complex and unusual composition of the property portfolio as we have set out in our submission.

We have given a very comprehensive analysis of the properties – description, their uses etc. This is now augmented by the clarifications requested by you in respect of some properties in Cork, Limerick and Waterford.

We confirm that the property "Clifton" in Cork remains on the market with no offers received in respect thereof.

3. Property Schedule

- 3.1 The properties which the Congregation occupy fall broadly into three catergories.
 - (A) Building Complexes in Cork, Waterford and Limerick where the corporate community care responsibilities of the care of socially disadvantaged people are carried out. These properties are detailed in pages numbers 3, 6 and 8 of the Property Schedule.
 - (B) Living / Ministry Accommodation for the Sisters generally in houses with a small number of apartments. In Northern Ireland there are 3 properties which house a larger number of Sisters including the sisters who lead the Contemplative Life.
 - (C) One property formerly used as a residence for sisters and as a Convalescent Home has been closed, put on the market for sale but remains unsold. (Page number 20 refers).

3.1 (A)

For the most part the buildings under (A) were built with the cooperation and funding of the respective City Councils of Cork, Waterford and Limerick. Allowance to 25% of the units was made for occupancy by sisters—who with paid lay staff provide the Service. Ownership and current and future use of these building/units is restricted—in the main to the provision of accommodation to homeless or otherwise disadvantaged women and men. These properties are held in a Mortgage arrangement with Cork, Waterford and Limerick City Councils until 2014.

It is most difficult to put a value on these properties. They were built with an acute social need in mind --- firstly -- as a more suitable and appropriate place for those formerly living in large institutional buildings and secondly -- with the passage of time the inevitable need to accommodate future homeless or otherwise disadvantaged people. In the main they are in "cluster" formation with living and administrative buildings – very suitable for purpose but very limited appeal or suitability for any other use.

Please see our best estimated valuations on the appropriate property schedules.

3.1 (B)

Properties under (B) above are occupied and utilised as set out in the Property Schedule. They are typically situated in the areas of ministry – Southhill and Roxboro in Limerick, Ballybeg in Waterford, Knocknaheeny in Cork and Rahoon in Galway - or are in areas of longstanding tradition of vocation and ministry, The Well in Cork, Rossmore Drive in Belfast and Waterside in Derry.

All these properties are in use by the Congregation and have been valued on the basis of a considered "desktop" assessment in the absence of a defined basis of valuation.

3.1 (C) Clifton

This property, Category (C) above (Page 20 refers) was closed in 2007. As well as a residence for a number of Sisters it operated as a Convalescent Home – essentially as a step-down facility for patients leaving acute hospitals but in need of further care before returning to their own homes. The cost of refurbishment necessary to bring the facility to an acceptable standard was clearly outside the financial capability of the Congregation and the Sisters discontinued this care facility. The amount of c. £ 675,000 (net) was paid in Redundancy costs to the employees. The property was placed on the market but has not been sold. (See letter from Malcolm Tyrell, (Not Fon Release Facility).)

The Congregation continues to bear the cost of security, heating etc to preserve the building.

3.2 Property Sold

Property (Page 14) Greenvale, a residential 6-bed unit of dependent elderly (part of 25 Rossmore Drive, Belfast complex) was sold to Ark Housing in April 2009 for €800, 065.

Property (Page 19) in Limerick was sold in early 2009 with funds for same in the amount of €161,363 being received in July 2009.
