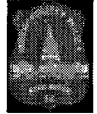
ON MONDAY JULY 30, 2012 AT 2343 HOURS, SHOTSPOTTER DETECTED GUNSHOTS IN THE 4700 BLOCK OF BROOKS STREET, NORTHEAST. SIXTH DISTRICT PATROL OFFICERS WERE DISPATCHED TO THE SCENE AND LOCATED THE VICTIM, LYING IN A DRIVEWAY, SUFFERING FROM AN APPARENT GUNSHOT WOUND. THE VICTIM WAS TRANSPORTED TO PRINCE GEORGES COUNTY HOSPITAL BY AMBULANCE 30. THE VICTIM SUCCUMBED TO HIS INJURIES AND PRONOUNCED DEAD BY DR. SAID DAEI AT 0013 HOURS.
