The Grand Jury charges:

#### FIRST COUNT:

Detrek Baker, also known as Cannon, also known as Superman, within the District of Columbia, while armed with a firearm, purposely and with deliberate and premeditated malice, killed James R. Sherrod, Jr. by shooting him with a firearm, on or about April 28, 2012, thereby causing injuries from which James R. Sherrod, Jr. died on or about April 28, 2012. (First Degree Murder While Armed (Premeditated), in violation of 22 D.C. Code, Sections 2101, 4502 (2001 ed.))

#### SECOND COUNT:

On or about April 28, 2012, within the District of Columbia, Detrek Baker, also known as Cannon, also known as Superman, did possess a firearm while committing the crime of murder as set forth in the first count of this indictment. (Possession Of a Firearm During Crime Of Violence Or Dangerous Offense, in violation of 22 D.C. Code, Section 4504(b) (2001 ed.))
THIRD COUNT:

On or about April 28, 2012, within the District of Columbia, Detrek Baker, also known as Cannon, also known as Superman, previously having been convicted of a felony did carry, openly and concealed on or about his person, in a place other than his dwelling place, place of business or on other land possessed by him, a pistol, without a license issued pursuant to law. (Carrying a Pistol Without a License (Outside Home or Place of Business), in violation of 22 D.C. Code, Section 4504(a) (2001 ed.))

#### FOURTH COUNT:

On or about April 28, 2012, within the District of Columbia, Detrek Baker, also known as Cannon, also known as Superman, previously having been convicted in any court of a crime punishable by imprisonment for a term exceeding one year, owned, kept and had within his possession and control, a firearm. (Unlawful Possession of a Firearm, in violation of 22 D.C. Code Section 4503(a)(1) (2001 ed.))

# FIFTH COUNT:

On or about April 28, 2012, within the District of Columbia, Detrek Baker, also known as Cannon, also known as Superman, did possess ammunition without being the holder of a valid registration certificate for a firearm. (Unlawful Possession Of Ammunition, in violation of 7 D.C. Code, Section 2506.01(3) (2001 ed.))
