**GIVE BRIEF DESCRIPTION OF WHAT HAPPENED:**

On, Sunday, February 24, 2013, members of the First District, Metropolitan Police Department received a radio run for a shooting at the location of ██████ Canal St. SW, Washington D.C. The first officer on the scene arrived and observed a black male, later identified as Tyrone Joyner, 22 years old, unconscious and unresponsive and suffering from an apparent gunshot wound to the lower left abdomen. The victim was transported to Howard University Hospital where he was admitted for surgery by hospital staff. The victim Tyrone Joyner, who will be referred to hereinafter as the decedent, succumbed to his injuries and was pronounced dead at 12:38 a.m. on Monday, February 25, 2013 by hospital staff. The decedent's remains have been transported to the Office of the Chief Medical Examiner and are pending autopsy.

During the course of this investigation, a witness was located and interviewed for the purpose of this investigation and will be referred to as W-1. W-1 stated that IT observed the decedent and a subject it called "Tay" in the vicinity of an entrance to ██████ Canal St. SW. IT then observed "Tay" exit the building, pull out his gun, and begin to jog away; the decedent chased after him, grabbing at a coat that was in the hands of "Tay." The coat fell to the ground, and "Tay" pushed the decedent away from him. The decedent came towards "Tay" and started to throw a punch at him; "Tay," with gun already out, shot the decedent. The decedent fell to the ground, got up and ran towards the rear of ██████ Canal Street SW, where he collapsed. "Tay" grabbed the coat and ran through an alley, making good his escape. At no time during the events described above did W-1 observe a gun or any other weapon in the possession of the decedent, and no weapon of any kind was recovered by police or paramedics either on the decedent's body or anywhere in the area around it.

Detectives of the MPDC Homicide Unit assembled a photo array with nine MPDC color photographs including the photograph of Donte "Tay" Graves, PDID 616-878. W-1 observed the array and unequivocally identified Donte "Tay" Graves PDID 616-878 as the person that IT saw shoot the decedent.
