**Count 3: Assault W/I to Kill** Sentenced to 5 year(s) incarceration, 3 year(s) supervised release, \$100.00 VVCA, Due Date 07/15/2018

**Count 4: Poss Firearm During Crime of Violence** Sentenced to 5 year(s) incarceration, 3 year(s) supervised release, \$100.00 VVCA, Due Date 07/15/2018
