(Assault With Intent to Kill While Armed, in violation of 22 D.C. Code, Sections 401, 4502 (2001 ed.))

SECOND COUNT:

On or about April 18, 2012, within the District of Columbia, Calvin Shaw, also known as "Sharkim Sharp," also known as "Sharkim Sharp-Robinson," also known as "Shocka," did possess a firearm while committing the crime of assault with intent to kill as set forth in the first count of this indictment. (Possession Of a Firearm During Crime Of Violence Or Dangerous Offense, in violation of 22 D.C. Code, Section 4504(b) (2001 ed.))

THIRD COUNT:

On or about July 2012 through August 2012, within the District of Columbia, Tonika Hilliard did knowingly endeavor to influence, intimidate, and impede a witness in an official proceeding with the intent to cause and induce the person to withhold truthful testimony, a record, document, or other object from an official proceeding. (Obstructing Justice (Witness/Officer), in violation of 22 D.C. Code Section 722(a)(2)(B)(2001 ed.))


FOURTIETH COUNT:

On or about July 2012 through October 2012, within the District of Columbia, Tonika Hilliard did corruptly and by threat of force obstruct, impede or endeavor to obstruct and impede the due administration of justice in any official proceeding. (Obstructing Justice (Due Administration of Justice) in violation of 22 D.C. Code Section 722(a)(6)(2001 ed.))
