

## Annex B to 2020-HQ-03-26 and 2020-HQ-AC-03-26-B

## Determining whether entry will be for a discretionary/optional purpose and whether an individual is exempt from mandatory self-isolation

Scenarios have been developed to assist border services officer (BSOs) and liaison officers (Los) in determining whether entry is for a discretionary/optional purpose and therefore prohibited. Entry may be considered not to be discretionary/optional in a range of situations.

These scenarios only apply to FNs who are not otherwise excepted or exempt from the OIC under another category. All scenarios below involve a FN who is neither a registered Indian nor protected person, and who is not symptomatic for COVID-19. References to "Canadian" pertain to both CC and PRs, unless otherwise specified.
