The Grand Jury charges:

FIRST COUNT:

Daren Vaughn, within the District of Columbia, while armed with a knife, in perpetrating and attempting to perpetrate the crime of first degree burglary while armed, as set forth in the second count of this indictment, killed Tyrell Swann by stabbing him with a knife on or about September 27, 2012, thereby causing injuries from which Tyrell Swann died on or about September 27, 2012. (First Degree Murder While Armed - Felony Murder, in violation of 22 D.C. Code, Sections 2101, 4502 (2001 ed.))

SECOND COUNT:

On or about September 27, 2012, within the District of Columbia, Daren Vaughn, while armed with and having readily available a dangerous and deadly weapon that is a knife, entered the home of Tyrell Swann, while Evelyn Bourn and Tyrell Swann were inside that home, with intent to assault Tyrell Swann. (First Degree Burglary While Armed, in violation of 22 D.C. Code, Section 801(a), 4502 (2001 ed.))

THIRD COUNT:

Daren Vaughn, within the District of Columbia, while armed with a knife, purposely and with deliberate and premeditated malice, killed Tyrell Swann by stabbing him with a knife on or about September 27, 2012, thereby causing injuries from which Tyrell Swann died on or about September 27, 2012. (First Degree Murder While Armed (Premeditated), in violation of 22 D.C. Code, Sections 2101, 4502 (2001 ed.))

FOURTH COUNT:

On or about September 27, 2012, within the District of Columbia, Daren Vaughn assaulted Nakita Bourn with a dangerous weapon, that is, a knife. (Assault with a Dangerous Weapon, in violation of 22 D.C. Code, Section 402 (2001 ed.))

FIFTH COUNT:

On or about September 27, 2012, within the District of Columbia, Daren Vaughn did carry, openly and concealed on or about his person, a dangerous weapon, capable of being so concealed, that is, a knife. (Carrying a Dangerous Weapon, in violation of 22 D.C. Code, Section 4504(a) (2001 ed.))
