Road Patrol-Shift Commander/ Lieutenant:

Our road patrol consisted of over 150 road patrol deputy sheriffs, patrolling cities, townships and villages with-in the county. Macomb County has 482 square miles and has a population of 840,000 citizens and is the northern border to DETROIT, Michigan.

SWAT: Hostage Negotiator:

As one of four sheriff's office hostage negotiators for twenty years, I have successfully negotiated over 25 incidents. I have also been the secondary or "coach" negotiator on many other scenes.

Auto Theft Commander: Macomb Auto Theft Squad (MATS):

I commanded the auto-theft taskforce, which consisted of police officers from the Michigan State Police, County Deputies, and local police officers from cities with-in the county. The unit investigated criminal activities into auto theft and fraud cases in the greater Detroit Metropolitan area. We also investigated stolen items such as commercial semi-vehicles, heavy construction equipment and motorcycles.

Criminal Investigations/Detective Division:

I have oversaw, or have been the lead investigator on every type of criminal activity possible for both adult and juvenile cases. I have handled cases such as homicides, criminal sexual conduct (rapes), shootings, assault, narcotics investigations, ect. I have testified in many times in court in front of both judge and jury trials. I have also testified in federal court and civil court.

Traffic Safety Enforcement Division (accident prevention unit):

I oversaw the traffic enforcement unit which consisted of ten (10) deputies. Our unit handled selective traffic enforcement, accidents and high profile escort such as presidential details, airshows and funerals details. We had marked patrol cars, unmarked cars and Harley-Davidson Motorcycles.

Narcotics / Surveillance Task Force:

I commanded a street enforcement "crack-cocaine" team and a major crimes unit. Working with the FBI and DEA, I have been to Florida and California on undercover narcotics investigations. Working undercover, I have purchased almost every type of drug and have executed over 300 search warrants.

Marine Division Command: Operator of Patrol Boats:

I have worked the Marine Patrol for over twenty (20) years part-time in the summer months on Lake St. Clair. I have conducted numerous search and rescue operations along with many arrested for operating a boat while intoxicated. I am a certified patrol boat operator.

Arson / Fire Investigator: Cause and Origin of Fires:

I am a graduated of the Michigan State Police fire investigation school held in Tustin, Michigan. I have investigated hundreds of fire scenes from houses, commercial building, boats and vehicles. I have worked very closely with the Michigan State Police arson unit, along with many federal agencies to conduct cause and original of fire scenes.

Corrections: Jail Operations Command (1300 bed jail):

As the Jail Operations Commander, I oversaw the daily operation of the county jail. Having over 1300 prisoner at any given time, the issues were never ending. We had 150 Correctional Officers and an additional 30 support staff, including a full time medical staff. During the week we would also run between ten and twelve prisoner transport vans all over the state (Michigan) transporting prisoners.
