GIVE BRIEF DESCRIPTION OF WHAT HADDENED.													

On May 21, 2013, Amber Middleton was served a subpoena to appear in D.C. Superior Court on June 10, 2013 to testify as a witness at trial in United States v. Anthony Hatton, et. a., Criminal Case number 2011-CF1-16685. Ms. Middleton was subpoenaed for trial because she has material information relating to the murder of Steven Moore, which occurred on December 3, 2011 in the 1100 block of 21st Street, NE, Washington, DC. On June 10, 2013, Ms. Middleton failed to appear and a material witness warrant was issued for Ms. Middleton's arrest. On June 29, 2013, Ms. Middleton was arrested on the material witness warrant.

On July 8, 2013, Ms. Middleton was called to the witness stand outside of the jury's presence. The Court asked Ms. Middleton questions to determine whether she would answer questions when called to testify. Ms. Middleton efused to speak. The Court ordered Ms. Middleton to answer questions when called to testify. The courtroom lerk attempted to swear in Ms. Middleton. Ms. Middleton refused to respond when asked to take the oath. The Court found Ms. Middleton in civil contempt of court for refusing to testify, in violation of her trial subpoena.

In July 22, 2013, Ms. Middleton was again called as a witness for the government to testify in the aboveeferenced case. When the clerk of the court attempted to swear in Ms. Middleton, Ms. Middleton again refused to espond when asked to take the oath.

In July 23, 2013, Ms. Middleton was again called as a witness for the government. When the clerk of the court tempted to swear in Ms. Middleton, Ms. Middleton again refused to respond when asked to take the oath.

n multiple occasions, to include on July 22, 2013 and July 23, 2013, Ms. Middleton was asked to provide the ason for her refusal to testify. She has refused to provide a reason. When asked specifically if she was afraid, ls. Middleton refused to answer the question. Ms. Middleton was repeatedly reassured that if she had safety oncerns she simply needed to make law enforcement aware of those concerns and they would be addressed. Ms. iddleton has repeatedly refused to specify any safety concerns.

Based on the facts set forth in this affidavit, your affiant believes probable cause exists and respectfully requests that a Judge of the District of Columbia Superior Court issue a warrant for the arrest of Amber Middleton for Obstructing Justice in violation of D.C. Code Section 22-722(a)(6).
