The Grand Jury charges:

FIRST COUNT:

Donte Graves, within the District of Columbia, while armed with a firearm, and with the intent to kill another and to inflict serious bodily injury on another and with a conscious disregard of an extreme risk of death or serious bodily injury to another, caused the death of Tyrone Joyner by shooting him with a firearm on or about February 24, 2013, thereby causing injuries from which Tyrone Joyner died on or about February 25, 2013. (Second Degree Murder While Armed, in violation of 22 D.C. Code, Sections 2103, 4502 (2001 ed.))

SECOND COUNT:

On or about February 24, 2013, within the District of Columbia, Donte Graves did possess a firearm while committing the crime of murder as set forth in the first count of this indictment. (Possession Of a Firearm During Crime Of Violence Or Dangerous Offense, in violation of 22 D.C. Code, Section 4504(b) (2001 ed.))

THIRD COUNT:

On or about February 24, 2013, within the District of Columbia, Donte Graves, assaulted Destiney Burns with a dangerous weapon, that is, a firearm. (Assault with a Dangerous Weapon, in violation of 22 D.C. Code, Section 402 (2001 ed.))

FOURTH COUNT:

On or about February 24, 2013, within the District of Columbia, Donte Graves did possess a firearm while committing the crime of assault with a dangerous weapon as set forth in the third count of this indictment. (Possession Of a Firearm During Crime Of Violence Or Dangerous Offense, in violation of 22 D.C. Code, Section 4504(b) (2001 ed.))
FIFTH COUNT:

On or about February 24, 2013, within the District of Columbia, Donte Graves, while armed with a firearm, by force and violence, against resistance and by putting in fear, stole and took from the person and from the immediate actual possession of Malik White, property of value belonging to Malik White, consisting of a jacket and its contents. (Armed Robbery, in violation of 22 D.C. Code, Sections 2801, 4502 (2001 ed.))

SIXTH COUNT:

On or about February 24, 2013, within the District of Columbia, Donte Graves did

possess a firearm while committing the crime of robbery as set forth in the fifth count of this

indictment. (Possession Of a Firearm During Crime Of Violence Or Dangerous Offense, in

violation of 22 D.C. Code, Section 4504(b) (2001 ed.))

SEVENTH COUNT:

On or about February 24, 2013, within the District of Columbia, Donte Graves did carry,

openly and concealed on or about his person, in a place other than his dwelling place, place of

business or on other land possessed by him, a pistol. (Carrying a Pistol (Outside Home or Place

of Business), in violation of 22 D.C. Code, Section 4504(a) (2001 ed.))
