On 9-29-2013 at 0240 hours, I was on routine patrol in marked unit 6822 in the area of US 422 and Harper Road.

I observed a black Cadillac, Ohio Registration FGR5862, traveling eastbound on US 422 at a high rate of speed. The vehicle was in a construction zone with workers present and the speed limit was set to 50mph. I activated the TruSpeed laser and observed a steady speed of 74 mph. I activated my overhead lights and stopped the vehicle on US 422 near milepost 18/6.

I approached the driver and advised him of the reason that I was stopping him. I asked the driver for his license and he handed me two credit cards. I asked him if he had his driver's license and he pointed to the credit cards as if he had already given me his license. The name on the card was Bernard Kosar. Mr. Kosar had slurred speech, difficulty speaking and a strong odor of alcoholic beverages coming from him. I asked Mr. Kosar if he had anything to drink tonight and stated that he was helping a friend out tonight. I asked Mr. Kosar if he could recite the alphabet starting at E and ending at W. Mr. Kosar started E, F, G, P, L, M, N, O, Q and from there it trailed on with more letters that were not correct and ended at X.

I asked Mr. Kosar to exit the vehicle in order to perform some field sobriety tests. Mr. Kosar complied.

The first test I had Mr. Kosar perform was the Horizontal Gaze and Nystagmus. I observed a lack of smooth pursuit, distinct nystagmus at maximum deviation, and an onset of nystagmus before 45 degrees in both eyes. While speaking with Mr. Kosar, I continued to smell the strong odor of alcoholic beverages coming from him.

I asked Mr. Kosar if he had any problems that would prevent him from performing the one leg stand or walk and turn test. Mr. Kosar stated that he had a lot of surgeries on his knees and ankles because his line couldn't block. I asked Mr. Kosar to take a portable breath test and Mr. Kosar stated that he was told never to take those.

Mr. Kosar was placed under arrest for OVI and transported back to Solon City Jail for processing. Mr. Kosar was read and shown the BMV Form 2255 as well as his Miranda rights. Mr. Kosar was given an opportunity to take the Breathalyzer and he refused. Mr. Kosar was charged with OVI and Speed into Bedford Municipal Court on 10-01-13 at 1330 hours and held on \$500 C/S bond.

The vehicle was towed to H&H by H&H.

The Muvi body camera video from the booking room was placed into evidence.
