

2013 BEACH WEEK RULES - FINAL

1. Cell phones on, charged and answered at all times.
2. NO ONE goes out alone; boys should always stay in pairs.
3. NO SWIMMING in the ocean, pool or hot tub after dark. No swimming in the canal anytime. During the day boys will swim in the ocean near guarded areas.
4. NO DRIVING! All car keys will be held by chaperones. Chaperones will drive when necessary.
5. THE BOYS WILL EAT DINNER TOGETHER EVERY NIGHT. Chaperones will coordinate, with the boys, making or ordering dinner. The boys will help set-up and clean-up each night.
6. BEDROOM DOORS OPEN AT ALL TIMES UNLESS DRESSING OR SLEEPING. No girls allowed in bedrooms 24/7. NO GUESTS allowed in any part of the house except common areas.
7. No hard liquor or controlled substances may be consumed.
8. Chaperones will record any DAMAGE to house and inform incoming chaperones. Damages will be discussed with boys as it happens, if blame can be placed on an individual, his security deposit will reflect damage.
9. Common areas need to be CLEANED by individuals using them. All boys need to help with daily cleaning, food prep, trash, keeping noise levels down, especially at night, and helping the chaperones.
10. Anything that belongs to the rental house is not allowed to leave the rental house.
11. No climbing, hanging or jumping on or from balconies.
12. GUESTS are allowed to stay at the house until 12:30 a.m.
13. CURFEW is 1:00 a.m. Every boy needs to sleep at the rental each night. NO SLEEPOVERS or OVERNIGHT GUESTS!

Victim Assistance Resources

The Victim Bill of Rights provides victims of crime with the right to be notified of and participate in all major phases of a criminal case, in accordance with the provisions of the bill, the below information is provided to you.

1. You have received a copy of the incident report taken by the police which includes the date of the complaint and the case number, as well as other helpful information. You may contact the police department to check the status of arrest of the defendant. Keep this copy for your reference.
2. Be advised the defendant in your case, unless he/she has been charged with a capital crime, has the right to bail or other pre-trial release, and therefore, may not be held in jail until trial.
3. The Violent Crimes Compensation Board has been established to assist those innocent victims of crime who sustain personal injury (bodily harm or extreme mental suffering.) The board, on a limited basis, may compensate victims of violent crimes some property loss or damage. You may be eligible for financial assistance if.
 - a. You are an innocent victim of a violent crime.
 - b. You cooperate with the law enforcement agencies in the apprehension, and prosecution of the assailant.
 - c. You did not contribute to the infliction of your injuries
4. Services are available for victims of crime throughout the State of Delaware. The police departments make referrals to victim assistance resources. Below is an additional list of victim assistance resources. Do not hesitate to call any of these resources for assistance
