- All posted video files (both publicly accessible and private)
- All logs showing the date and time videos were uploaded by the user of this account
- All logs showing the date and time videos on this account were linked/saved/associated (such as 'Favorite Videos') by other YouTube accounts
- All logs showing the date and time videos uploaded by other YouTube accounts were linked/saved/associated (such as 'Favorite Videos') to this account
- The content of Private Messages sent to or from this YouTube account, to include the time and date of messages sent, received, drafted, or deleted.
- All logs related to the deletion of videos, Private Messages, or other data (such as 'Favorite Videos') related to this account
- All videos and other content which may have been deleted by the account user but is still retrievable by Google
- All connection logs related to this account
- All registration and user account information related to this account
- Any other content, metadata, logs, or information in the possession of Google related to this account

- 4. Records, documents, information, or data identifying persons or entities involved in such violations, including communications, financial transactions, and data exchange with or related to such persons, photographs and/or videos of such persons.
- 5. Records, documents, information, or data identifying the methods or means used to obtain U.S. government information or the communication, delivery, or transmission of such information.
 - 6. Records, documents, information or data evidencing knowledge, intent, or motive.
