Myself and D/Sgt. Wengrowski responded to the Outer Drive address at approximately 6.a.m. on a shotgun discharged by homeowner at an unknown female on the front porch (called in 0442 a.m.).

Conditions: cold, windy and rain. At the scene DHPD Patrol Sgt. McManmon provided me with a DHPD Consent to Search Home - located at W. Outer Drive Dbn. Hts., MI 48127. The consent form signed by homeowner Wafer and Cpl. Gonzalez, witnessed by Cpl. Hutchens.

I observed Decedent McBride lying face up on the porch (feet within a few feet of the front door & head partly obscured by a bush). McBride suffered a large wound to the center of the face/head, consistent with a closer range shotgun blast. McBride was wearing black boots (left sole split, white socked foot showing) dark blue jeans, black belt and blue zip-up hoodie.

Northern most West side door was locked and no obvious sign of tampering to that door (partially collapsed wooden steps leading up to door).

The front entry door was open (no signs of prying, kicking or tampering) and the front screen door was closed/locked. The front screen was popped out with a tear in the screen (Cpl. Zawacki had photographed that upon arrival).

On the carpet near front door lay a Mossberg Model 500A 12 ga. pistol grip pump shotgun. black in color, Ser I unlocked screen door while M.E. took photograph of shotgun through screen door. ID for Renisha Marie McBride on her person TOT DHPD at scene. I popped screen back in place (held in loosely by one screwed in tab at the top and rested in the channel at the bottom of storm door) so Cpl. Zawacki could photograph it in place with a tape measure, as shotgun blast could have blown screen out of place.

D/Sgt. Wengrowski preserved shotgun for prints: he discharged the only round in the shotgun: one spent red 12 ga. shotgun shell casing onto the carpet. Cpl. Zawacki finished photographs and collection of evidence (see his report).

Victim possibilities include: she is in fact known to Wafer, lost, neighbor, car trouble/accident, left group home, Vista Maria resident, crime victim, etc.? Cpl. Hutchens related he would check at

Vista Maria (no result) officers noted that other parked vehicles in area belong to residents.
Myself and D/Sgt. Wengrowski then responded to WC M.E., Dr. Kesha examined decedent
McBride and stated it was a homicide, McBride was "shot at close range."
D/Lt. Serwatowski was phoned immediately and ran the 2004 Taurus Ml
