Dear Governor Walker, Senate Chief Clerk Renk, and Assembly Chief Clerk Fuller:

It is my pleasure to submit the annual concealed carry statistical report, pursuant to Wis. Stat. § 175.60(19). As you will see from the report, the citizens of Wisconsin have eagerly embraced the right to carry concealed weapons, as provided for in 2011 Act 35. There was a steady interest throughout 2013 in obtaining the concealed carry licenses, and as of December 31, 2013, DOJ issued concealed carry license number 209,251 to a Wisconsin resident. The Department of Justice also denied 857 applications for disqualifiers other than a lack of valid ID or age restriction, and revoked 374 licenses for reasons other than the license holder no longer residing in our state.

The staff of the Firearms Unit in the Wisconsin Department of Justice has worked diligently to ensure a good customer experience for the applicants, and is averaging a turnaround time of application received to a license decision made and mailed of 6 days. Our team is also working on developing online applications to enhance the user experience for license holders that need to make name changes, address changes, or eventually an application for renewal. These enhancements will bring additional operational and cost efficiencies to a program that has been fully funded by the applicants and does not require any tax revenue.
